# Hawaii Area 17 Standing Committee Reports - 10 minutes each

**Treatment Facilities Committee** – Albert M.

Ordered treatment facility workbook if you want to give them to DCM's. This book has a lot to offer. I have a list of all the treatment facilities in the State of Hawaii. I have been contacting them. If you want copies of this list, I have that too. There is a request for what these programs may need on this list. You might want to take this back to your groups to see who can help. Bridging the Gap sign up sheet is being passed around. Changes for Kauai, Amos will no longer be the contact person, Lenny L. will be the new one. I've been getting a lot of emails from members of AA letting me know if their groups are supporting treatment facilities. Questions and comments: Are you looking for people on Oahu to help by going into facilities? Yes, it's weak on Oahu. We need some help. Maybe you could call Floyd M, who was working with the treatment committee; he knows this system very well. Let's work with Mary H. who is new to the position and just getting started. She's great. We're not doing any presentations and that it seems that people think that it's Area's job to do this. Clarification: Standing Committee Chairs are the contact people, not the one that's doing the work. The Districts should be doing the work.

#### **CPC** – Francesca P.

I take information from GSO and give it to you, that's my job. Workbooks are available so that I don't have to make this stuff up. They tell exactly what AA does and doesn't do. Literature is going to be updated with a quote from a doctor. There is also the pamphlet "About AA" and it talks about our singleness of purpose. These handouts are available today for you to take them back to groups. The medical profession is very important to us. Updates re: the current display units. When I went to PRAASA I met a lot of other people from CPC and it was good to share the things that we do. We go into DUI classes and talk about what AA does and is. Sept. 2003 is called Recovery Month. It is to promote that recovery is possible. GSO sends lists of doctors that have expressed interest in having AA information. How many of your doctors know that you're in AA? How many of the waiting rooms of your doctors have literature?

#### Hospitals – Joe G.

We take literature to hospitals or if there is a request by a hospital to come in and talk to an alcoholic. If I don't hear from your representatives I will speak to your DCM's about needs for this committee. Oahu is doing pretty good. There are a lot of people doing work there. The Mental Health Unit at Castle Hospital is getting a speaker on Thursday nights. We need help with that, so if you know someone that can speak there, call me. Windward has a meeting at the State Hospital in Kailua. At Queen's Hospital, Bad Brains is taking a meeting. Pali Momi is also served. Kauai is served by Will and he's doing great. We had a one week debate about what materials he wanted to use. I can say now that this was a *loving* debate. PRAASA was very interesting and helpful and I learned a lot. *Questions/Comments:* What day is Queen's Hospital meeting? *It's on Mondays at 6 pm.* Need panels of people to go into the prison here on the big island.

#### 2004 Proposed Budget - Lyda

Finance Committee – explanation of the Procedures to DCMs

Being elected started a process for me about learning more about general service. Excitement, pride and fear were all part of my process. I've gotten a lot of help along the way from a lot of people who have been there. PRAASA was a big influence for me. (Next PRAASA is in Irvine California on March 5-7, 2004). There were over 1000 people in attendance. Everyone is there to learn how to better serve the alcoholic. My life totally changed at the Waianae assembly, Inform the Delegate. I learned that I am responsible. It was so inspiring that all of you did so much work on the topics. It was a picture of your commitment to sobriety and to yourselves. Same processes at GSO as here in Hawaii Area. Voting is the same, discussions are the same. Two of the biggest realizations that I had while I was in New York is that we are really heard and they really want to hear from us. The most current Box 459 is a recounting of the decisions that were made at GSO. What GSO is doing worldwide is amazing. I'll have a complete report for all of you in August. Here's what New York needs from us now. Two openings in New York for class A trustees (non alcoholics). We are being asked to submit resumes or outlines for potential trustees. We need to get that to New York as soon as we can. We need someone from the clergy and the medical field. All trustees are volunteers, but they are funded for all their expenses. Literature committee is asking for help with their AA group pamphlet. Take the pamphlet and make changes and give it to Don. June 27<sup>th</sup> is the deadline for that, and then the next deadline is October 10<sup>th</sup>. CPC/Treatment Facilities are discussing the possibilities of developing a pamphlet re: courts sending people to AA. More input is needed for this topic.

Pamphlet from a "talk story" type to a "Q&A" format

Aloha,

I ask that the district forward my proposal to redo the format of the Bridging the Gap pamphlet from a "talk story" type to a "Q&A" format.

BACKGROUND: I read the "Bridging the Gap" pamphlet and found it confusing. First it speaks to a reader that is interested in being a volunteer. Then the "voice" of the author changes to one who is speaking to a client interested in signing up for the program. Then, the "voice" changes again to address a potential volunteer.

I spoke with Albert M. (Hawaii Area 17 T.F.C. Chair) and gave him an alternative pamphlet. The pamphlet I gave Albert is the exact same copy I am forwarding with this proposal. He wrote back saying that he cannot address this issue at this time because he is working on other plans for his committee. However, he did encourage me to forward my proposal to the district and again to the area.

ABOUT THE PROPOSED FORMAT: The proposed format is not a new idea or an original idea of mine. Instead, I "borrowed" the *Sponsorship* pamphlet format.
