Bill W.'s Commentary on Concept XII

"Therefore we expect that our Conference will always try to act in the spirit of mutual respect and love—one member for another. In turn, this sign signifies that mutual trust should prevail; that no action ought to be taken in anger, haste, or recklessness; that care will be observed to respect and protect all minorities; that no action should ever be personally punitive; that whenever possible, important actions will be taken in substantial unanimity; and that our Conference will ever be prudently on guard against tyrannies, great or small, whether these be found in the majority or in the minority. The sum of these several attitudes and practices is, in our view, the very essence of democracy—in action and spirit." The A.A. Service Manual, page 75

We also discussed agenda item B, regarding the mailing and my opinion was given that we should discontinue the bi-annual mailing. I also shared with the Committee the discussion that Hawaii Area had regarding utilizing local Corrections Committees to make contact, that face to face interaction would be more personal and effective. We talked about Bridging the Gap – which is being done in both Corrections and Treatment, and while it may be called different things, it is being done.

Delegates' Only Dinner & Meeting

Beautiful sharing, open mic for Delegates. Had many moments of relating, and I knew that I was exactly where my HP wanted me to be, doing exactly what He/She/It would have me do. Sylvain shared about being the 1st French only speaking delegate from Quebec. Members in his Area were concerned that he would have a hard time fulfilling his service responsibilities. At the Conference last year, he ran down to Times Square and bought a camcorder. He filmed 68 people at the Conference saying "Bonjour Quebec". When he showed this at his Report Back, more than ½ of the Assembly was in tears. As we all circled up to say the 3rd Step Prayer, I looked around and got chicken skin. How the heck did a drunk like me get to this place? It's beyond human power, that's for sure.

Wednesday April 29, 9:00AM – 11:00PM

• Workshop: "Language of the Heart – Keeping It Simple"

There were 10 separate Workshops; each person assigned to one on the same topic "Language of the Heart – Keeping it Simple" There was a moderator, who read the 3 questions. This was a mixed group of GSO Staff, Delegates, Trustees and non-Trustee Directors.

Setting an example; giving people rides (talking on the way); simple example of service; "this is what I did" rather than "you must do this"; the welcome to AA; I have never been fingered in the chest.

Rogelio Flores, Class A Trustee, Drug Court Judge is Santa Barbara, CA, shared about sentencing a man to treatment for a DUI, and then the man came back one year later and gave Rogelio his one-year coin.

We talked about reaching out to the member who has time in the program, but is new to the area. I realized that I personally can do better to reach out to new faces at my home group.

• Sharing Session – What's on your Mind?

An opinion was voiced from the floor that the manner in which we select our leaders has been compromised, that our principles have been undermined and our concepts violated. There was a spreadsheet made by this individual, showing her perception of an imbalance in "power". I knew something like this was coming, as the individual who brought this up was my delegate big buddy, and had tried to get me to see things her way prior to the conference. It left me feeling uneasy and upset.

Joint Dinner Meeting of the Trustees' and Conference Committees on International Conventions / Regional Forums

We talked about the agenda items, and we requested that the Trustees discuss at their July Board meeting making the Flag Ceremony Broadcast more widely available. The soft cover edition of "AA Comes of Age" will be released at the 2010 International Convention.

I was pulled from the hat to Chair this Committee. So in addition to working on the Committee year round, I get the opportunity to attend the January 2010 Board Meeting in New York.

Committee Reports and Discussion

Agenda

When Waikiki presented on these agenda items at our Inform the Delegate Assembly, they expressed specific concerns about the entire agenda process. I did vote in favor of all the Agenda Committee's recommendations, as it seemed to address the concerns to some extent.

The committee <u>recommended</u> that the theme for the 2010 General Service Conference be "Practicing A.A.'s Principles – the Pathway to Unity" [PASSED]

It was <u>recommended</u> that the following be presentation, discussion topics for the 2010 General Service Conference. [PASSED]

- 1) Practicing These Principles in all Our "Service" Affairs
 - a) What is the Difference Between General Service and Service in General?
 - b) Love and Tolerance is Our Code
 - c) Setting an Example Attraction to Service
- 2) Unity Through Inventory

- a) Our Common Welfare Should Come First
- b) This We Owe to A.A.'s Future
- c) What Happens After Inventory?
- 3) General Service Conference Agenda Selection Process:
 - a) How it Works
 - b) Collective Participation
 - c) Communication The Key to an Informed Decision

It was <u>recommended</u> that the following be the workshop topic for the 2010 General Service Conference: "Discuss the General Service Conference Agenda Selection Process," [PASSED]

Thursday April 30, 9:00AM – 11:00PM

Committee Reports and Discussion

During the Committee Reports, there were several times when I changed my vote after hearing the minority opinion. I shared this with a Panel 58 Delegate, and he said that was good, it meant that I had an open heart and open mind.

Literature

The committee <u>recommended</u> that the revised draft pamphlet "The A.A. Member – Medications and Other Drugs" be approved. [FAILED]

The committee <u>recommended</u> that the revised draft pamphlet of "A.A. for the Native North American" be approved. [PASSED]

The committee <u>recommended</u> that the trustees' Literature Committee undertake a thorough review of the pamphlet "Questions and Answers on Sponsorship" and eliminate or revise outmoded ethnic, cultural and vocational references. The committee looks forward to reviewing a progress report or a revised draft pamphlet at the 2010 Conference. [PASSED]

The committee <u>recommended</u> that a Special Needs recovery pamphlet for newcomers or prospective members be developed and that stories be solicited from members with various special needs, for example, members who are deaf, blind, wheel-chair bound, etc. The committee looks forward to reviewing a progress report or a draft pamphlet at the 2010 Conference. [Note: The approximate cost is \$6,850] [PASSED]

The committee <u>recommended</u> that a sentence encouraging newcomers to obtain and study the Big Book, Alcoholics Anonymous, be added to the pamphlet "A Newcomer Asks." [PASSED]

The committee <u>recommended</u> that the title of the pamphlet "44 Questions" be changed to "Frequently Asked Questions About A.A." [PASSED]

The committee recommended that the trustees' Committee on Literature develop a questionnaire to gather input from the Fellowship on whether there is a need to develop Conference-approved literature that focuses on the topics of spirituality, and agnostics or atheists/nonbelievers in A.A. and that a report which includes a summary of the results from the responses to the questionnaire be presented to the 2010 Conference Committee on Literature. [FAILED]

Additional Committee Considerations

- The committee considered a request to publish a book of stories from members living in remote communities and took no action. The committee noted that there was no widely expressed need.
- The committee considered a request to develop a second volume of Daily Reflections and took no action.

During the Literature Committee Report, Agenda item H: discuss whether there is a need to develop Conference-approved literature that focuses on the topics of spirituality, and agnostics/atheists in A.A. was a very hot topic. A group in our Area had requested this in 2008; it was approved at our January 2008 Assembly, and went forward as a proposed Agenda item by our Delegate. As the deadline had already passed to request an agenda item for 2008, it landed on the 2009 agenda for the Conference. There was tons of loving discussion on this item. I waited in line at the mic for 15 minutes, and the question was called before I got to say anything. When the Committee recommendation failed on the floor, I had the opportunity to speak in the minority on it. I gave an impassioned plea for this literature. The sense I got of the reason why it failed was that the body didn't feel that sending out a questionnaire on this item was enough action. There was a subsequent floor motion "Recommend development of Conference Approved Literature that focuses on spirituality and includes stories from atheists and agnostics who are successfully sober in Alcoholics Anonymous." This floor motion was recommitted to committee, so it will be back next year!

Corrections

A. Consider updating the pamphlet "It Sure Beats Sitting in a Cell."

The committee <u>recommended</u> that the trustees' Committee on Corrections undertake a revision of the pamphlet "It Sure Beats Sitting in a Cell" which will take into consideration

- More stories of recovery from alcoholism through the principles of Alcoholics Anonymous, drawn from Sharing From Behind the Walls, Box 4-5-9, or other available sources.
- Less use of 'directive' language (such as that used in the section on H.A.L.T.)
- Including photographs that reflect current times.

and that a draft pamphlet or a report of progress be brought back to the 2010 Conference Committee on Corrections. [PASSED]

The committee <u>recommended</u> that the photo on page 18 of the pamphlet "It Sure Beats Sitting in a Cell." which shows an inmate smoking a hand-rolled cigarette, be replaced with a photo of the current edition of the Big Book of Alcoholics Anonymous in future reprints, as well as in any revision. [PASSED]

Additional Committee Considerations:

- The committee reviewed the contents of the Corrections Kit and Workbook and made the following suggestions:
 - 1. That the list of contents be corrected to indicate that both the Corrections Correspondence Service flyer for the outside A.A. member (F-26) and the Corrections Correspondence request form for inmates (CCS-2) are included in the Kit.

- 2. That the Spanish-language and the French-language Corrections Kit contents be updated to match as closely as possible the English-language Kit. The committee heard a report from the Publications Director that A.A. in Prison: Inmate to Inmate will be completed in Spanish by fall of 2009, and the DVD A.A. in Correctional Facilities will be available in a compilation of all three languages by the end of 2009.
- 3. That a copy of the booklet A.A. in Prison: Inmate to Inmate (in the appropriate language) be included in the Kits.
- 4. The list of Corrections Kit Contents be placed on G.S.O.'s AA Web site in the Corrections 'bucket' with the appropriate links to each service piece, pamphlet or book where available.
- The committed considered alternatives to a biennial mailing to corrections professionals, and made the following suggestions:
 - 1. That the automatic biennial mailing begun by an additional committee consideration of the Conference Committee on Corrections in 1999 be suspended indefinitely.
 - 2. That the American Correctional Association Directory of Adult and Juvenile Correctional Departments, Institutions, Agencies, and Probation and Parole continue to be purchased on a biennial basis and the contact information therein be sent to the relevant area corrections committee chair.
- The committee discussed issues that may be involved in A.A. members' complying with the rules of correctional facilities, such as signing 'sponsorship agreements' or legally binding documents, and requested sharing from the A.A. Fellowship regarding this topic to be gathered by the staff member and the trustees' Committee on Corrections and that the sharing be sent to the 2010 Conference Committee on Corrections.

When the Corrections Committee gave our report, there was a question about how the picture of the "hand rolled cigarette" got into "It Sure beats Sitting in A Cell" in the first place. Chris Cavanaugh (non-alcoholic), AA Publications replied that the picture used to be of the 3rd Edition Big Book, and when the 4th Edition came out, they needed to replace the picture. Apparently, Publications was not able to review the next reprint of this pamphlet due to the draft being sent over in a different format. The bottom line is the picture was added in error.

Policy & Admissions

The committee <u>recommended</u> that the General Service Conference develop a procedure for the submission of minority appeals to the General Service Conference and bring a draft to the 2010 Conference Policy/Admissions Committee for their review. [PASSED]

The committee discussed the proposal requesting a General Service Conference Inventory and recommended that the General Service Board develop a plan for the General Service Conference to conduct an inventory of itself that includes a planning committee consisting of representatives of Delegates, Trustees, Directors, non-trustee Directors, and Staff, and that a progress report be presented to the 2010 Policy/Admissions Committee. [PASSED]

Committee Reports and Discussion

At one point in the discussion, the idea was expressed that Committees just slide difficult or challenging agenda items to the following years Conference. This was very disheartening to me, and has not been my experience at all.

Public Information

The committee <u>recommended</u> that the four selected A.A. Videos for Young People be approved with minor changes. [PASSED]

The committee <u>recommended</u> that the videos "A.A.: Rap With Us" and "Young People and A.A." be discontinued. [PASSED]

We got to view all 4 accepted video submissions, and they were awesome! Three were in English, and one in French. Apparently, there had been no acceptable Spanish language videos submitted. They are, however, continuing to accept submissions.

Additional considerations included:

• The committee requested that the A.A. Videos for Young People Project continue, and that video submissions be encouraged from young people in the Fellowship, especially from Spanish-speaking members.

Treatment

It was <u>recommended</u> that the committee's scope be expanded to include service to Special Needs/Accessibilities committees and that the name of the committee be changed to the Conference Committee on Treatment Facilities/Special Needs/Accessibilities. [PASSED]

During the Treatment Committee Report, there was a concern expressed about having full face shots of actors in videos for A.A. This is an area where there will be continued discussion on, and in fact there is currently a request for fellowship wide sharing. I emailed out a request for sharing, and I would like to thank the one person who responded to me email in time for me to forward the sharing to the Trustees Committee!

At 3:30 pm, the General Manager made a decision to cut the time for discussion at the mic per person to 1 minute from 2. This was in the hopes that we wouldn't be there all night.

Trustees

The committee unanimously <u>recommended</u> that the following slates of trustees and officers be elected at the annual meeting of the members of the General Service Board in May 2009: [PASSED: 105/18]

During the discussion of this Committee Report, there was a moment when it looked and felt as though the body was not going to vote to accept the slate of incoming Trustees and Directors of the Boards. One member asked that we vote individually, person by person, rather than for the entire slate. I had a very emotional moment when for just a split second I wondered what would happen to Alcoholics Anonymous if these slates for Trustees vote voted down? I felt scared for AA. I began to cry quietly in my chair, and someone came up to me and handed me a tissue. At that moment, our Pacific Region Trustee Madeleine came up to the floor mic and made the announcement that Bill M., one of our Region's past Delegates, had been killed in an accident. She was crying as she delivered the very sad news and she joked that no wonder all her Delegates were such crybabies, as look at her. Tears were streaming down her face. Later that evening, during a smoke break, I related what I had felt to my friend Elaine, from Washington DC. She told me "Girl, that's when I just knew that AA is going to be just fine. I know that our Higher Power was present." I love that! How we can just share with another, and their perception helps our perception!

International Conventions/ Regional Forums

The committee <u>recommended</u> that an anonymity-protected photograph of the flag ceremony be taken at the 2010 International Convention. [PASSED]

The committee <u>recommended</u> that an encrypted, anonymity-protected Internet broadcast of the 2010 International Convention Opening Flag Ceremony be approved. [PASSED]

Additional Committee Considerations:

- The committee requested that the trustees' Committee on International Conventions/Regional Forums consider ways that the broadcast of the 2010 International Convention Opening Flag Ceremony could be made more widely available than was the 2005 broadcast.
- The committee discussed the site selection process for the 2020 International Convention, and requested that the trustees' Committee on International Conventions/Regional Forums conduct a review and inventory of the site selection process for International Conventions and prepare a report for the 2010 Conference Committee on Conventions/Regional Forums.
- The committee discussed ways to encourage interest in Regional and Local Forums, including:
 - Be enthusiastic in announcing the Forum in advance, and reporting on it afterwards
 - Write an article about the Forum for a local newsletter or Web site
 - Participation is key get people involved in the planning of the Forum, as greeters, hospitality, registration, etc.
 - Encourage all segments of the Fellowship to attend, including those who speak other languages
 - Seek ways to prevent conflicts with other local events, such as sharing weekend A.A.
 event schedules through a central office or intergroup
 - Let members know that Local Forums can be requested by any A.A. entity; the request
 does not need to come through the general service structure
 - Overcome challenges of the cost of attending Forums by encouraging members to ride together and share rooms; some areas have rented buses for members to travel together.

- Floor Action #1: Recommend a thorough inventory of the Conference Charter be made a standing agenda item for the Conference Committee on Report and Charter.

- Floor Action #2: Recommend that the revised pamphlet "The A.A. Member Medications and Other Drugs" be returned to the trustees' Literature Committee for additional discussion and report back to the 2010 Conference Committee on Literature. [PASSED]
- Floor Action #3: Recommend a needs assessment for Special Needs literature that includes scope, content and cost of such literature by trustees' Committee on Literature.

 [DECLINED TO CONSIDER]
- Floor Action #4: Recommend development of Conference Approved Literature that focuses on spirituality and includes stories from atheists and agnostics who are successfully sober in Alcoholics Anonymous.
 [RECOMMIT TO COMMITTEE]
- Floor Action #5: Recommend that the price increases proposed by Alcoholics Anonymous World Services in a letter dated March 20, 2009 be withdrawn and the current pricing structure be maintained.
 [FAILED]
- Floor Action #6: Recommend we develop a uniform Conference approved policy regarding full-face photography of actors or subjects appearing in our General Service Conference approved videos, public service announcements or graphics arts projects, before any new projects are placed into production.

Paul C., General Service trustee said "Throughout our Conference structure there will always be paranoid conspiracy theorists, bomb-throwing anarchists, and naysayers. Ray M., General Service trustee said regarding this year's conference we did what we needed to do to get what we got. We didn't want to settle for second best, we wanted the best. That's why we were in session until 2:15.

Bob M., East Central regional trustee, shared that God puts you where you serve and then He qualifies you. He was much more diplomatic when he too presented there was division on the board. One of his points was there was a denial of a written minority appeal. I am not sure exactly what he was referring to (I suspect it was the ongoing controversy about the method of hiring the GM), but there is a recommendation in motion (Policy and Admissions) to develop a procedure for this. He said I am here, right now, for a reason. He stated he was witness to some very uncomfortable expressions of disunity on the board.

Finally Leonard Blumenthal and Herb Goodman, (Class A Trustees) said their farewells. Adjourn
