There were 194 attendees at the forum this year in Fairbanks with 107 of them being first time forum attendees. I sat there and watched and felt their gratitude for that opportunity and hoped that we could bring a Regional Forum to Hawaii—making GSO within reach of many AA Members in Hawaii. So, my question is -

Re: Looking for 'hot topics' for a district or group meeting? Turn to

quarterly issue of Box 4-5-9.

Often at the General Service Office when there is shared experience about a particular topic that may benefit groups and/or trusted servants in A.A., a chorus of voices can be heard to say "how about an article in Box 4-5-9?" However, putting that information in the pages of Box 4-5-9 won't be useful unless it is read!

To that end we hope that you will share with the DCMs and other trusted servants in your area the following key points:

- An issue of Box 4-5-9 is sent quarterly to each G.S.R. or other group contact for A.A. groups in the United States and Canada. This issue is meant to be shared with the group, possibly pointing out articles of particular interest regarding group issues that are brought to the attention of G.S.O. through phone calls, e-mails and other correspondence.
- The articles of interest to group life may be used as topics for discussion in A.A. meetings.
  - A few topics covered in recent issues include: How do you introduce yourself in A.A.? (Spring 2012); What can be done about a disruptive member? (Fall 2010); New and revised literature for group racks (Fall 2012 and many other issues); What is Conference-Approved Literature? (April/May 2008); How do we handle anonymity at the group level? (Fall 2012); a three-part series about A.A. group life (beginning with Fall 2012).
- The Winter 2012 issue will cover Gratitude Month in A.A., along with a myriad of other ways that the topic of self-support in A.A. can be addressed.

Also, you may want to note that there is an archive of Box 4-5-9 newsletters on G.S.O.'s A.A. Web site going back to the year 1990, with new decades being added as they are scanned. A.A. members can also digitally subscribe to Box 4-5-9 on G.S.O.'s A.A. Web site.

# ARCHIVES REPORT Interior Alaska September 2012 MOMENTS-IN-HISTORY FOR SEPTEMBER

Sept-1830: Dr. Samuel Woodward calls for creation of inebriate asylums for alcoholics across America.

Sept-1844: "Lodging Homes for the Fallen" are opened in Boston, marking the roots of getting alcoholics our-of-sight, out-of-mind and away from public view.

Sept-1894: Bill W's parents will marry at the Congregational Church in East Dorset Vermont.

Sept-1896: Dr. Silkworth meets and falls in love with Marie Antonette Bennett. Dr. Silkworth's nick-name for her was "Annette".

Sept-1910: Book "As a Man Thinketh" by James Allen published. One of eleven books (including the bible) that will influence how our Big Book will be written.

Sept-1914: At this time Bill W. and Lois B. meet and fall in Love. Lois was highly educated. Graduate of Packer Collegiate Institute in Brooklyn plus several years of art school in New York.

Sept-1931: Bill W. wrote his last promise to quit drinking in the family bible. He was a complete failure.

Sept-1938: Arch Throwbridge sobriety date. He sobered up under Dr. Bob. His story in our big book is one of the few stories that has survived all four editions of our book.

Sept-1948: John McDonnell opened "Pioneer House" in Minnesota. One of the first alcohol treatment centers in the mid-west.

Sept-1950: The National Institute of Mental Health in Washington D.C. establishes a special division on alcoholism

Sept-1954: Bill D. passed away. (A.A. #3) He was a pioneer member of the first A.A. group in the world, Akron's Group Number 1.

Sept-1974: Jim B. Passed away. Jim is buried near Fitz M. They are both A.A. Pioneers and both their stories are in the big book.

Sept-1977: The General Conference has issued an advisory action to all delegates that they establish area grapevine committees to achieve a grapevine representative in every group.

# SAFETY IN A.A.: OUR COMMON WELFARE



There has been much discussion regarding the 2012 General Service Conference topic, Safety in A.A.: Our Common Welfare. This is an important discussion to keep having. I suggest you use part, if not all of the subjects, as meeting topics. Please keep talking about this in your home group meetings. The following are some of the results from the 62<sup>nd</sup> GSC:

How can we make our Home Group a welcoming and accessible place?

SMILE.

Have both men and women greeters if mixed meeting.

Have the meeting space set up early

Be ready to escort handicapped if necessary.

Help newcomers find the coffee.

Be sure the secretary reads housekeeping items and guidelines for the meeting (e.g. cell phones away, no smoking, crosstalk, etc.)

Personally invite the newcomer back.

Be sensitive to closing the meeting with a religious prayer.

Don't leave any cleanup people alone to do the chores.

SMILE.

How can sponsorship aid in keeping our A.A. meetings safe?

Discourage profanity.

Discourage sharing re sexuality.

Educate as to pray vs. prey.

Offer guidance in life skills.

Be an example of appropriate conduct.

Be aware that predators exist and speak up if see inappropriate behavior.

In keeping with the Traditions, how would/does my group address matters that may arise, such as:

Conduct that disrupts the meeting

Be sure the secretary reads housekeeping items and guidelines for the meeting (e.g. cell phones away, no smoking, crosstalk, etc.).

Speak quietly with the person; if one-on-one is not effective, ask the person to leave the meeting (but not AA).



# SAFETY IN A.A.: OUR COMMON WELFARE

In group conscience, define disruptive behavior and develop a plan (snoring, texting, kids running around, pets running around.

Illegal activity

Any illegal activity that jeopardizes the health and well being of others needs to be reported.

Call police.

Take action, don't withdraw.

Inappropriate behaviors towards vulnerable newcomers (e.g. "13 Stepping")

Be aware/mindful.

Sponsors can alert newcomers to potentially harmful situations.

Encourage newcomers that we need to change behavior in sobriety (i.e. appropriate dress and language).

Inappropriate behavior includes more than sexual predation; be mindful of monetary predation and so-called personal behaviors; watch for drug dealers.

**Emergencies (injury/accident/fire)** 

Have procedures in place.

Call 911.

# Finally, here are two thoughts:

**Inaction = condonation** 

Remember: what's good for the group comes first, but personal welfare follows close behind.

Stick by them when they're inconvenient!




