Hosted by: East Hawaii District 7 Saturday January 21, 2012

## Call to Order: at 9:05 AM

- Serenity Prayer, host DCM announcements, welcome Past delegates Dick M. (Panel 39) Scottie (Panel 49), introduce new
  assembly members, birthdays.
- Update Archives, Cheryl N., Chair A group has been working on the archives. 98 boxes (down from 144 boxes) Working on decreasing archives, so if we decide to keep them, we'll be able to go to a smaller space. Could go to space 60% of what we are spending. Only women working on archives, men can help as well. We can use help with shredding papers. Consensus of what to do with archives. If consensus is to get rid, we need a plan for what to do. Ideas to think about: send back to island they came from, digitize, shred, etc.
- Agenda: reviewed. Our day is longer today so we can have a shorter day tomorrow (to take advantage of better airfares).

# GSR, DCM, Standing Committee Chairs, Intergroup, Area Officers Roundtables - followed by reports:

<u>Intergroups, Mathea</u> - Four of the five Area 17 Intergroups were represented, Jessica from Oahu, Billy from Hilo, Chappy form Kona, and Mathea from Kauai. The discussion was brisk. Our subjects were:

- 1. Schedules: paper, downloaded, charge for each schedule, how distributed. Most charge 10 cents for each schedule, relied on downloading for most needs, and print also 3,000 schedules per year.
- 2. Newsletter: Oahu no, other three yes and it was available online.
- 3. Phone Service: Oahu 9AM-9PM (non alcoholics of phone service 9PM-9AM); other three had 24/7 coverage by alcoholic members in recovery.
- 4. Physical Office: all but Kauai have one.
- 5. Website: all four Intergroups have websites that are actively managed.
- 6. Budget: Oahu low on money last year. Kona budget \$23,000 with \$4,500 reserve. Hilo not known. Kauai \$2,000 with 10% reserve.
- 7. Support events with money: all support 2-4 events/year.
- 8. Literature: all four have literature bought in bulk from GSO and sold individual pieces at GSO individual prices, which is more than bulk and important income source.
- 9. Intergroup Meetings: each was once a month.

Thanks for this format so we could exchange ideas.

## DCMs, Tommy- DCM Roundtable Wrap up Report

At our DCM roundtable we decided to start by talking about how our districts are doing. Jesse the alt DCM for tri-island mentioned about the May Committee Meeting - that it would be closer to fly in to Kapalua instead of Kahalui, she also mention about their communications with Molokai and Lanai.

# Tele-Service:

Bob has been doing tele-service for 3 or 4 years. Gotten only 2 calls in that time. Due to a particular good website. Bob does it on Saturday. Tele-service is an Intergroup function.

Ches said that he worked on tele-service because of resentment from no help on Ohau.

12th step calls are hard to contact. Need more phone numbers to be able to communicate.

Dick: two separate things. Out of 600 calls only 30 may be needing 12 step. Others are informational. Check website or local intergroup. Go back to your groups and find out what's happening with intergroups, as to service and 12th step list. Communication:

Margaret: Sponsees call their sponsors. No responses from emails and left messages. What should she do next? Chairs are not getting back to committee members. Solution needs to be: meet some of the committee chairs. Puna group is starting to get some help from Kona. Face to face to approach persons.

Steve from Diamond Head: Two way is a must, can improve, by finding out what is expected of us. Agenda was confusing to access. Website is listed in GSR Handbook and Agenda is posted there.

Dick says to stay involved.

Marissa: DCM explained Areas duties. Varied people on different islands and different committee. Get the information out and respond quickly! Responsible, for returns.

Ches: said to replace people that do not show.

Dick: said Volunteers need to be responsible and responsive.

Neighbor islands hosting has helped. Used to be only on Oahu. On 18th there is a committee to address these issues.

Tradition 6

Ches: brought up Alano Club problems, and tradition issues. Cannot be addressed on Area Level. DCM and Intergroups have addressed issue.

JD: each group is atonomous, we must trust that things will eventually sort themselves out. God is the ultimate answer.

Steve: Really appreciates this being brought to attention. And inform his home group and enjoy the opportunity to bring this up. The message will be delivered. Will bring up at next home group meeting.

JD talked of the importance of contributing and being registered.

Patty: Arizona Alano clubs have community fund raisers. Alanoclubs are an outside issue.

Kevi: These issues will eventually work themselves out. Autonomy is paramount. You will read BB and  $12 \times 12$ . Good thing we are all sober. Principles before personalities.

Polani: Alano clubs are a great help to the alcoholics. Great place to get sober.

Loyal: Lest money, property, and prestige divert us from our primary purpose. We do not discipline each other. No penalties.

## GSR group 1, Linda-

- 1. How to get a volunteer to work at intergroup for free in a paying job: Presented at intergroup meetings, withhold funds, or fill out application.
- 2. How to get participation in activities: GSR lead by example with enthusiasm, relay you experience to anyone interested, get sponsees to attend, pick them up. Love your service and show it, encourage all members to attend assemblies in their neighborhood.
- 3. How to get members that are active to become GSRs: Railroading does not work. Nominate at group meeting. Describe the job completely and explain its importance to the life of AA as a whole and to the lives of members. Home group voted for money, save for assemblies, helping hands tickets. Home group needs to vote their group conscience to fund GSR. Read the pamphlet "GSR May Be the Most Important Job in AA." DCM go to home groups and stress the joy of general service. Recite Responsibility Pledge often.
- 4. How to report back to group: no long reports at group meetings, during your share, short excerpts during AA announcements.
- 5. Ho to get GSR to PRAASA save for it, send GSR every two years. New GSR, fundraisers. PRAASA opens the world and makes us better servants.

Officers, Coleen - We discussed: 1. The pros and cons of pairing a committee meeting with assembly. 2. Layout of the room, so that the focus is on the person at the microphone and everyone can hear. 3. The need to let those not in service know what Area 17 service does, and how they can work with the area and/or committees, if they want to participate.

## Inventory Report Back -

Each of the 9 inventory groups presented summaries at the mike. Notes from these groups were submitted. These will be reviewed by the Area Chair. The Chair will summarize the 9 inventories and email this summary to the assembly. Based on this summary, The Chair will also present possible action item at the committee meeting in February.

# At the microphone -

- + Archives is such a mess, far from being ready to be digitalized. Help out for an hour or a day. Also, newcomers at assemblies go brain dead. Have past Delegate have mini orientation for them at the beginning of the meeting, make assembly more inclusive.
- + Archives we don't know what the other 92 areas are doing about their archives. Others have gone through this. Delegate or Chair ask at PRAASA to see what they do, have done.

- + Adhering to tradition and concepts almost entirely. Our Hawaiian air code gives Hawaii Area 17 credit to areas flights. Seems like an affiliation.
- + Observation, seems we spend lots of time in round tables, talking about things, hearing report. But we don't seem to do a whole lot of business. Don't feel like I've gotten help from group as a whole from learning about our concepts and how they apply to business we conduct here. Service sponsor suggested, but more emphasis in training us on concepts. i.e. Workshop discussion, one concept per assembly.
- + Assembly goes someplace else, we have more participation for those on that island. Because of that more contacts, more info from area to this island because area rotates from one district to another. This is an opportunity to inform. Before deciding to Skype, anyone can come to an assembly so they get informed. The voice of AA in Hawaii is here, and if we don't share that we are remiss
- + Rumors about lots of things. When you hear something that sounds like information, maybe doesn't smell right, check with someone who knows. You might have received misinformation.
- + Member who didn't sign up to assembly, first attended here. Archives have been very important. It's a major task, important that we keep the legacy of that going. Newcomers and repeaters won't get a chance to know it if it's all digitized. Important to show and share it with everyone.
- + Get at least a little information on all meetings on all islands, rather than a lot of info from a few meetings.
- + Archives -Like to see area make a decision, to have one, and how much to spend on it.
- + Everything is at my feet, it's up to me to pick it up. I learn, I make mistakes. I get something when I come here, and it's the work that I need to take back. It's been a journey, not easy. I was afraid but you guys gave me the opportunity to work on me.
- + Listening to conversation, inventory taking. My experience I am responsible. You're not, I am when anyone, anywhere reaches out. I've done studies, tradition, big book, concepts. Take responsibility of informing those I sponsor.
- + On back table there are registration forms for 19th annual Aloha Round Up. All are welcome. All.

Also in January, we received our Agenda Item "D." It was presented in April at the Inform the Delegate Assembly.

In March the district's DCM and Alt DCM attended PRAASA in Honolulu. They attended all Area 17 Assemblies as well.

In the summer, District #4 invited our Delegate, Linda McD. to present her report back from the GSC in New York. We also had a visit from our Alt Chair, Bob H., who presented Area 17s Proposed Budget for 2012.

In September, we hosted the Area 17 Budget Assembly in Kaneohe.

In October we attended the Woman's Health Fair at Waimanalo Health Center. We provided an information booth.

The site has our meeting schedule, events, flyers, links to new AA's literature and much more plus beautiful flower pictures, one for each day of the week by which meetings for that day are located. All is well in Kauai Intergroup.

# Annual Hawaii Convention:

As a member of the Annual Hawaii Convention I was on duty during the convention. It was the first time I'd been in this position and I was a bit nervous as things got rolling. During the convention itself my main job was to be present and visible. Everyone in service

knew their jobs well so thing went very smoothly. I spent most of my time thanking our volunteers for doing such a good job, asking if there was anything they needed, and mostly just being available. I attended the follow up meetings and lots of good information on how things could be improved though as a group we all agreed that this one of the best recent conventions as far as operations went

Then it was back to business and meeting regularly with the rest of the steering committee. Kunane fulfilled his term as chair of the steering committee and our new chair of the steering committee (not the convention itself) is Zack. Of particular interest to Area 17 are the decisions we've made over the course of the last year and reaffirmed recently:

- 1. The Area will no longer be required to spend money to send the Alt Delegate and Alt Chair to attend Steering Committee meetings. Currently as both Ken and I are on Oahu no money is being spent, but if one of us were to step down and be replaced by a non-Oahu servant the cost would be to the convention and not to Area.
- 2. In addition the convention will be taking care of housing during the convention should it be necessary to bring an Area servant from another island to Oahu.
- 3. Finally it appears, though figures won't be available till the next assembly, that the Convention will be able to make a contribution to Area this year. This would be from funds in excess of those necessary to fully fund the prudent reserve. In short, the convention is very solvent at this time.
- 4. Work on Appendix C continues.

#### Oahu Intergroup

I continue to serve on the Oahu Intergroup and am very involved in the committee to reexamine their by-laws. We have not issued a recommendation yet, but our work is scheduled to be completed in April and is current on track.

Rich, Oahu Intergroup Chair, stepped down recently for personal reasons and I'd like to extend a big Mahalo to him for all his hard work. In his place the Vice Chair, Jessica, has moved taken over the position and currently a search is on for a new Vice Chair.

- Compiled the Year End Summaries from Area Officers, Standing Committee chairs and DCMs. It's up on the website for
  all to review and I have made copies for DCMs, Standing Committee chairs and the Area Officers. Mahalo to those who
  have submitted their reports. One of the reasons I wanted to do this was so we would have an easy answer to those who
  asks "What does Area do?"
- Attended District and Intergroup meetings in West Hawaii.
- Worked with various DCMs and Standing Committee chairs on issues that have come up.
- Worked on the Archives and continued to look for people willing to serve on an Archives ad hoc committee. So far, no one
  has stepped forward. It's time for Plan B. Our alternate delegate will be heading up the committee so now's the time to
  step forward if you're interested.

I am going to go a little past my three minutes allotted because I've been hearing concern about 'Hawaiian Miles for Area.' When I heard this from a number of people I called one of my service resources – a past delegate. She reminded me that Area needs to be prudent with our funds. GSO puts on the International Convention every 5 years. A few years ago, San Diego was one of a number of cities that had submitted a bid to GSO to host the convention. Each city's Visitor Board presented their package to the committee – just like they do to all the other potential conventions. Not just to AA because we are AA but that is how they attract the conventions. San Diego won the bid because they provided buses. GSO participates in a similar plan with airlines that serve the hosting city. So, GSO, being prudent with its use of 7<sup>th</sup> Tradition funds, takes advantage of this routinely.

The Hawaiian Miles program is something they offer to anyone who uses them regularly, not just to AA. They call it their "Preferred Affiliate" program but those are their words. We are not affiliating with them but we are taking advantage of this opportunity to be prudent with our  $7^{th}$  Tradition funds.

Happy New Year to each of you. Welcome especially to any new GSRs and other assembly members. The groups comprising A.A. today hold what co-founder Bill W. called the ultimate responsibility and final authority for our world service. The entire structure of A.A. starts with a single group; and the way each group conducts its affairs has a ripple effect on A.A. everywhere. The direction of the group is essentially determined at its business meeting... It is essential that the members be given all the facts relevant to the subject at hand in a neutral tone. According to our Concepts, we avoid undue concentration of money or personal influence in any of our service groups or activities. That's one of the beauties of rotation. Even GSO staff members rotate desks every two years. It is important that we hold each other accountable while trusting those servants selected to serve us.

G.S.O. and A.A.W.S. have been busy at work, as always. Some of the international service events include the 9<sup>th</sup> Asia-Oceania Zonal Service Meeting in India, the 17<sup>th</sup> Zonal Meeting of the Americas (REDELA) in San Salvador, El Salvador, and the 16<sup>th</sup> European Service Meeting in Frankfurt, Germany. During REDELA, a request was made by the delegates of Ecuador, Peru, and Bolivia that the Big Book be translated into Quecha, the ancient language of the Inca, spoken today by about 8 million people. The request was forwarded to the International Desk to be sent to the A.A.W.S. Publications Department.

The A.A.W.S. board meets monthly to hear progress reports on ongoing projects, to consider new requests received by groups, and to tend to other pending business. The following are some highlights from the last three months.

	The Treatment Committee appointed a subcommittee to review the script of the video "Hope: Alcoholic Anonymous" taking into consideration concerns expressed by the 2011 Conference Committee. After discussion on the report submitted by the subcommittee at the October board meeting, the committee agreed that the concerns expressed by the $61^{\rm st}$ Conference Committee did not warrant the cost to remake the video or remove any single line of dialogue. In addition, the committee reviewed an area suggestion on a possible piece to carry to A.A. message into treatment settings for those who have mental illness. The Publications Department will prepare a draft of the material to bring to the January 29 meeting of Treatment/Special Needs-Accessibilities.
_	The Corrections Correspondence Service (CCS) put out a request for male A.A. members on the "outside" to correspond with male members in correctional facilities to share their experience, strength and hope. To participate in this service, contact the Corrections Desk ( $corrections@aa.org$ ) or write to Corrections Desk, G.S.O., P.O. Box 459, New York, NY 10163. You can also call (212) 870-3400.
	The Literature committee continues the valuable work on literature that focuses on spirituality. The current process is to review and prioritize the 201 stories submitted. Progress has also been underway on the revision of the pamphlet "A.A. and the Armed Services" with the intent of including new stories, stories previously published by the Grapevine magazine, and a few stories from the current pamphlet. Revision of <i>Living Sober</i> is going forward as well. A new request was made by an area to add the Twelve Concepts for World Services to the current edition of the Twelve Steps and Twelve Traditions. Different variations in this regard are also being discussed. I would look for this to be included in the 2012 Conference Agenda. A Navajo translation of "How It Works" will be sent to the Publications Department Director for authentication and to ensure that the translation maintains the spirit of Alcoholics Anonymous. All translations go through this necessary process.
	A.A. Regional Directories: work is planned for the 2012 Directories. In order to be included, a group must provide a name and phone number for the contact person. The deadline for the new Directories is May 11.
	2011 Membership Survey: last year, three groups in Hawaii were chosen at random to participate in the triennial survey. The more than $10,000$ surveys completed are currently being tabulated. The 2011 Membership Survey pamphlet should be on hand for approval at the $62^{nd}$ General Service Conference.
	The board received a Copyright and Reprint Report, presenting an overview of policies, practices, and information. Included in the report is an inventory of the status of copyrights on major A.A.W.S. works. The report will be a valuable tool in the review of intellectual property issues.

□ A new proposal was submitted for posting Daily Reflections on G.S.O.'s A.A. Website, with an optional e-mail delivery service.

1. The subscription service is one-way communication.

The recommendation was approved with the following conditions:

- 2. There is an unsubscribe function.
- 3. Anonymity for the A.A. member who subscribes to the daily e-mail as it relates to the sender's e-mail address.
- eBooks: the Fourth Edition of the Big Book and the Twelve Steps and Twelve Traditions are now available in eBook format for certain Apple devices iPhone, iPod Touch, and iPad. In order to download the books, you must first go to the Apple App store and get the AA eReader app for free. You can then purchase the books through the A.A.W.S. Online Store for \$6 each. The eBook project is ongoing with plans underway to offer the books to Android users and which books to make available. The priority in planning has been to maintain control of the sale of eBooks by A.A.W.S. and to ensure to protection and integrity of the A.A. message. For more information, go to aa.org and click on "e-Books."
- □ Website: aa.org was launched nearly 16 years ago. Since then the Website has expanded to embrace evolving technology. You can now read the Big Book and the *Twelve Steps and Twelve Traditions* online, make contributions online, and subscribe electronically for newsletters. Currently, the board is considering revision to the Website policy to delete reference to the prohibition of online sales, such as described above.

The workshop topic relates to Tradition One, which states, "Each member of Alcoholics Anonymous is but a small part of a greater whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows closely afterward." Three questions have been posed, which are intended to facilitate a full and fruitful discussion:

- 1. How can we make our Home Group a welcoming and accessible place?
- 2. How can sponsorship aid keeping our meetings safe?
- 3. In keeping with Traditions, how would/does my group address matters that may arise, such as:
  - a. Conduct that disrupts the meeting
  - b. Illegal activity
  - c. Inappropriate behavior towards vulnerable new members (e.g. "13 Stepping")
  - d. Emergencies, such as injury, accident, fire, etc.

I am hoping that we can have our own workshop on these topics at our April Inform-the-Delegate Assembly.

We have been keeping busy giving out literature out to the Treatment Facilities, Clean and Sober houses, homeless shelters, and Adult Mental Health. First of all, we only spent a little more than 34 dollars on hospital work this past year. Since Hugh is out of money for Treatment work, this may change for the current year because Hugh and I have talked about working together. We may eventually suggest that these two committees be permanently joined to better carry out this work and bring us more in line with the recent General Service Conference decision to use the term "treatment settings" which encompasses both types of facilities.

This morning's Hospital Committee meeting was a wonderful experience for me. I love getting together with you guys and thank you for the corrections to the hospitals list we came up with.

That list was posted on the wall over there and it shows (somewhat) the hospitals in the different Districts in our area. It was put together as a display for the convention and it has many mistakes, but it is a beginning.

I've given DCM's a list of what I thought were hospitals in their districts and asked that they reference the work being done in these facilities so we all can have a better handle on how we're carrying the message into these facilities.

Archives, Adinah - Archives standing committee met at the Area Inventory Assembly

Past minutes: None. Linda McD. provided an update on the progress of the temporary Ad Hoc Committee. Unfortunately, Heidi G. had to step down as the Non-rotating archivist in September 2011 and Linda along with several other volunteers have visited the storage unit in Kapolei on several occasions to assess the problem and develop a possible plan of action. Initially, there were approximately 144 boxes and with a lot of hard work they were able to reduce them down to approximately 98. However, much more work needs to be done. Several boxes have the same information base on who supplied the material.

All members of the committee agreed it is important to preserve the physical documents, some important memorabilia and to discard the duplicated information and digitized the balance in hopes the whole body will have access to the Area 17 Archives in the future. However, a plan for Area access is secondary to reducing the cost of the current storage facility and thus reducing the amount of stuff in the storage unit.

It was suggested we develop a plan of action to present a comprehensive plan to the body for review. We determined the primary action was to reduce the duplication of non essential materials. Together we determined some realistic goals to meet a flexible timeline.

- 1. Reduce the non essential material by 30 boxes every 4 months:
  - Committee and other volunteers to meet at the storage facility in Kapolei on Sunday's from 2-5
    - Volunteers need either to be knowledgeable about AA or be supervised by other members of AA who have knowledge of what is important. So, valuable information is not lost.
      - A set of the GSO guidelines are available at the storage unit for review by all volunteers.
    - Get rid of trash, unnecessary office supplies and donate desks, storage cabinets and selves.
      - Bart Waianae DCM agreed to help with these items.
    - Extra Grapevines to Budget Assembly and give to the Grapevine chair for disbursement.
    - Have the Oahu Central Office Manager review the boxes of Intergroup material, to determine their value and what should be kept.
      - Dick has agreed to assist with this portion of the project.
- 2. By Inform the Delegate Assembly provide a proposal to reduce the size of the storage unit as the amount of material has been reduced.
- 3. By Budget Assembly discuss the possibly of digitizing the balance of material remaining.
- 4. By the Election Assembly request funds for the digitizing.
  - Linda to meet with a professional digitizer in January and visit the facility and discuss a plan of action for future digitizing.
  - Hope to place all digitized information on flash drives

Convention - District 7, East Hawaii DCM, Alfred N. (presented by Francis)

Motion made by Alfred, seconded by Bill. – (This proposal did not pass: Yes= 6, No= 67). Procedure as followed:

#### Discussion:

- Against the motion this is the third time I've seen this come up. Association between area and convention is productive.
- Do use AA guidelines that explain how to put on a conference. Reasoning is, if one is wrong the whole this should be thrown out. Prepaid attendance if it is wrong, the assemblies are wrong too.
- Is there a problem with money being contributed to area?
- The cooperation between the two is breaking the traditions.
- Group decided to accept that steering committee pay for the chair. We want to keep it as it is, but I was listening about groups and contributions back to AA. I would like to decline contributions back to AA because we don't need that money. Be inclusive, adding to convention by allowing home groups to hold alcathons at the convention.
- Cheryl read out of the S and G 5.15 re money back to area
- Home group felt relationship is beneficial, oppose this proposal
- First, propriety of contribution from convention back to area international convention took the extra money and it went to GSO. Second most states have conventions which are affiliated with area or district structure. It's in the general service material how to conduct conventions. District believes it to be beneficial, since the 60s.
- Been part of committee for a while. It's always been a beneficial relationship. We come to area, serve area, sit at round tables, look for GSRs to share information, and take info back to home groups. I've always felt the connection. Having alt del and alt chair bring their experience to he table, beneficial to convention. Never been a separate body. Not the perfect communication effort, but we do it the best we can so area is well informed, and we keep trying.
- Point out in GSO guidelines, most convention make a profit. what's to be done? Part held for next convention. Then committee may use balance to support local service or general service.
- Last year the district was for it. But, first issue it wasn't inclusive, second area wasn't included. But I was invited to share, the topic was about area service. The panel has changed to include the area. This has changed my opinion, and I have changed my mind.
- Under our literature the committee isn't an AA group, it's a sub structure of area. They don't use the AA name. Don't call it the AA convention, but our literature is there.
- At first didn't know what was going on with AA or the money, as a newcomer. Only requirement, desire to stop drinking. The answer in tradition 3, experience taught us to not take away opportunity for new person to attend. Newcomers with no money, we're sinking to his death. No matter how good the cause is, in the long term it messes our structure and true message. It's against our traditions, wasting time on this. Convention is set up enough to keep itself going, doesn't need AA help. AA doesn't need its' help, though it's nice.
- We're part of a bigger whole. People come from the mainland because this is Hawaii. Someone needs to think about those folks too.
- My group conscience, they expressed it's been going on for some time. If it's just money, they were for the separation because don't believe area should pay for alt chair and alt del to go to the meetings. But yesterday after round table discussion, re outside contributions, I'm questioning the money. They are changing, and the convention is paying for alt chair and alt delegate to attend meetings because I am a trusted servant, and I have new information that can change my groups vote on it, my vote will be to keep it together.
- The budget, it doesn't matter how big it is. It's us being responsible as alcoholics. Good the convention has a budget. Tradition 7 re prepaid entrance. A lot of functions are prepaid, I've been to function where I had no money and they said come in, or someone has a scholarship and has paid for it. We are self supporting. It's our state convention. Steering committee serves, staying in traditions checks and balances. Convention is changing and adapting. That's positive.
- Against proposal, cant site chapter and verse except personally the convention has been very inclusive, especially in the last year to make it an all Hawaii convention and not just an Oahu convention. The steering committee has made great strides in fixing some of the objections as to the way the finances were handled. Don't see need to change things.
- Groups' objections have all been met by the changes that the convention has addressed at the assembly. So I get to bring that back to my group and have them reconsider. My recommendation is that we don't change.
- Kalani, motion to table the motion and bring this back to our home groups. I didn't know about convention paying for alternate until today. Want to bring it back to home group and then vote for it.

# Minority Opinion:

-Not against the convention, against it being under the structure of the area. And basically because convention money cannot be put back into AA area. The structure needs to be changed. It is taking money from outside, it's paid money. Convention money shouldn't be put into area. This issue will be continued into the next area assembly.

- 6th tradition read. In my opinion, we're endorsing and lending the AA name to an outside enterprise. IT's a good thing, but literature from Bill says lets don't sacrifice the good for the best. Is this convention doing what we want? And things go back the way they were? Where are the checks and balances? All we have is pulling back the AA name. What is AA getting from the convention that we need it. What does the convention get from AA that it needs. This controversy will continue. No one changed their vote, the motion failed.

<u>Report on Structures and Guidelines Review</u> - Ken K., Alt. Delegate - This committee met at the September 24-25, 2011 Budget Assembly and the following items were discussed:

- 1. Change the title of the Structure and Guidelines to Hawaii Area 17 Service Manual.
- 2. Section 7.5, D. Priority Of Spending: Rather than define "The priority of spending is as follows:", give

the Finance Committee some leeway to determine priorities.

3. Section 2.10, F and Section 7.3 refer to the Prudent Reserve. Section 2.10, F refers to "a Prudent

Reserve as specified by the budget" while 7.3 states that the Prudent Reserve is \$5,000. These two

Sections should be consistent.

4. Section 2.10 Treasurer's Duties. Add "J. Maintain tax-exempt status". Tax-exempt status is defined

In section 7.6)

Additionally, we recommend that the Area Chair assign a committee to be responsible for any updated changes to the Structure and Guidelines, as approved proposals occur, to insure that the Assembly members are well informed. This committee would also need to be informed of any updated information under the Corrections and Convention Committees for inclusion in the Structure and Guidelines. This committee would give a written report of all updated information at Assemblies and Committee meetings.

Corrections, Lena - We are currently going through it and will have an update at the next assembly.

<u>Convention, Zeke -</u> Also working of S and G. Everything you heard about convention paying for alt. also looking and changing term limits. It's a constant work in progress to change the S and G. Most recommendation come from people attending convention, what they would like to see is different. Your voice is heard. If you have other recommendation, contact Zeke. Will have an update by the next assembly.

#### Ask it Basket:

What are Area's main responsibilities. Refer to Area S and G, can get it on website. Service materials) you can print out a copy of the S and G. Linda read page I Preamble of the Hawaii Area Structures and Guidelines.

If a group does not have a GSR, their group has no voice in AA as a whole.

Can we have the entire GSC agenda in addition to those topics selected for discussion, helpful for PRAASA? Yes. There are usually 100 things on the agenda, a lot are not topics for discussion, and have to do with reviewing draft publications. The committee gets

those items. You have to pay for the printing. At the February committee meeting I have CDs available for DCMs for the background material.

Could we have a survey of what other areas do about their archives activities and budgets? You can have what you want. No sure how to go about getting that info to you. And if the body wants that info, I can get it to on at the next assembly.

- thank volunteers to help clean up archives. Heard treasurer's report, it's great and thank them for more help. If we can get archives down to 50% and get storage at  $\frac{1}{2}$  the price, we would have been prudent.
- how to save money; Videoconferencing. Stop talking about it and do it. We need to save some money. Like to see it done before this panel is done
- can we meet in handicapped accessible location? We need to try to do that. Sometimes we're hampered by location. We need to look at and will in the future.
- -Registrar- thank for returning everything.
- -Money -We did fabulous last year given this economy, and contributions a so way down and expense are up. Didn't mean to be sarcastic about if you want something you have to pay for it. If we want the services, we have to pay for the services. The spiritual value of our dollar. Sometimes not decreasing expense, sometimes increasing contribution.
- -Money, past Delegate a few years ago. I put \$2 in. one for me for me, and \$1 for the suffering alcoholic. PRAASA, I put \$3 in, one for each for the three legacies. Person at home group shared, no matter what's going on I put \$5 in my home groups basket.
