<u>Delegate Report</u>, Linda - I also attend a lot of intergroup meetings. Thank Ken for filling in for her due to physical challenges.

The 62nd General Service Conference was held in Rye, NY at the Hilton Rye Town April 22nd-28th. The theme this year was "Anonymity: Our Spiritual Responsibility in the Digital Age." I wish I had the words to describe to you that, while the week long schedule is grueling, the work is satisfying and spiritually fulfilling. I think Ward Ewing, Chair of the General Service Board, put it best in his opening report, "I have always viewed the General Service Conference as a spiritual adventure - at once exciting and a lot of hard work, but also uplifting

as we seek to reach an informed group conscience for A.A. in the U.S. and Canada." This part of my journey is so amazing to me that anyone who drank like I drank and felt like I felt would have evolved to be a member of the General Service Conference that develops and improves ways of reaching people who are still drinking and feeling that pitiful, incomprehensible demoralization. I believe that we are all here because of the General Service Structure and our trust in the processes of the GSC. I know today that I am sober in Alcoholics Anonymous because someone took the responsibility to reach out with the hand of A.A. We hope that hand will always be there in fulfillment of our responsibility.

I am not going to give you a full report back today. I hope that each of you plan to attend a report back when I come to your district. So far, all districts but two have scheduled dates with me, at least tentatively. (Please see the schedule at the end of this report.) I will touch on some items that were mentioned during open discussions during the Conference. We were asked to remind you that each home group is encouraged to have a Grapevine representative, who ought to register with The Grapevine, Inc. in order to receive helpful materials. However, the current Grapevine Workbook is way out of date. A plan is in place to update the Workbook, but the work has not been funded. And speaking of the Grapevine, I am happy to inform you that The Grapevine, Inc. (not including La Vina) finished 2011 with a net profit of nearly \$23K!

At the last assembly, I informed you that the conference members received an additional agenda item brought by the General Service Board to the Conference regarding the development of a plan to restructure the current Grapevine governance and structure while retaining the Grapevine's independent voice. The purpose of the plan is to increase unity, better reach and connect Grapevine, Inc to the broader Fellowship while addressing financial stability. So the first thing that happened was a motion made during the Delegate only dinner on Saturday night, to send the motion to committee. Following some discussion, the motion sort of died due to the fact that the conference had not officially started, and the Saturday night dinner is considered to be more of a social gathering. Once the motion was heard in the order of business, multiple "friendly" amendments were made and accepted, and over three hours of discussion ensued before the motion was, in the end approved. Please be advised that the purpose of the plan will be to improve the performance of The Grapevine, Inc. and has no hidden agenda to end the Grapevine magazine.

The theme has been chosen for the 63rd GSC: "The General Conference Takes Its Inventory - Our Solution in Action." The 62nd Conference approved the presentation/discussion topics for next year:

Spiritual Principles for World Service:

- a. The Triangle More Than a Shape
- b. The G.S.C. Inventory Why Is It Necessary?
- c. Self-Support What Does It Mean to the Fellowship?
- d. Primary Purpose Carrying the A.A. Message

There will be fewer presentation/discussion topics in the next three years to allow time for the inventory. The 2013 and 2014 Conferences will each consider 15 inventory questions, leaving 14 items for the 2015 Conference.

Other news from A.A.W.S.:

International - Member is Iran have formed a small General Service Board and a GSO. They are now working on developing a Conference structure. A member in Cook Island wrote about the Maori Big Book translation: "We are already using the Chapter 5 translated content in out meetings both in town and in the prison. It has been VERY well received by local members." A volunteer with the Peace Corps in Uganda reports that the literature sent by GSO is being used for the prisoners at the Uganda Government Prison-Gulu. And a member from Zimbabwe was elated with the box of literature they received, especially Daily Reflections.

- <u>Ebooks</u> As you know, the first two A.A.W.S. eBooks were launched on a new A.A.W.S. Online Store. They are working to ensure the smooth operation of the system and sales simultaneous with the development of an App for Android and iPad. The IT group and Publications Department are addressing post-launch corrections, adjustments and communications. The next two eBooks planned for release are *Daily Reflections* and *Living Sober*.
- Reminder: Daily Reflections is now available on aa.org in all three languages. The page is updated daily. The new page can be reached by clicking on the "Daily Reflections" link on the upper left corner of the home page.
- Bar codes: The Publications Department will be providing bar codes on books in order to help track inventory and process purchases. The Department will also look into adding bar codes to A.A.W.S. pamphlets.
- <u>Copyrights</u>: A sub-committee has completed an inventory list of the status of copyrights on major A.A.W.S. works. One of the purposes of compiling such a list is so that we do let copyright expiration dates go by unnoticed.

- Class B (alcoholic) Trustees Three new trustees will be elected at the 2013 GSC. Elections will be for the East Central and Southeast Regions and for trustee-at-large/US. Resumes for trustee positions are submitted by delegates and are due by January 1, 2013. A sound A.A. background is a basic qualification for Class B trustees. Ten years of continuous sobriety is desirable but not mandatory. Candidates should be active in both local and area A.A. affairs; and because trustees serve the entire Fellowship, they require the background and the willingness to make decisions on matters of broad policy that affect A.A. as a whole. It is also important that trustee candidates understand the commitment of time required. Trustees are expected to attend three quarterly board weekends, with meetings often scheduled from Thursday afternoon through Monday morning, and the GSC which lasts for one week. Often trustees are asked to attend a Regional Forum weekend. In addition, regional trustees are usually asked to serve two years on either the A.A.W.S. or Grapevine Corporate Boards, which meet more frequently that the GSB.

Estimated 1,400,000 AA members in US. If each contributed \$1.00 all of GSO's projected plans would be funded.

Pamphlet on Spirituality that includes stories from atheists and agnostics (working title) should come out of committee probably next year. Trustees have reviewed the spirituality stories, whittled it down to 23 stories. Reviewed by committee and sent back to trustees for further development. It's not being stopped. Things in AA take a long time.

Q/A

We don't know if any of the stories are from our area.

The next three years, the panels will take inventory, so they have a lot to do. And they will have all the conference business on top of that. (> 100 agenda items and inventory process), so be aware of that. Ebooks - are not available on nook yet.

GSC support - Minimum requirement increased from \$1,200 to \$1,60D. Did it increase our support amount? The conference works on committee system. The committees meet separately, then we vote on items that the committees have decided we'll vote on. It seems that item went smoothly. Areas that cannot contribute all of the amount can still attend. Some areas are able to contribute more that that amount. We help each other and are interdependent on each other.

What happens with net operating income? I believe it goes in the reserve fund. Our reserve fund = 11.3 months of operating funds.

Sexual predators in AA, was it talked about? Yes.

Also, wasn't there a discussion on safety in meetings? Yes.

The workshop topic was safety in AA, our common welfare. It was broken down into 3 topics. The first was how to make home group welcoming and accessible. Smile, have greeters (men and women). Set up space early. Be ready to assist disabled if necessary. Help newcomers find coffee. Secretary reads housekeeping items. Invite newcomers back. Keep an eye on newcomer, done' let them feel unwanted, or sit in a corner because that's when stuff happens. Don't leave the clean up people alone to do the chores.

Sponsor ship can help: discourage profanity, sharing on sexuality, educate sponsees and newcomers that this does go on and distinguish between pray and prey. Offer guidance in life skills, (ie appropriate dress) be an example of appropriate conduct. Be aware and speak up if you see inappropriate behavior. Domestic abuse or abuse of any kind is every ones problem, not just the victims.

How would/ does the home group address matter that may arise? i.e. disruptive conduct that may disrupt the meeting such as predation : money, sexual, drugs. Notice, be aware, be mindful, and speak to the person, talk and take a group conscience and have a plan. We cannot police our meetings but if someone is disrupting the meetings, address it. (distractions such as sleeping, texting, kids/pets running around). Illegal activities need to be reported, call the police, 911. Its' a meeting of AA and we owe it to each other to keep each other safe. Inappropriate behavior toward newcomers - sponsors can alert newcomers to potentially vulnerable situation, appropriate dress and language.

What do we do about emergencies? Dial 911.

Two thoughts: inaction equals condoning the behavior. I, you see something and ignore it, then you are OK with what is going on. I might be the only example of the Big Book that anyone ever sees. Talk about this stuff, (don't ignore "the elephant in the room"). What is good for the group comes first, personal welfare follows close behind.

Linda serves on the treatment, special needs and disabilities committee. That will be part of her report back. Money – minimum for conference is to help cover delegate expense. The average Delegate expense was \$5,800.00, so the \$1,200.00 that we contributed barely covered Linda's airfare. Other people can drive there, that is why it's averaged.

Facebook page, and is GSO going to buy stock? Subject will be further explored, will talk at her report back.

This year's conference was such an awesome experience. No controversy, no contention, nothing was made personal. That is not to say there weren't some lively discussions. Some committee recommendation took 2 minutes to cover, others took 2 hours. It was amazing, calm, and the support showed to me by other pacific region delegates and delegates in general blew me away. I'm having a hard time getting around, and I had all the help I wanted.

- I have been using the <u>area17all@area17aa.org</u> mailing list to email everyone on all our mailing lists of new postings to the website, to help with alerting people to new content.
- As a step toward our goal of implementing videoconferencing, I have been thinking about a one way video conference of an Area meeting over a closed private channel and will begin testing some technologies to do this over the next few months.

Linda - concern would be that people might think that it would preclude their attendance. Are GSR's going to think they don't have to show up?

By going to the website for the 6th International Seniors in Sobriety Conference in New York in 2011, I found audio versions of topics include: Alone Again and Staying Connected, a song called It's Never Too Late, Are You Too Old for Counseling and Asking for Help. Another topic called Over Sixty Sober and Retired...Now What? Caught my interest. I would like to share a condensed version of a 65 years' old share on the topic:

Before I retired I had a title. Then I retired and a chapter in my life was over. What to do? Go to AA meetings every day? I did the to-do list that had been around for the last 20 years. Then I went to a nearby VA hospital and was not well received. I decided to try again a few months later and was welcomed with open arms. Since then, I have been a volunteer for eight years. I found my purpose and a new chapter in my life had begun and that was to serve my community and feel better in and outside of AA. Today I am busier than ever and retirement has been very good to me. There is an old American Indian saying: "When you are born you cried and the world rejoiced. Live your life so that when you die the world cries and you rejoice." I look forward to chairing the Seniors meeting at the upcoming Convention on Nov. 2 and possibly a second meeting dedicated to seniors to come to the mike on Nov. 3. Mahalo for the opportunity to be in service.

Proposal to Combine Hospitals and Treatment Standing Committees - Jim D

In the course of this panel, reading last years report back from Linda. GSC changed the language from "Treatment Facilities" to "Treatment setting." It make more sense for us to combine that function here as well. Go to AA.org and get standing committee book, pamphlet, support. There is no longer a Hospitals committee. It's combined with accessibilities, etc. This pulls us back in line with what is happening nationally. It's more prudent. One the down side, I wouldn't be a part of this panel. It cuts our numbers down. Something to think about. I haven't brought all that much to the work of this panel. My understanding is this would be brought to the August assembly. The change would be: "H. Treatment Settings - Coordinates the service work of A.A. groups and individuals who carry the message to alcoholics in hospitals, clinics, treatment facilities and other institutions where alcoholics receive attention from medical and other professionals for their diverse restrictions which may or may not limit their participation in meetings outside of the restrictive setting."

AND THAT Article 3.7 be deleted and subsequent subsections be appropriately re-lettered.

Q/A

Have you discussed this with current treatment chair? Yes.

All this is the combining two committees? Yes. And the job description.

Reiterated what I understand the proposal. page 4 of S and & G under standing committee H. is for hospitals. You'd have to delete K. and instead of saying what is says.. verbatim. So for the DCMs, we'll post on the website. DCMs take to next district meeting to let everyone know this proposal has been made, so you can get input from your groups, and be prepared to vote on at the Budget assembly. We haven't had a lot of things voted on.

T and H both have a budgeted amount. Do you forsee an increase? Hugh and Jim would get together to discuss that. Budget might be reduced by \$100. Proposal is available in last issue of the MB. On page 10. How did Hawaii end up being different from the rest of the world in regard to H and I?

Each group is autonomous so each area is autonomous. We do not necessarily bind our self to the conference or the trustees' committes. Each area does it differently. CA has H and I, but it's almost like a separate entity. They report to the area, but they have sub committees. They have a committee for incarceration, teen facilities, etc. and they have a huge budget. H and I predates Area17, I think.

Jim - Also, FYI I receive mailing of stuff, I.e. Bridging the Gap, because they lump stuff together. Because this will be a change in the guideline should it come in that form at the assembly? Page 8. In writing. It will come forth as a change in the 5 and G.? Yes.

I like this idea, was there some reason why he didn't want to include Bridging the Gap? And what AA can and cannot do? We fought so hard for having a Bridging the Gap committee. It's an important thing to say. Not opposed to the motion, the wording Bridging the Gap important. Friendly suggestion?

Jim - This discussion is the one we should have in August. But, I didn't include that because I felt what we do here is supporting the groups. How each group does what they do is up to them. I think we give too much direction, the directions would come from the groups so I'm leaving it as broad as possible. If this is a friendly amendment, I don't want to.

I disagree slightly. The standing committees generally is outreach for AA. I resisted talking about this, don't' want to be too pushy. Bridging the Gap is so important. I don't think we use it enough in our area. There are forms, guidelines to follow. It's talked about in the treatment workbook, I think it's also in the special need workbook. I think we want to be inclusive and say something like "it includes Bridging the Gap. I think this is the place to iron out the wrinkles. I would agree to propose that you include bridging the Gap. Also prefer that you would take out the word "Facilities" that is the conference committee, doesn't dictate what we do. I can send you the scope. There is a new workbook and I can send you the scope of that committee.

The second line, treatment facilities to "Treatment settings." That's OK, he thinks with Jim. Procedural question. How to get the amended one? Can reword it, bring it to us this afternoon. Run it by us, see what we think? It will be posted on the website also, so people know that it is on the agenda.

Basically we're taking out facility and putting in word setting, and including "Bridging the Gap. Suggested so far.

Suggest treatment setting/bridging the gap.

2:56 Proposal from Finance Committee:

Currently, we had nothing in S and G regarding contributions from bequests. GSO has a limit they accept.

Proposal: The Hawaii Area 17 Assembly recognizes that contributions are made in a spirit of sacrifice, and they honor A.A.'s code of "love and service." In keeping with our Seventh Tradition we will accept personal financial contributions only from members of Alcoholics Anonymous. We will accept a maximum per year contribution from living individuals not to exceed the amount accepted by GSO at the time of the contribution. Bequests in wills are acceptable only from A.A. members, limited to the maximum accepted by GSO at the time of the time of the time of the bequest from any one person, and only on a onetime basis-not in perpetuity."

It's disruptive to the flow of the assembly, and disrespectful to the district to leave the assembly to provide airport transportation f or you early. Treat others as you'd like to be treated.
