Kihei District 11, would like this to serve as a proposal asking that the Area 17 body consider supporting the Kihei District in developing an ad hoc committee to work with the General Service Office and local Tongan translators with the objective of producing Alcoholics Anonymous literature pieces in the Tongan language and having these translations produced in bulk. We recommend starting with the pamphlet "Is AA For You" [P-3] and the excerpt of "How it Works" from Chapter Five of the book Alcoholics Anonymous.

This proposal was brought to us from the group, Kihei Morning Serenity, after a person speaking only Tongan, brought a translator to the Happy Hour group and was disappointed that there was no literature available for him. Once voted upon by Kihei Morning Serenity, our G.S.R.s discussed the matter with their groups and the vote was approved unanimously at our September District Committee Meeting.
