On September 8th, I attended the monthly Oahu Intergroup Meeting, representing Area 17 as a voting member of that body. In addition to explaining the purpose of our Area Service Structure and informing IG about Hawaii Area activities, I encourage IG reps to participate by filling out the Grapevine Survey, volunteering at PRAASA in March, and supporting the Annual Hawaii Convention.

On September 11th and 26th, I attended sessions of the Hawaii Annual Convention Steering Committee Meetings along with our Alternate Chair. In addition, on September 27th, I was able to participate in a special convention meeting at the Hilton Hawaiian Village. What a beautiful site! I truly applaud the hard work and time put in by so many capable people to put on this fabulous event. I hope you all plan to attend. On that note, later today we will be talking about a proposal regarding area's relationship with the convention. I cannot stress enough that the proposal is in no way a comment on the convention itself. We'll hear more about that later. In addition, I have been asked by our Delegate to compile the information from the Grapevine Survey. As of 10/4, I had received 143 surveys. 127 of which were entered into our database and have been sent to the lead compilation team. The deadline for submitting the survey is the end of October. I had the opportunity to attend the Pacific Regional Forum in Torrance California on August 27-29th.

Pacific Regional Forum August 27-29 Torrance, California, Alternate Area Chair Report

Aloha Area 17, Colin, your Alt. Area Chair and here is my report from the Pacific Regional Forum. First of all, I would like to say Thank You to Ken for sending me in his place. The Forum began with a very nice Welcome and Opening remarks from our Class A Trustee, (nonalcoholic) General Service Board, Chairman: Reverend Ward Ewing. I particularly liked this he said, "I firmly believe that together we can ensure that this Fellowship will not only stay together, but will continue to be that beacon of hope for alcoholics yet to come."

We were then introduced to our new Pacific Regional Trustee Rod B. from Area 69 Utah. He came out of the hat at the General Service Conference in April and he is a wonderful example of sobriety and dedication to Alcoholics Anonymous. We were then introduced to our new General Manager, Phyllis H. and she was a prior Pacific Region Trustee. She gave a report of the General Service Office and the employees. There are 82 full-time and 5 part-time paid staff. One Hundred sixty-eight Regional and Special Forums have been held since 1975. The concept is to improve communication within the Fellowship. Members of the board and G.S.O. staff members along with Grapevine editorial staff gave presentations and shared information throughout the weekend. Here are a few notable bits of information.

Alcoholics Anonymous can be found in 180 countries and the book Alcoholics Anonymous is printed in 60 languages. Membership in U.S. and Canada is approximately 1,400,000 with 63,175 groups (including Correctional Facilities). Since the First printing of the book Alcoholics Anonymous through December 31, 2009. In English there has been 30,664,881 books printed (all versions), Spanish (all versions) 879,541 Twelve Steps and Twelve Traditions 14, 727,777 (all versions), Spanish 569,929 (all versions).

-AA has no Dogma, we transmit hope

-Spirituality has no boundaries

Delegate Report: Elizabeth: verbatim: Aloha all, and welcome to our last Area Committee meeting of Panel 59! I am so grateful to be here with you all today after having missed the August Assembly. I appreciate all the love and support Hawaii Area members showed me during my personally difficult summer. Serving as your Delegate continues

to bless me with spiritual growth in ways I'd never imagined, and truly is an honor beyond my wildest dreams. I love AA and those to whom I am directly responsible to beyond words.

Tradition Two / Concept Four:

Today I'd like to speak a little about Tradition Two and Concept Four in light of some recent events within our Area that I have been very concerned about. I have prayed about this, sought guidance from service sponsorship, and finally tried to ignore the feeling in my na'au that it's my responsibility to speak to this. It wouldn't go away, so here I am. I truly believe that Servant Leadership often requires one to take an unpopular stand or bring up the uncomfortable in Alcoholics Anonymous. In Tradition Two, we are reminded that our Ultimate Authority is a Loving God as he may express Himself in our group conscience. In order for us to reach that group conscience, we must have full and thorough discussion in the appropriate arena for that discussion. Then we can all practice our Right of Participation. When a proposal is brought to the Area and it is not allowed to move forward, the groups and members of Hawaii Area 17 Alcoholics Anonymous are then denied their participation and their responsibility to discuss and have a voice in matters affecting AA in our Area. The business of AA is a spiritual business, to which we apply spiritual principles. The majority and the minority will always have their chance to be heard, have a place to be heard – and that is on the floor during open discussion at an Assembly. Remember, God is our Ultimate Authority and our Higher Power is in charge here.

Pacific Regional Forum:

I attended the Pacific Regional Forum over the weekend of August 26-28, 2010 in Torrance, CA. along with our Alternate Chair, Colin. There were 822 members in attendance, and 590 were first time attendees, as was I. It was an amazing experience, and I will try to attend each time I am able in the future. I wish I had the opportunity to go in the past, as it would have enhanced my service to AA and knowledge about the General Service Structure. In 2011 there will be an additional Pacific Regional Forum, August 19-21 in Woodland Hills, CA. In 2012 the regular Pacific Regional Forum will be in Fairbanks, AK September 14-16.

I attended presentations, workshops and presented on Sponsorship. I got to spend time with my service sponsor, our past Regional Trustee, and spend time getting to know our new Pacific Regional Trustee Rod B. I was called on to answer several questions from the floor during the open sharing /ask it basket sessions. I brought some copies of the final report, along with a piece about the Services provided by GSO and AAWS. Please take one and share it with your district. Here are some highlights of the weekend:

Anonymity protects AA from alcoholics

Anonymity is more about preserving Alcoholics Anonymous, less about peoples privacy

The process is more important than the final decision

The fellowship is refreshed by the spirit of rotation

An AAGV subscription is not just a subscription, it is supporting the GV

Current subscription number is 90,000, needs to be 110,000

Prudence is rational concern without worry

The traditions and concepts are living principles

Trust and faith are the primary principles of the concepts

Are the traditions and concepts being passed on through sponsorship?

AA is not a country club for socializing, it is a hospital for the sick

Spirituality is not what I believe, it's not what I think, its what I do

My group will never be more enthusiastic than I am

The AAWS E Tech AD Hoc Committee expects to have an electronic format available in about a year

When we talk about predators in AA, its not about chasing predators out of AA, it's about creating a safe environment for members or potential members

Current AA News:

We have been requested to gather suggestions for the Theme, Presentations and Workshop Topics for the 62nd Annual Meeting of the General Service Conference, April 22 - 28, 2012. I sent out an email in back in August, and so far have received one reply. I will be collecting these until 12/1/2010, and these can be emailed in to me. The theme, presentation and workshop topics for each General Service Conference are discussed by delegates during the week of the Conference. These topics revolve around basic principles of A.A. and can spark thought-provoking discussion at Area and district meetings as well. Regions, areas and districts may incorporate discussion of these topics into workshops, meetings, pre-Conference assemblies, etc. This gives A.A. members involved in service the opportunity to participate and become more informed about A.A.

The Corrections assignment updated the A.A. Guidelines for Corrections Committees with additional language regarding how A.A. members cooperate with the rules of local facilities, and a new section on Pre-release/Bridging the Gap/Temporary contacts. Additional language regarding cooperation with facility regulations and how A.A. committee might prepare members new to this Twelfth Step work will be in the next printing of the Corrections Workbook. The Corrections Desk is also seeking local shared experience about how Corrections Committees resolve perceived conflicts between facility regulations, and what A.A. does not do, particularly regarding facility regulations that involve legally binding paperwork. Please email the Corrections Desk at corrections@aa.org to pass along local experience, so that others may benefit from shared experience.

The trustee's Literature Committee formed the following three subcommittees to address recommendations approved at the 2010 General Service Conference: Subcommittee on the Development of Literature Which Focuses on Spirituality; Subcommittee on the pamphlet "The A.A. Member-Medications and Other Drugs" and a Subcommittee on the pamphlet "A.A. and the Armed Services."

At G.S.O., there are two staff changes: after an internal promotional recruitment for the new position, Director of Staff Services, Doug R. has been appointed this position effective October 1, 2010. Additionally, duties of Staff Coordinator have been carefully reviewed and due to the critical nature of the principal responsibilities, it was determined to retain this position with additional assignment of web services and a title change to Staff Coordinator/Web Services. Rick W. assumed this position on October 1, 2010.

The next AA membership survey will be conducted in 2011.

The A.A. Service Manual, edition 2010-2011, will be mailed out by October 20th.

The Regional directories have been mailed out already. I spoke to one DCM who states that many of their groups were not listed. DCMs: please check your copy, and note any discrepancies and communicate them to our Registrar, Sue.

The first batch of AAGV surveys has been input into the database by my lovely alternate, Linda and has been sent off to the Area that is compiling the surveys for all the Delegate Areas that are participating. So far, 83 surveys we mailed in and 50 were completed online. We have 3 more weeks to collect, and then we will be closing out the survey to enable us to have adequate time to collate and transmit the results.

E-Tech Surveys - today is the last day we can accept these surveys, as they are due to GSO at the end of this week and we still have to compile the results.

During the opening of one of the sessions at the regional Forum, as we said the Serenity Prayer, my soul signed and I experienced one of those moments of complete connectedness and a sense of purpose. Thank you all for this opportunity to be helpful and useful, to be of love and service and to continue my climb out of darkness and despair into love, light and laughter.

Convention Chair: Patti: verbatim: (had to leave; report was given early) Aloha Everyone, Thank you North Shore District for hosting this assembly. As the Steering Committee Chair for our 49th Annual Hawaii Convention, I'm happy to announce that we have exceeded our early registrations of 600 by 144, with our new count of 744 thus far. To date, our food & beverage revenue total \$44,176.00. We needed to sell \$35,000.00 to satisfy the minimum revenue. As a reminder, no meals will be sold on site and payments for meals must be postmarked by October 14th. Our total of room block nights that we had to sell was 427. We have sold 507 room nights. We are going to send HHV a second list of names of our registrants to match HHV's list to see if we have others that signed up as kamaaina's or didn't signed up under 'Bill's Friends' or 'Annual Hawaii Convention'. This will be done just prior to our convention. Our cutoff date for the rooms is October 14th. So, if you haven't made your room reservation, there's still 5 days with the discount rate. The service committees have been filled, however there's still need for everyone to get into service. I am now concentrating on working out a contract with Andrea Hennings-Beavon from Helms Briscoe for next year's convention, which will be held from November 17 – 20, 2011. One suggestion that was made by the convention chair was to look at signing a contract for the next 2 years just so we can have a better selection of dates; which isn't close to Thanksgiving. Convention Proposal – Alt. Delegate Linda reads proposal: PROPOSAL TO AMEND THE AFFILIATION BETWEEN THE AREA 17 COMMITTEE AND THE ANNUAL HAWAII CONVENTION

In the belief that guidance from the Area Committee is no longer considered necessary to the success of the Annual Hawaii State Convention, this proposal is to bring to an end Area's required participation in the Annual Hawaii Convention Steering Committee and to likewise end the required participation by the Steering Committee Chair on the Area 17 Committee. In practicality, the affiliation no longer serves any effective purpose, and the Steering Committee of the Annual State Convention is extremely capable and should be autonomous in all its processes. We further propose that any changes resulting from this action take effect January 1, 2011. Please note that the proposed change does not represent a spiritual separation but rather a practical partition of two separate groups that share the primary goal of carrying the A.A. message to the alcoholic who still suffers (Tradition Five). As stated in Tradition Four, "Each group should be autonomous except in matters affecting other groups or A.A. as a whole...Autonomy means simply that every A.A. group can manage its affairs exactly as it pleases, except when A.A. as a whole is threatened." The amendments to the Hawaii Area 17 Structures and Guidelines that would result from passing the proposal are listed on page 2.

BACKGROUND: 1961 and 1962 were years of AA coming of age in Hawaii. Our first Area Delegate served on Panel 11 from 1961 to 1962, and November 10-11, 1962 the first Annual Hawaii State Convention was held at Hilton Hawaiian Village, chaired by the Area Delegate, whose idea it was to have the conference in the first place. This may have been the beginning of the spirit of cooperation between Area 17 and the Annual State Convention, an association that was formalized in the mid 70's by having the Area Alternate Delegate and the Area Alternate Chair serve on the Convention Steering Committee. During the ensuing years, each of these entities has become separately incorporated as 501 (C) (3) organizations and operates with only a loose association with the other.

FYI: Even though each group is autonomous, our Area Delegate did conduct an informal survey of the other 92 areas around the country and Canada. Of the 20 areas that responded 4 areas have no conventions, 5 areas run their state conventions, 4 states have conventions run by districts that bid to host the convention, 1 state has a statewide service assembly rather than a convention. 1 state has the immediate past delegate serve as convention chair, 1 state has an arrangement similar to ours, and the remaining 4 states who answered the survey have no practical affiliation with their state conventions.

FISCAL IMPLICATIONS:

Hawaii Area 17 Committee Meeting October 09, 2010 ~ Central North Shore District

The fiscal implications of this proposal are minimal and were not factors during the consideration of the proposal. The items listed below are for your information.

Hawaii Area would eliminate from its budget allowance for airfare to send the Alternate Delegate and/or the Alternate Chair to attend the monthly Convention Steering Committee Meetings. Hawaii Area would no longer budget amounts to send the Convention Steering Committee Chair to the Area Committee Meetings and Area Assemblies.

Full proposal with the changes to the Hawaii Area 17 Structures and Guidelines is available on the website.

Discussion: Chappy: Q: *How is the convention chair elected?* A: The Chair (for next year) is selected by the steering committee for the next year, when they are immediate past chair serve on the steering committee, the next year that person becomes the senior advisor, they are always rotating through plus the two members from this body, six total, 5 for a quorum. Q: Chappy: *How would that affect the convention committee if we pulled back 2 Area members of that committee?* Linda: *They would have to reorganize and structure their convention structure, their guidelines so other people can sit on the steering committee.* Chappy: *What was the impetus for the move?* Colin: These are two separate entities, as Patti said earlier, the Convention depends on financial support to continue, Area 17 works within our Traditions, our Primary Purpose supporting the Delegate, Standing Committees. The Convention is not A.A. event, it is for AA's, put on by AA's for AA's, it does not fall in the parameters of General Service, it's a gray area, each area is autonomous, is it time to look at this again? Is the convention really serving AA. This proposal brings the discussion to the floor Chappy: *so this is not a GSO activity, this is an outside entity, it's a violation of traditions then.* Linda: *this is the value of discussion* Sean: *In past history has Area ever given money to the convention?* No. Patti: *when the conventions were held at the hotel the convention was making lots of money, the convention gave Area and Inter Groups lots of money. We gave a big a percentage. At the convention center we lost money, not able to give, we lost money. Steering Committee thought it's about time to move to a hotel.* Sean: *so if this proposal goes through, we would not be able to help them out, we would no longer be affiliated right?* A: *We are not affiliated now, we are not fiscally responsible to the convention.* Coleen: *Events that are put on in Area and want to contribute to Area – donations are accepted because they are AA members, AA does not give money to outside entities, there is no fiscal association right now.* Ermina: *This is an exciting time for the convention, so much more they can do in fundraising, ask for donations, in kind, etc.* Patti: *We cannot do that, we still abide by the Twelve Traditions.* Coleen: *GSO is the same way, they do not accept contributions from outside entities, we accept from AA members, we are self supporting through our own contributions.* Elise: *I already discussed this with our groups, how does the convention feel about this?* Patti: *The convention steering committee likes being a part of Area and feel they keep us in line. I made mistakes, I learn from the, but they are there to guide us. (reads from GSO guideline on conventions page 1 on conferences/conventions and roundups).* Kevin: *Hearing of this for the first time, I haven't heard a compelling reason to take action.* Linda: *We are not here to debate the proposal, we are here to ask questions and discuss.* Nora: *State convention is fun and exciting but my experience is that the conventions are also a service event so it felt a part of area.* Colin: *We are basically watch dogs* Patti: *I don't like that term, no.* Jim: *We have the relationship as outlined in the structure and guidelines. A speaker from Kauai will be at the convention, had the convention requests come through area I would have been more informed about it.* Coleen: *Officers don't sit on any other committees, why do officers sit on this committee.* Linda: *I encourage you to be fully informed, call, email the officers and convention committee.*
