- The proposal to combine treatment and hospitals standing committees was initially defeated. After the minority opinion was heard, a reconsideration was approved and the motion passed 58/25.
- The proposal to define the scope of the archives was passed 78/5. The proposal to combine Area assemblies and committee meetings was tabled till the Orientation assembly.
- Proposals to Amend Structures and Guidelines:

  - <u>Section 2. OFFICERS OF THE AREA ASSEMBLY, 2.10 Treasurer's Duties</u> To add item J. Maintain Area 17's tax-exempt status. Withdrawn
  - <u>Section 2. OFFICERS OF THE AREA ASSEMBLY, 2.10 Treasurer's Duties</u> Change D to read "Deposit all contributions into the Area operating funds account" instead of "Deposit all contributions into an interest-bearing account". Passed 71/2
  - <u>Section 3. AREA ASSEMBLY STANDING COMMITTEES, 3.2</u> Change the wording from "The assembly must confirm all standing committee chairs, except the Convention Steering Chair" to "The assembly must confirm all standing

committee chairs, except the Convention Steering Committee and Corrections Committee chairs". Passed 78/1

   "Coordinates the service work to carry the message of Alcoholics
