## 11:30 Proposal presentations

Corrections bylaws revision to Area17 Structures and Guidelines. 3.1, 3.2, 3.7-E.

Background, in the past (1981) Corrections committee was on Oahu only and did training for going into the prisons/facilities. Stems from the era of all assemblies on Oahu and that back then AA was in-charge of going into the prisons, there has been a shift in responsibility in the last 30 years. S & G are out of date as to how things are actually done.

Formal Proposal:

Rescind and remove Alcoholics Anonymous Hawai'i State Corrections Committee By-Laws from Structures and Guidelines, remove reference to said bylaws from section 3.7-E and remove Corrections Committee Chair from exceptions to appointing and confirming procedure in sections 3.1 and 3.2.

Time will be given for this proposal to be presented and discussed at the Inform the Delegate assembly. Have GSR's take it back to the groups and vote on the proposal at the Budget Assembly.

Draft Proposal: Add an item to the secretary's duties in Structures and Guidelines to "send approved minutes to the GSO Office." Discussion on where to actually send the minutes was had.

This is not a perfect system so GSR's can be gentle with themselves and expectations.

GSR's can mix their experience in with their business reports to increase interest.

GSR's could be given jump drives with the GSR packets so they have all the information right after their first assembly.

Talk to those new GSR's and share our own experience, ask them how they are and answer questions.

Remember that what we are doing here is saving lives. GSR's are in integral part of that.

As an overwhelmed GSR I was inspired by the Mynabird to keep going and trying, by the writing of committee chairs and officers.

I try to make my experiences with area look as great as I can and hope that GSR's will participate.

I have experience now and by participating in caravans, workshops etc. it helps get GSRs motivated.
