
Aloha. I am truly honored to be serving as Panel 65 Delegate for Hawaii Area 17. I am excited about our next two years together and the growth and fellowship that lies ahead. Past experience tells me that we will all become proficient at our new service positions at the end of the panel.

I'd like to start by outlining my duties as described in Area 17's Structure and Guidelines as well as our General Service Manual. The General Service Manual (Ch. 6) states that though the high point is the Conference meeting in New York in late spring, "the delegate's job goes on year-round and involves all aspects of the Conference structure. The delegate should:

- Attend the annual Conference meeting fully prepared. Immediately upon election, every delegate is put on the GSO mailing list to receive Conference materials.
- Communicate the actions of the Conference to area committee members and encourage them to pass on this information, and the delegate's enthusiasm, to groups and to intergroups/central offices.
- Be prepared to attend all area and regional service meetings and assemblies applicable his/her respective area. From these meetings, delegates come to better understand their own areas and can make suggestions for the Conference agenda.
- Help area committees obtain financial support for the area and GSO.
- Provide leadership in solving local problems involving the AA Traditions.
- Remind GSRs to inform groups about the AA Grapevine and Conferenceapproved literature.
- Cooperate with GSO in obtaining information for example, making sure that upto-date information reaches GSO in time for publication in the AA directory and helping carry out the triennial membership surveys.
- Visit groups and districts in the area whenever possible.
- Work closely with committee members and officers, sharing experience throughout the year. Obtain feedback on reports on the Conference.
- Assume added responsibility if the area chair and alternate chair are unable to serve. Or, if an area committee is not functioning effectively, the delegate may take an active role in remedying the situation.
- Keep the alternate delegate fully informed and active so the alternate can replace the delegate in an emergency.

• Late in the second year of the term, work with newly elected delegates to pass along a basic knowledge of Conference proceedings and problems.

When I was a DCM attending PRAASA, I heard someone describe my job then as being a link in the chain. Just as we are all essential links in the chain of General Service. As delegate, I am the liaison between Area 17 and GSO. I pass on information, announcements, and requests from GSO to our Area. The DCMs pass this on to their GSRs who carry the message to the groups and AA members in general. And the information, ideas and requests of AAs and AA groups are passed on by their GSRs at District meetings, carried to Area assemblies and on to GSO. The business of the Conference comes from all of you.

All delegates serve on committees at the Conference. I have been assigned to two committees – International Conventions/Regional Forums and Corrections. I am very much looking forward to the Committee on IC/Regional Forums especially since the 2015 IC will be held July 2 – 5, in Atlanta, Georgia with the theme "80 Years – Happy, Joyous and Free." To date there are two agenda items for the committee:

- 1. Discuss the upcoming 2015 International Convention.
- Discuss ways to encourage interest in Regional Forums and attract first-time attendees.

Hawaii Area has the honor of hosting the Pacific Regional Forum Sept 30 – October 2, 2016 in Waikoloa on the Big Island.
