Hawaii Area 17 2015-2016 Panel 65

Proposals Summary

2015

- We passed the Proposal requesting the General Service Conference consider adding a paragraph extolling the positive experience of participation in general service meetings (including business/group conscious meetings) to Chapter 29 "Going to A.A. Meetings" in subsequent printings of <u>Living Sober</u>.
 - o First vote: 52 Yes, 41 No
 - Vote to reconsider (need simple majority): Yes 74
 - Second vote: 81 Yes, 17 No

2016

- We passed the Corrections proposal: 84 yes, 0 no. This enables the Corrections Committee Chair to be appointed in a manner consistent with other standing committee chairs. Also, the Corrections by-laws that were adopted in 1987 are no longer relevant and were removed from the Structure and Guidelines for Area 17 General Service.
 First vote: 84 Yes, 0 No
- We passed the proposal to send the approved Area 17 minutes to GSO

 Firsts vote: 80 Yes, 1 No
- The motion made on the floor to use \$600 of Area17 contributions to purchase lei for the Pacific Regional Forum was not seconded.
 - No action taken.

Delegate Summary

Aloha kakou and mahalo mucho from the bottom of my heart for placing your trust in me to serve as your delegate for Panel 65. I am deeply touched and truly honored. The panel has absolutely flown by and my life has been enriched beyond measure from the experiences I have had.

Immediately upon being elected in November 2014, I began re-reading the *A.A. Service Manual* and the *Twelve Concepts for World Service* as well as *Alcoholics Anonymous Comes of Age, Dr. Bob and the Good Old-timers* and *Pass It On.* Before I was halfway through, I was once again in awe of our history and fellowship. At the same time, I began receiving enormous quantities of correspondence from G.S.O. and Area Delegates from the U.S. and Canada.

- Attended all committee meetings and assemblies and provided report on GSO activities. Participated in all Pacific Regional delegate conference calls with Regional Trustee.
- Serve as a resource for GSRs, Standing Committee Chairs, DCMs and area A.A. members.

 - Participated in workshop on 'Diversity in AA' and welcomed those attending.

- February
 - Received and reviewed the Final Conference Agenda and background material for the GSC, selected 12 agenda discussion topics to be distributed to our Area SCCs and DCMs at the February Committee meeting. Thanks again this year to our alternate delegate for preparing the flash drives.
- March
 - March 4 6 PRAASA was held in Spokane, WA.
 - Delivered presentation on 'Living Our Spiritual Way of Life in All Our AA Affairs.'
 - Attended two Delegate workshops with Pacific Regional trustee.
- April
 - Inform the Delegate Assembly on April 2 3, hosted by Honolulu District.
 - Presentations and discussions of the 12 agenda topics by the GSRs, SCCs, DCMs and area officers were informative. They prepared me well for my second GSC.
 - 66th Annual General Service Conference was held in Manhattan April 17 23, 2015.
 - Flew direct to New York three days earlier than prior year to acclimate better to 6-hour time difference and jet lag. It worked!
 - We joined many other delegates and their guests for the first "unofficial" event - a boat tour around Manhattan Island on Friday, April 16. On Saturday, many delegates and guests travelled to 'Stepping Stones,' the historic home of Bill and Lois Wilson outside New York.
 - Attended all general sessions, workshop and committee meetings for Corrections and International Conventions/Regional Forums bringing the voice of Hawaii to the General Service Conference.

Treasurer Summary

End of Panel Summary – Treasurer Panel 65

It is with mixed emotions that I see Panel 65 come to a close – sadness that our panel of officers will go on to other things, satisfaction of doing service for Alcoholics Anonymous and anticipation of what might be ahead.

I have really enjoyed working with all of the other officers and committee members who were part of Panel 65. I felt a sense of cooperation and a sense that we all had the best interests of Alcoholics Anonymous in what we were doing and the decisions we were making. The Area purchased a dedicated computer for the Treasurer. This will make passing on the records to the next treasurer seamless. The Area has a debit card which was used for purchasing airline tickets, paying the archive storage fee and printing for assemblies and committee meetings. Past treasurers are an important resource – there are going to be things that come up during the panel that aren't covered when "passing the torch".

I learned a lot this panel. After all isn't this part of what service is about – learn how to do the job, pass the knowledge on to the next in line, and move on to something new. I had never worked with QuickBooks before and am still not an expert. I have however, learned enough to pass on the books to the next treasurer. Again, the resource of experience from people who held the position before me was invaluable.

I was able to attend PRAASA in both Spokane and Layton. I was also able to go to the Pacific Regional Forum last month on the Big Island. Again, the sense of gratitude that I feel for Alcoholics Anonymous when I attend these functions cannot be put in to words.

There are duties that the Treasurer for Area 17 performs that go beyond paying bills, balancing a checkbook and making regular reports. An early task is to form a finance committee – made up the treasurer, alternate chair, and representatives from all the islands. For this panel, in addition to myself and the alternate chair, a DCM from Oahu, a DCM from Hawaii Island and the DCM from Kauai made up the finance committee. The main tasks for the finance committee were to make a budget and then present to proposed budget to each of the districts. There are forms to be filed in relation to our 501c3 status. The Area has an insurance policy that needs to be renewed. The area also has a "Preferred Affiliate" account with Hawaiian Airlines. The treasurer also makes some of the travel arrangements for officers and committee chairs. I will include information about these items – dates, passwords, contact information etc. – to whoever is elected Treasurer for Panel 67

As I write this, I hope to be involved in some capacity for Panel 67. I will be open to whatever comes – be it an officer or committee member or "member willing to share experience and be supportive of our chosen officers and committee chairs".
