I shared Hawaii Area's CEC workbook and it was gratefully received — it was sent to all who attended the the Roundtable. All agreed that it is often difficult to get information about AA to retirement homes because the staff and family members do not want to acknowledge that there is a problem.

2. On Maui, several of us will be meeting to combine efforts of different committees – Public Information, Cooperation with the Professional Community, and Cooperation with the Elder Community. I was off island for the first meeting, but attended the second meeting and will be attending future meetings. I was given the task of preparing an outline for a script for presentation at non-AA meetings. We also discussed putting together materials for health fairs. We want to be prepared for events as they come up. Other Topics: I continue to look for articles in the AA Grapevine, Box 459 and other material related to the elder community and pass them on to committee members. Members have reported to me that literature has been placed where there had been none.
