I have forwarded this information to Area All mailing list. Please see me, your DCM, or an Area Officer if you are interested in applying. Resumes must be submitted by July 7, 2017 if you are interested.

- Non-Trustee Grapevine Director – I've previously sent out information on this position, so this is a reminder that resumes are due by August 1, 2017 if you have an interest in filling this important service position.
