## **Draft Proposal - District 8**

Presented by Sheree. Copies of the draft proposal was provided to area committee members in attendance.

Draft Proposal: "The Mana of the Round Table Group proposes that AAWS design a pamphlet to help AA Members outside of General Service to apply the Twelve Concepts at the Home Group Level."

My name is Sheree, I'm an alcoholic. I am a member of The Mana of the Round Table. The member that I had spoken to, who had worked on this since January of this year had a wonderful idea. As he shared with me this idea. He brought it to Bob's attention and also Tommie's attention and Mark L, District Chair. They kind of brainstormed on it, and talked about it, eat it, digest it, feel it and the result of all of that is it went full forward in going ahead and

making a proposal.I'd like to ask Tommy to give a few words on what happened and where we're at today.

I'm an alcoholic and my name is Tommy. I'd like to thank Kunani for putting this on the agenda. Thank Bob for helping our member out. It's always good if you got an idea "throw it down" and ask somebody you know (like he asked his DCM), me and Bob. It was a two page proposal is one sentence today.

The member believes we can make the twelve concepts illustrated easier for people to understand by breaking down each concept into a few sentences each or a blurb. This could be more attractive for the basic homegroup member, This could encourage members to want to know more about the concepts, and making it easier for members to learn about the concepts; ultimately attract them into general service.

#### Discussion points/questions:

- Objective of proposal is to encourage others to get into service.
- Was the proposal passed by District 8? Or is it just coming from the group? The group passed and brought it to the district and the district passed it unanimously". It was passed because it was a good idea and so we could get it to this committee meeting. This is a draft proposal for us to look at. If we decide to go forth with it; we need to write a formal proposal and hopefully get this onto an assembly agenda if need be.
- Is this just for our area, not the idea to pass to GSO in the future? If we allow it to become a proposal, have the motion put on the floor and passed to our delegate to take it
- Bob this is a demonstration of how exactly motions come to the floor of the general service conference. At some point. Somebody has an idea in this case we have a member from The Mana of the Roundtable who had an idea and he talked to other people. He went to his group and they approved the idea. When he called me on and I worked with him on this it's not my job to say whether this is a good idea or a bad idea. It's my job to help shape the idea so that it can be a legitimate motion. My job was to make sure that this is something that could actually be passed. Any member can submit a proposal. But a proposal carries more weight when it's been through the entire process. Now that (we know) the district has passed they're essentially saying their making a formal proposal to Area that We discuss this. We are not a deliberative body today the area committee. We make no decisions make no decisions whether this a a good idea or a bad idea. One of the reasons we do this is to make sure this is a passable idea. We have our eyes on it to help the district form the draft into a passable one mainly the language of the (draft) proposal.
- Are you asking for a version like the short form of the traditions or something between
  the short form of the traditions and what already exists? We really don't know. He has
  his own idea of what he wants, but having a short form of the concepts; an easier short
  form such as a short blurb using "straight english" or "plain english" or "plainer english"
  version of the concepts.

- Are you asking for a Plain english version of the twelve concepts illustrated, so short and in current english as opposed to the previous. yes
- Regarding addendum B, is that separate or is it part of the proposal? It (Addendum B) is background information only and not part of the proposal.
- Can we get a copy to put up on the website? Yes, the final proposal.
- Would it make sense to present a rewritten version? Is there a rewritten version? Does he have something in mind what he wants it to look like or read like in the simple english version? Yes, he has an idea.
- Regarding the intent. When we read (something like) concept 1: The final responsibility
  and ultimate authority for AA World Services should always reside in the collective
  conscience of our whole fellowship" it doesn't say "Our group conscience; our collective
  conscience -what we all agree on" so the idea is to have something in simpler-plain
  english as well as how does this (concept) apply at the group level.
- Do we have the authority to change the wording of the twelve concepts? We're not changing the wording of the twelve concepts. We're asking for a pamphlet to explain the twelve concepts.
- How much more simpler can you get than the illustrated version? A regular off the street member could understand (the proposed version) a little better at the homegroup level.
   That's what he's trying to get at.
- Is there an objective to this? It is for the regular homegroup members to learn. Inform the homegroup member more and hopefully encourage them to get into service.
- This is a very good Idea of how the concepts fit in at the homegroup level
- Did this person read the twelve concepts before? Has he studied them? The pamphlet is to excite them (homegroup members) to read the concepts. Most people don't study it. This is to get them to study it that is the intention of the pamphlet.
- Change in wording under History: replace resistive with resistant. Resistive is archaic.
- Where is the Letter of approval from the district approving the proposal?
- The consensus of the committee is that this is a good idea. Sheree will report that back to her homegroup.

# **2030 International Convention Bid:** The General Service Office (GSO) is accepting bids for there 2030 International Convention

In case you are wondering how international conventions are decided upon, they are actually bid-on by different areas well well in advance so we can move around 50k to 60k to 70k people.

In 2001 GSO recommended that the bid process for for city site selection be moved forward from 10 to 12 years out from the event. There are a lot of things that we need to meet to put in a bid. Deadline is November 1st. We will get a general sense about whether we will go forth or not.

The minimum Criteria: Covered stadium with a minimum seating of 65k or open seating with proven statistically a minimum possibility of rain for the specified date. The

Hawaii State Convention Center meets the minimum square footage criteria of 600k gross square feet, minimum theater seating of 25k which may include exhibit halls (not sure if we meet the 25k theater seating), at least 12k commutable hotel rooms within a 20 mile radius from the Convention Center.

- We meet the minimum qualifications. The consensus of the group is to submit a bid.
- No financial commitment to the Area.
- This item will be added to the next assembly agenda to be voted on.
- Please let your GSRs know about this vote so they can carry the voice of their group back to vote whether to move forward or not.

## **2018 Inventory Planning Discussion:**

One of the main reasons we wanted to bring everyone together today besides staying connected was to have a conversation, that came up by past area chairs, about putting together the inventory agenda, questions and process.

To help with our conversation I put together past inventory information to help get your input. We want to ask ourselves, what is it that we want to know? What are we looking for? What kinds of questions do you want us to ask on this fact finding journey? Please glance through the handout of questions I compiled from past inventories and give your feedback. This will help us put together the list of inventory questions.

Within the next two weeks we will figure out the twelve questions and get them out to you. We really want these questions to get out to the fellowship any way we can so to start the conversation about what we want feedback on at the inventory assembly. Give some time for the questions to be posed to the fellowship so when we get together in January, and we break out into our groups, all who are participating will be able to give responses that we hopefully got from the fellowship, our own personal experiences and reflections on our service at the Area level.

## Some discussion points:

- Comment: As a general rule for all of us sitting around today and when we have an assembly with the GSRs that are representing their groups; those (our) groups are probably well informed. But what about the groups that think all we do is sit around and chat or play (this weekend)? Those are the groups we need to somehow reach; people who don't know nor care about AA as a whole.Let's somehow find a question that address these issues and reaches the groups that don't participate.A list of things for us as members suggested we do before holding our area inventory.
- Suggestion: "What about the groups that we aren't really reaching or have a perception
  of what happens here (Area business meetings) and how do we possibly change that?"
- Question: There are Districts here today that have groups they want to be autonomous.
   They don't want to be involved in Area. They don't want to be informed. A DCM attending

a meeting in their district is made to feel like an outsider because group members think they are there for business reasons rather than wanting to attend an AA meeting. Groups maintain their distance and seem to have a wall up against Area. How do we reach them?

- Question: Are there communities in Hawaii that the AA message is not reaching them? Socially there are races of people that the message is not getting to them.
- Question: Are we doing an inventory of ourselves or is our group doing an inventory on us? We would like to get the twelve questions out to you so the GSRs can have these questions. Not necessarily do our inventory at your group conscience but to start a conversation on the questions so that on January 27th we are not passing out asking the body to answer the best you can. We can conversation with people prior. My hope is that people would bring back to the table that day.
- Question: Is there a way we could get the inventory questions surveyed on the Area website such as Survey Monkey? Area Chair will look into the pros and cons of surveying the questions on the Area website.
- Comment & suggestion: Most of these questions are specific to area service not the homegroup. Maybe we could ask the groups for questions we should ask ourselves?
- Suggestion: Maybe we can get into small groups to put gather questions? You could
  dedicate as much time in your round tables to selecting or developing inventory
  questions.
- Are we truly being of service and what do we need to do to make up the shortfall?
- Questions will be posted on the Area website.

## <u>Structures and Guidelines - Is it time to review?:</u>

At the last assembly after reading the structures and guidelines as it states "the minority opinion will always be heard". Half the room looked like they wanted to throw stones at me and the other half nodded their heads following along.

In 1998, at the inventory assembly, the body voted to take out the words "that it would only be heard once". We changed the structures and guidelines. So I must follow the structures and guidelines whether I like it or not.

- Question is it time to review our structures and guidelines?
- Comment: It's always good to review the structures and guidelines as needed.
- Question: did we say we would review the alternate delegate and alternate chairs job responsibilities in the structures and guidelines at the last gathering?
- Do we want to review the entire structures and guidelines or specific items? We would need a motion to move forward in any direction.
- Comment: The structures and guidelines is a "voting document". [Scott C. Past Delegate]
- Comment: Because the document is a voting document by the past body. A review of it would be checking grammar and looking at syntax (the arrangement


## Aloha Everyone:
