activities can keep us very busy. It is not always easy to set aside time to focus on agenda items or what we'd like A.A. World Service and A.A. Grapevine to do for us. The work we do helps us figure out what we'd like to have available for alcoholics around the world. Each person's contribution of time is no small gift. Showing up is part of what keeps A.A. around for us and for those who are new or returning to A.A.

Hawaii Area 17 also contributes to A.A. as a whole through individual and group contributions. GSO let us know that 29.43% of Area 17 registered groups have contributed a total of \$9,854.82 (as of March 31, 2019). Our contributions help us have access to all that A.A. publishes. It is all there for us, whether we are meeting with a sponsor or sponsee, gathering and our groups and events, or carrying the message to institutions and treatment options where we meet up with alcoholics who either cannot or have not yet joined us.

Our contributions help us to share the A.A. message around the world. In his February 2019 letter to A.A. members, our General Manager Greg T. wrote, "Today an A.A. presence can be found in more than 181 nations worldwide, with a membership estimated at over two million. There are more that 120,000 A.A. groups around the world and A.A.'s literature has been translated into languages as diverse as Afrikaans, Arabic, Hindi, Nepali, Persian, Swahili, and Vietnamese, among many others."

Of course, we could not hold an annual General Service Conference without financial and spiritual contributions of A.A. members, groups, districts and areas. Who hasn't heard that the hat is where money and spirituality mix? It's one thing to have the financial means to get the work done. It is equally important to have a say in what gets done. Our Inform the Delegate Assembly gives us a place to voice our experience and meet that responsibility. It is not the only way to give back to A.A. It's not the only thing we need to do. I see general service is a way to be the link between the last panel and the next. If we make the effort, I believe we will be around for all the people who just might need Alcoholics Anonymous.

I would like to give you some brief history on this opportunity within the UH system. Within the CPC workbook there are some templated letters that are recommended when we try to engage with different organizations within the professional community. One of the letters was sent to an administrator within the UH school system, who informed me they were very interested in cooperating with AA. A big reason is because they are federally mandated through Title IV program called Every Student Succeeds Act (ESSA) started in 2015 and specifically part A of that act called Student Support and Academic Enrichment (SSAE) which is supposed to (1) provide all students with access to a well-rounded education (2) improve school conditions for student learning. All of that is to basically say they want students and staff to know about the resources that AA has to offer and have opened their doors for us to participate or not.

- District 4 has already begun this process with Windward Community College by starting a meeting and getting an information rack on campus. I would like to thank Janin and her home group Misfits for stepping up and making this happen. This is a perfect example of one member having a passion for something and through the guidance of her sponsor, support from her district, her home group, and the fellowship at large was able to make something happen out of nothing.
- There was also some discussion that UH Hilo might have a meeting on campus but still need to confirm this.
- District 6 Kauai has initiated contact with Kauai Community College and received permission to place an information rack on campus and to start a meeting. We are still

And finally I've also reached out to the judiciary and will hopefully have an in-service scheduled next month to talk about what AA is and what AA isn't.

I did receive one inquiry from GSO for someone on Oahu who wanted more information on CPC but did not leave a phone number or address so I mailed out a response and am waiting to hear back so I can follow up with this individual.

Received another inquiry from one of our members on Maui interested in taking a meeting into the psychiatric ward at the hospital and was able to connect him to a person with knowledge of the meeting in Kaneohe at the state hospital and what it takes to get one started.

In closing would like to say it's been an honor to be in service these past few months as your CPC chair and realize more than ever the power of service and more importantly being here with all of you and your servant hearts.

***What the Public Information Standing Committee did to carry the message of Alcoholics Anonymous:***

First of all, I apologize for not being present and thank want to Thank Tommy and Cheryl for standing in for me.

My report is a follow-up on the goal of getting cards on the buses in Hawaii informing the public of who we are, what we do, and how to find us since our last committee meeting:

- Received the letter of 501 3c from Area Treasurer (Rachel) via email (thank you Rachel)
- Was able to make contact with the vender who works with the Honolulu City Bus and was given specifics on (3) things that he needs to present to the county i.e copy of the 501 3c, number of buses & the length of time to run the ad, and the verbiage of what we want the card to say on a 11" by 28" card in digital form and this vender does this part at no cost on a case by case basis depending on what we put on the card. First month is free, thereafter the cost is \$1.75 to install a card and \$14.75 per month.
- Was able to obtain more examples from the Public Information Person at GSO (Racy). So the card will read as this "IF YOU HAVE PROBLEMS WITH DRINKING, ALCOHOLICS ANONYMOUS CAN HELP, CALL \_\_\_\_\_(INSERTED WILL BE OAHU INTERGROUP NUMBER)
- I was informed by the OAHU Intergroup Office Manager (Adina) that (2) homegroups is wanting to pick up to more bus routes. Once I get everything in line and hear back from the City and County of Honolulu, then I will follow up with OIG with information regarding adding (2) more buses.
- I was informed by Mare (Maui) that Maui buses is not doing any advertisements on their buses at this time.
- I had no response from the island of Hawaii.
- Brian K, has been working with District 6 is enthusiastic about getting involved in this process for their district, thank you District 6.
- For the island of Oahu, I was able to meet with (2) standing committee chairs to go over the topics the upcoming conference.
