

DELEGATE REPORT Hawai`i Area 17, Panel 69

Committee Meeting November 16, 2019

Aloha A.A. friends and trusted servants,

At the top of Hawai`i's service triangle are more than 5,000 members that I call my bosses. Being a part of AA's service structure is heartwarming and inspiring. Our work includes the agenda items we discuss with A.A. members and talked about at our Inform the Delegate Assembly, recommendations made by voting members at the General Service Conference and actions taken by our friends at the General Service Office and A.A. Grapevine Inc. This year long process has always been in plain sight, and my understanding of this process improves with each service position held. Serving as delegate has given me a new appreciation for the way we attempt to ensure each A.A. member has a voice, and A.A. has a presence in the world.

The connection to the General Service Office trusted servants is equally moving. Through conference calls, the email system, and the General Service Conference Dashboard, the bottom of the service triangle also keeps me informed and connected.

Kathi, Our Pacific Region Trustee, has schedule a conference call Monday November 18th with Pacific Region Delegates. She'll go over her last meeting in Rye, NY and give delegates opportunity to ask questions and share our input with her and with each other. You will soon receive the full report from AAWS, AAGV and Trustee's Committees. Until then, here are a few highlights to pass on:

- <u>Accessibilities/Loner International</u> -The Big Book is available in American Sign Language. <u>The Twelve Steps</u> <u>and Twelve Traditions</u> will be available soon.
- <u>Communication Department</u>- In addition to continuing the current communications department work, a new department has been implemented to also help address the facets of needed change in how we communicate inside AA, to the outside world and our public relations policy.
- <u>Corrections</u> received more than 400 letters per month for correspondence or literature. AAGV/LV Carry the Message project helps get AAGV/LV into the hands of these members.
- <u>International Convention</u>- Has processed over 21,000 registrations. Hotel rooms are available and shuttles will be provided for participants.
- ERP (Enterprise Resource Planning) has been implemented. The Records Department is processing Service Kits, GSR and DCM Kits.

- <u>Publication-</u> 3 audio books in English, Spanish and French will be released in streamable and downloadable formats in early 2020. They include <u>Alcoholics</u> <u>Anonymous</u>, <u>The Twelve Steps and Twelve Traditions</u>, and <u>Living Sober</u>.
- <u>Finance-</u> Contributions have been 6.29% higher than this time last year. Book and booklet sales are below the budgeted estimate. Operating expenses were 4.53% greater than budgeted.
- <u>AAGV/LV-</u> American Prison System gave approval so that digital material can get into prisons. Check out AAGV YouTube Channel, and audio stories submitted by members. AAGV/LV free shipping through 12/31/19.


