Question #1: Consider requests to develop a book on AA history from 1955 through the present.

Background: The book AA Comes of Age documented the history of AA from the start to 1955.

This topic for consideration is should we contemplate continuing documenting our history from 1955 to present day.

15 Total Responses: 12 Support 3 Take No Action

Comments:

"Wasn't even aware that our recorded history ended in 1955! Glad this topic was brought up."

"After much talk we came up with "Yes" (Thumbs up) We saw that new members and the most important discussion was that history needed to be written about Younger people in AA's history needed to be brought to its attention. It also was said in our group -before it was lost. How did AA's under 30 get their groups going and where is it the strongest."

"Also, where do loner's who can't make meetings because of age or location, develop that part of AA's history ... not much of that is discussed in "AA Comes of Age"

"Overall, the group wasn't prepared to say a blanket yes without having information about the cost of this endeavor, especially in light of the Covid-19 Pandemic. The Group appreciates the idea in theory. A member recognized that there is information in the Archives. A great suggestion was made and appreciated by all to pursue the possibility of completing this book and releasing a digital version to mitigate costs and preserve our AA history. Taking into account the basic question which is simply, should this be looked into, as trusted Servant, I am also interested in preserving AA's history by completing a book that brings AA into the present day in an accessible way and looking into releasing a digital copy until a future publication estimate can be obtained."

"Excellent idea"

"yes however we considered it a B priority. We should focus on electronic issues such as social media and digital infrastructure"

"Need to continue to authoritatively continue recording our AA history"

"We feel that archives and present literature is sufficient to inform the fellowship."

"Our group saw a need with younger people coming in and the need for information needed or collected since AA Comes of age."

"Don't want to lose the history"

Question #2: Review the pamphlet "Self-Support: Where Money and Spirituality Mix"

Comments:

"The Group feels that the request is understandable, but that the current suggested splits apply to most areas. Since every Group is autonomous, Groups can decide on their own how to allocate splits."

"It's just a suggestion and a good one at that."

"Do not think revision of pamphlet would help beginning treasurers, and experienced treasurers know to make their own divisions. Message is pass along money to District, Intergroup, Area and GSO, not control divisions"

"They thought they should have the right to see where their 7th tradition should go. The need might be greater in the district or the area and they wanted to make that decision"

"Each group should feel free to decide how to distribute their 7th tradition"

There were 3 parts to this topic – further comments related to each of these subparts are listed below.

A. Consider a request to revise the pie chart percentages

Comment:

B. Consider a request regarding contribution percentages to service entities

[&]quot;...it's up to the group to decide on how that is to be distributed..."

Background: There are 3 pie charts in the current pamphlet. Remove the 2 charts that indicate the percentages from #2 above – leaving only the chart without actual numbers and add the following language:

"Duties of the entities noted above are described on page 7 of this pamphlet. Performance of these service duties vary from area to area. Please be sure to inquire which services these entities provide in YOUR area and contribute accordingly."

Comment:

- "...on view of the expense of the district, area and intergroup and what was available for committee work we all agreed to change the wording back to what it was..."
- C. Consider draft language related to the "virtual basket"

Background: The CoVid pandemic provided sufficient background without saying anything further. Add the following language:

"Q. Some members of our group wanted to pass a "virtual" basket – to collect Seventh Tradition contributions digitally. How could we do this?

A. A number of groups have utilized digital payment platforms as an adjunct to passing the basket in the conventional sense in order to provide opportunities for cashless contributions. There are different payment platforms to facilitate this service and it is up to the group to determine which one to use. Some groups have found that a smartphone app-based payment platform is the most efficient, seamless and minimally disruptive solution for providing a digital contribution. Experience suggests that the treasurer is a likely choice to handle digital contributions, though some groups add more than one trusted servant to share the responsibilities or create a new service position to inform the group about digital payment options and assist other group members who are interested in contributing this way."

Comment:

"My group supported the virtual basket part of the finance issues but they voted to take no action on the pamphlet... the group does want GSO to look into the virtual basket issue."

"VIRTUAL BASKET is a good idea, since it saves on stamps, and letters." Written pre-CoVid.

CPC Inform the Delegate Report

Panel 69 Area 17

- A. Consider a request to discontinue the pamphlet "AA in Your Community" (pgs.99-117)
 - 1. The group "Sobriety Society" in area 64 Tennessee made the proposal with the primary premise being the information is already present in two other pamphlets "Information on Alcoholics Anonymous" and "AA at a Glance". This pamphlet has been a topic of discussion since the 1980's where it was discontinued and then reinstated in 1981. The group points to low sales as another reason why it should be discontinued. They also pointed to some grammatical errors in this pamphlet. There was a letter from Lois F., secretary, dated 1/15/1981 that stressed the importance of the title of the pamphlet as her reason for supporting the pamphlet remain in circulation. She stated "My experience is that "AA in Your Community" is needed. It is true that other pamphlets contain similar information. However, I believe that pamphlet titles are important since they, too, make a statement." Regarding this question there were 5 in support of "considering" this proposal, 3 who voted to take no action and one that abstained. Based on some of the comments it seemed to be redundant information and therefore were in support "considering" this proposal.
- B. Consider a request to create a pamphlet for mental health professionals (pg. 118-128).
 - 1. This proposal was submitted by the Area 11 Connecticut CPC committee. Although they agreed that most mental health professionals were aware of AA there remains a lot of misunderstanding and misconceptions about what AA is and what it is not. Some of the points they thought should be included in this pamphlet are as follows; 1) AA is not the same as psychotherapy. 2) AA is a spiritual program not religious. 3) Inform them that prescribed medication does not interfere with the principles of the program. 4) AA does not offer financial help to those in need nor does it provide housing or social services. 5) AA requires no payment for participation. 6) Reinforce the only requirement for membership is the desire to stop drinking regardless of any other outside issues. 7) AA is not affiliated with any other 12 step programs. 8) Describe the disease/craving/obsession concept of alcoholism. 9) make them aware of the AA website and smartphone app. 10) Let them know alcoholism impacts people from all walks of life. 11) Explain the anonymity of the program. 12) Suggest they attend an open meeting. 13) Suggest they make contact with the CPC committee in their community. 14) Let them know the long history of mental health issues within the fellowship and the likelihood of coming across a potential alcoholic within their day to day work. The group was unanimous in their response to "consider" this proposal. Some additional comments were:
 - 1) "A pamphlet for health professionals is outdated. If health professionals were researching AA they would use an electronic data base such as "Up to Date".
 - 2) "direct insinuation of a positive view of AA into the places where mental health and all physicians look for info, that is on their smart phone, the app "UpToDate" and the attachment of the UpToDate info to the electronic medical records now in

universal use would be a meaningful advance. The newly trained doctors would be helpful in this."

Cooperation with the Elder Community

Topic: Review progress report regarding the pamphlet "AA for the Older Alcoholic - Never too Late"

Background: In January 2019, the Conference Treatment and Accessibilities Committee advised that the pamphlet be updated with a revised introduction, current and inclusive stories, reference to online AA and an updated "How Do I Find AA section."

A subcommittee worked on the revision and reported back. In August, the committee then requested for additional sharing and requested a call out for stories. 44 stories were submitted with equal participation of male and female A.A. members, as well as broad regional representation.

Hawaii has been active in participation with suggestions and stories for the pamphlet. Several seniors were interviewed and four stories were sent from newly sober over 60 years of age AA members.

After reviewing the background information and several discussions, our Cooperation with the Elder Community committee agree that the pamphlet should go forward. We know that this population is vulnerable, growing quickly in number, and in need of support.

We request that the pamphlet be printed in the regular "large print" however, NOT the Huge font used in the existing pamphlet, making it bulky and heavy. We feel that it is an insult, that we are seniors, not visually impaired. We developed our own pamphlet because we felt so strongly opposed to the current one.

One member comments, "The older alcoholic is changing- so should the pamphlet."

Topic: Review progress report regarding the development of the pamphlet for Spanish-speaking women in A.A.

Background: In February 2019, the Trustee's Literature Committee agreed and forwarded to the 2020 Conference Committee a progress report regarding creating a pamphlet for Spanish-speaking women in A.A. In July, the chair requested feedback from Spanish speaking women members from throughout the United States and Canada to support the idea. Conference calls, round tables and workshops have contributed many possible titles and material for such a pamphlet.

Our group feels strongly to support the idea of a pamphlet for Spanish -speaking women in A.A. Although we do not have a large Spanish -speaking population in Hawaii, we have attended PRAASA's that speak to the need.

Topic: Consider requests to revise the book <u>Twelve Steps and Twelve Traditions.</u>

Background: suggested to remove the phrase "opposite sex" from p. 117.

Also to reconsider the use of the phrase "lustful enough to rape" on p. 66.

There were concerns that "if we start changing language, where will we stop? However, those in favor commented that those phrases were not inclusive and offensive.

Our group felt strongly that the word "lustful" should be removed ("No one wants to be angry enough to murder,lustful enough to rape"...) We now know that lust does not cause rape and that it was not known in Bill W's time. It is offensive at least and certainly incorrect and misleading. Omitting it will not change the gyst of the paragraph.

Half of the committee agreed that removing "opposite sex" from the sentence was appropriate, that this terminology was outdated and wrong and what does the gender of our partners have to do with the success of A.A? It is important to not have language that would cause someone to reject the program.

"But replace it with what?" was asked by several members of the committee.

The other half of the committee said that it was a waste of money to change the book, one line at a time. People recognize when the book was written, the gender question was not charged as it is now. Others said a whole new 12 and 12 revision might be appropriate in the future to improve many of the archaic terms.

Corrections Panel Report May 2020 for Inform the Delegate Topics

Q1. F. Consider a request to develop an A.A. Grapevine pamphlet on how the AA grapevine can be utilized to carry the A.A. message.

For: 10 / No Action: 3 /Abstain: 1

Comments:

For: In favor but keep it simple please, it would help to enhance the mission of the Grapevine and put all the information about it in one place.

Against: The Grapevine does job well without pamphlet to assist, It's redundant and not the best way to raise awareness of the Grapevine.

Q2: T. Consider revising the pamphlet "Questions & Answers on Sponsorship"

- 1. Change the suggestion that sponsor and newcomer be of the same sex.
- 2. Expand the section on "Service Sponsorship" and retitle the pamphlet to include service sponsorship.

For: 8 / No Action: 5 / Abstain: 1

Comments:

For: These should be two separate topics for survey, current language does not accurately represent today's diversity of membership, but some felt more specific wording needs to be provided. Service sponsors are important, including in title good idea, another was in favor but there needs to be separate pamphlet for service sponsorship.

Against: Same sex sponsor is most appropriate, not appropriate for newcomer to address these issues, topic draws conflict & controversy. There is adequate information on both topics, no change is needed.

Q3: U. Consider request to include a G.S.R. preamble in the pamphlet "G.S.R.: Your Group's Link to A.A. as a Whole."

For: 9 / No Action: 3 /Abstain: 2

Comments:

For: Further explaining the role of GSRs good idea and would be a positive addition, another in favor but we need two different pamphlets not just preamble, many of us never read GSR preamble.

Against: no comments, an abstaining group commented that preamble is not broken.

Panel V. Grapevine Inform the Delegate Summary Report, Julie G.

Question 1). Review progress report on actions taken from the findings of the AA Grapevine and La Vina Fellowship Feedback Survey.

Background:

Fall 2018, 4500 15 minute surveys were completed by readers and potential readers of GV and LV to measure attitudes toward existing, current/intended usage, and future preferences. Summary of findings from the feedback survey are listed below.

- 1. Opportunities to improve perceptions and relevance of GV/LV as important personal recovery tools, via outreach coordinator, improved communication with GV chairs, workshops, expanded AV content on YouTube channel, increase call for tradition and step stories
- 2. Clarify funding of GV & LV may increase revenues, via educating that GV is self-supporting and new GV/LV product catalog
- 3. Improve content to reach younger members and be more relevant to those with long-term sobriety, via more digital delivery platforms, website rebuild, young people stories in every issue and young and sober stories all the time, GV Staff attend ICYPAA, and increase content on YouTube
- 4. Desire for simpler subscription model and less interest in stand-alone digital subscription

Feedback from Area 17

All responses (10 GV committee members & 5 other people in general service who completed the survey) were neutral or in favor of the GV changes. AA's like picking articles from GV's online search by topic for their meeting. AA's feel supported and like that the GV is offering all their services for free as part of the We-Are-Here-To-Help response to the pandemic, providing free online access to all written and audio GV/LV articles and YouTube videos. Some AA's select topics from GV to discuss during walking AA meetings, and others, who are uncomfortable with Zoom, listen to GV audio stories with headphones while taking walks. AA's like the changes which are making GV/LV more current and accessible for young people.

Question 2). Consider revising the AA Preamble to use gender neutral pronouns. For example, "Alcoholics Anonymous is a fellowship of people who share their experience, strength, and hope with each other..."

Question 3). Consider a request to change the language of the first sentence of the AA Preamble as follows: "Alcoholics Anonymous is a fellowship of people who share..."

Background:

The AA Preamble was written in June 1947, and introduced in the GV soon after the GV began circulating to non-alcoholics, to describe what AA is and is not, and to be used for public information purposes, later it was added to many conference approved publications, and now is often used to open meetings. It was revised in 1958, when the word "honest" was removed from the phrase, "the only requirement for membership is an honest desire to stop drinking."

An advisory action from 1992 references an advisory action from 1986 pertaining to sexist language in the Big Book and other Bill W writings addressed the issue. 1) "as

the preface of the Big Book clearly states that the text was written in 1939 and that it hasn't been changed, no further explanation regarding out-of-date phrases and/or gender-oriented pronouns or chapter titles is necessary." 2) "AAWS editorial staff continue to degenderize AA literature, with the exception of Bill W.'s writings, as the items are reprinted, i.e. Staffing the booth rather than manning the booth, etc.

There were 6 requests to AA GV in 2018 & 2019 to revise the AA Preamble, which were made into 2 different agenda items. 4 of the requests were from GSRs and 2 from Area Delegates, and none of the 6 had the support of substantial unanimity from their areas. All 6 people were concerned that the current preamble stating "...fellowship of men and women..." Isn't inclusive, especially for those transgendered persons who do not identity as either male or female, and for AA's as young as 12 who hardly consider themselves men and women, but simply alcoholic. 5 of the 6 requested using the term "people" rather than "men and women" since it sounded more welcoming to all persons.

Feedback from Area 17 (since all people responded the same to both questions 2 and 3, they were grouped together)

No Action (7 GV and 2 others): We all come to AA and we all feel we don't fit in, which is why most of us drank. Our goal in AA is to be inclusive and make everyone feel welcome. The way we convey this message during the meeting is more important than the language in the Preamble. We have learned in AA to identify with each other even though we are all very different. As women, we have been subjected to sexism and know much of the AA literature is sexist. However, we are going down a slippery slope if we start changing the language as we may start changing the message of recovery. Many groups don't support making any changes since they like it the way it is, and it has worked for them. Some people wondered if anyone had asked someone who doesn't identify as either male or female how they feel about changing the Preamble, if they thought it would make a big difference to them, and if they would want it changed to something else, like "alcoholics" rather than "people."

Support (3 GV and 3 others): In the survey, one GV GSR referenced how AAWS is trying to degenderize AA literature, except for the Big Book and Bill W's writings. The Preamble was written by the GV staff and not by Bill W., and it is not included in the Big Book. One group had 5 in favor and 4 opposed to making a change, so there wasn't substantial unanimity. No one who supported the change came to the GV committee Zoom meeting 4/30.

We were Panel VI Mynah Bird and we had 3 agenda item topics to consider. GSR's did a great job, as we had 13 groups from across the state that gave feedback.

Topic 1: Consider request to add subtitle to the booklet "Living Sober."

A group in California suggest that the title of "Living Sober" be amended to read: "Living Sober. How not to take the first drink."

(2) Support

- 1.-To be consistent with table contents. Chapter's suggesting of "How not to take the first drink."
- 2.-Group voted to support

(7) Take no action

- 1.-Keep it simple. Staying away from the first drink is the second article in the booklet.
- 2.-motion did not pass
- 3.-We are voting to not change it-trival and the book is fine with the title as is
- 4.-group stated leave it alone.
- 5.-We think that the current title is inclusive of all the topics within the booklet, including how not to take the first drink. 6.-No change is needed.
- 7.-Book is fine as it is and very popular
- 8.-no comment
- 9.-no comment
- 10.-no comment
- 11.-no comment

Summary: It is the consensus of the participating groups to "Take no action." We believe that it is already outlined in the booklet and mentioned multiple times of how not to take the first drink. Members did not want to change something that was working.

Topic 2: Consider request to revise text related to open meeting in the pamphlet "The A.A. Group."

Last year *ITEM N:* Consider suggestion to add "Non-alcoholics may attend open meetings as observers" to the end of the open meeting side of the Primary Purpose (blue) card. This item failed. However, in "The A.A. Group" pamphlet on page 13 it reads: *Open meetings* are available to anyone interested in Alcoholics Anonymous' program of recovery from alcoholism. Non-alcoholics may attend open meetings as observers.

The request is to have consistency in our literature and would like it to read: *Open meetings* are available to anyone interested in Alcoholics Anonymous' program of recovery from alcoholism.

(6) Take no action

- 1.-In the A.A. group pamphlet it is basically describing the difference between an open and closed meeting. I believe it's important to inform those who may want to know the difference between an open and closed meeting.
- 2.-Some of us didn't even recognize that we were alcoholic until we had attended a few meetings (as observers.)
- 3.-Tradition four: Each group should be autonomous except in matters affecting other groups or AA as a whole. The group conscience can decide whether to use or omit that language.

(5) Support

- 1.-Our home group is in favor of exploring

- 4.-No comment but in support of.
- 5.-No comment but in support of.

Summary: The general consensus of the group is to "Take no action." No changes are necessary. The groups can decide for themselves. The importance of knowing the difference between open and closed meetings.

Topic 3: Consider request to revise text related to self-support in the pamphlet "Frequently Asked Questions About A.A."

This paragraph was referenced in the background notes: "What does membership in AA cost?" we have a problem with the answer which state that most local groups "pass the hat" at meeting to defray the cost of renting a meeting place and other meeting expenses, including coffee, sandwiches, cakes or whatever else may be served.

(7) Support

- 1.-I support request of revise text related to self-support in the pamphlet "Frequently Asked Questions About A.A." I believe we should state that 7th tradition pays for rent, coffee, literature and for contribution to Area, Intergroup and GSO. Nothing more and nothing less.
- 2.-We agree that AA is not a catering service, and that that language does not reflect AA's primary purpose, to carry the message to the alcoholic who still suffers.
- 3.-Group voted in favor
- 4.-Pass the hat should be removed, that's why each group pass the basket etc. for the 7th tradition. To be used for meeting expenses, including coffee, sandwiches or other expenses that the group might have.
- 5.-It's simpler and more supportive of Tradition 4, to allow the group to define what their 7th tradition supports and how specific they wish to be. In our area, the days of sandwiches are long gone.
- 6.-This piece of literature needs updating.
- 7.-Support but no comment.

(3) Abstain

- 1.-our group feels the text is transparent of what money may be used for.
- 2.-need more info.
- 3.-Abstain with no comment

(3) Take no action

- 1.-We recently added this to our reading material before the meeting so we vote no.
- 2.-No comment
- 3.-No comment

Summary: The consensus here was in support of. However, during our zoom committee meeting it was mentioned that there, were other verbage that needed to be addressed and so it was decided to abstain.

Public Information Chair: Deborah L.

Having repeatedly going over these topics, my focus shifted to Tradition 5, as a group the only primary purpose is to carry it's message to the alcoholic who still suffers. In short my understanding of the topics for Public Information is 1) convert three selected pamphlets to video shorts that would be readily available through technology for the alcoholic, 2) create an A.A. podcast available through the internet and/or app that would cover all aspects of sobriety that include topics such as "Experience with Steps/Traditions/Concepts," "The Service Manual," "Experience, Strength, Hope from current and past trustees and delegates," "Our different pieces of literature," and "The Grapevine and La Vina." In yesterday and today's world we are conditioned to engage ourselves in technology, it has evolved to being the "go to" solution via phone/computer for instant answers, solutions, education for almost everything and anything, this would allow more opportunity to reach out to persons that have a problem with drinking vice versa for those seeking help, and 3) Update the pamphlet "A.A. and the Black African-American Alcoholic" and my perception on this topic is like going through the process of developing a 5thEdition book of Alcoholics Anonymous, and it is asking to update the personal stories of experience, strength and hope that just may just help that alcoholic.

I found the list of contact for GSR's on this committee helpful in a way that, I was able to discover who is still a GSR and who is not, whether or not the phone number is active or inactive, if so, I was able to leave a message and wait for a response or not (in most cases no response). I appreciate the few that answered my call. I was able to actually talk to two GSR's on this committee including an alternate GSR whom actually reached out and contacted me (he was not on that list). In addition to, I had shared these topics with other members of the fellowship and was able to get their feel or feedback, however they are not voting members, so I took Concept III, Right of Decision on their behalf. Other difficulties I gathered from the GSR's were not having access to a computer, more focused on the struggles with adjusting and adapting to the limitations set because of this COVID-19, not clear as to what was being asked on the survey and the readings were lengthy and difficult to understand. Most effective for me was being able to talk to someone one to one via phone.

Here is a roundabout consensus for the topics for the topics laid out for Public information through the survey and through members of the fellowship of Area 17 that I have personally spoken to. For the members of A.A. I have spoken to, I will provide a comment on the majority of their opinion in favor of or not.

Item G: Review a draft plan to create video shorts based on A.A. pamphlets.

Survey: (4) Yes, comment: more visual the better (1) take no action, and (1) abstain, comment: w/ the Covid 19 there was no Group Conscience and did not understand, did not want to make a comment because it was unclear.

Members of A.A.: The majority of individuals that I spoke with where in support of reviewing for reasons being that with technology, why not, it would be easily available and some people need visuals rather than reading the literature, on the Members AA: Yes, move forward, however one individual did mention, these video shorts will cost money to create.

Item J. Consider a request to develop a plan to create an A.A. podcast.

Survey: (5) Yes, comment: modern way to get information out there, great educational platform. and (1) take no action.

Members of A.A.: Yes. Again, the gest of comments geared towards having more opportunities to reach out to the alcoholic and having this service is a step further to having a Grapevine on-hand, being able to connect instantly through listening to another alcoholic sharing their experience. The majority said yes, were technology inclined and there were those that said yes, however felt they would not utilize this service because they were not technology inclined and preferred being in a physical meeting of Alcoholics Anonymous carrying the message.

Members of AA: A majority of members was for updating this pamphlet with new stories and others were not either interested or open. I noticed that members with time, took this personal after sharing the background history as why this pamphlet came about reasons such as voicing "you're either an alcoholic or not, all is inclusive. One person was Hawaiian and an Alcoholic and felt as an Alcoholic he once felt discriminated for being an alcoholic and recalls being called a loser.

Committee report—treatment committee

Based on the survey, the vote on two of our issues was 7-4 with two abstentions. This is not substantial unanimity, so the committee was invited to discuss the issue on April 28. Four members and the committee chair were present

Q1- add text from the pamphlet about the AA meeting to the big book.

Survey vote was 4 in support and 7 for take no action

The committee chair read out the comments from the survey and asked the four members if they represented the minority or the majority. All present represented the majority except the chair. So the chair spoke for the minority however a couple of the survey responses had already changed my mind. While I'm in favor of promoting this material, the big book is for new members and the point that the 12&12 may be a better fit changed my mind. The four members did not change their votes so substantial unanimity was achieved with the change of my vote.

Final recommendation from our committee is 8-3 take no action.

Q2 revise the big book to eliminate inappropriate gender references.

Survey vote was 4 in support and 7 for take no action

The committee chair read out the comments from the survey and asked the four members if they represented the minority or the majority. All present represented the majority except the chair. So the chair spoke for the minority. This time I did not change my mind. I feel this is a thoughtful approach to a serious issue that is damaging to new members. However, the four members present did not change their minds. They said their groups feel strongly that changing the first 164 should not be done. They felt that creating new or alternative versions of the texts would be a better direction—instead of changing a historical document.

To achieve substantial unanimity, I changed my vote from support to abstain l—not because I changed my mind but because as chair, I felt my vote should be a tiebreaker instead of causing dissent.

Final committee recommendation: is 7-3 take no action.

Q3. Create a new Spanish translation of the Big Book

Initial survey vote was 8 votes for support and some abstentions.

Since this vote was unanimous, no additional discussion was necessary. All present agreed.

Final committee recommendation: unanimously support.

The District Committee Members (DCM) got together on April 26, 2020 to discuss and vote on Panel Topic XI for consideration. There were 11 DCMs, 2 Alternate DCMs and 2 Area Officers present. The discussion involved the DCMs and Alternate DCMs with the voting body being left to one representative per district (11).

The Focus of Discussion:

VI – Literature Committee

Consider if proposed agenda items for plain language, simplified language, accessible translations and large print versions of the book Alcoholics Anonymous, as well as workbooks to help study the program of Alcoholics Anonymous, can be addressed with a common solution.

In short, 6 DCMs voted in support of the consideration, 4 voted against supporting the consideration and 1 DCM did not vote. Though the discussion was meaningful, it was difficult to differentiate the comments made by each participant with a definite yes or no vote because most comments focused on or reflected the proposed agenda items (5 to be exact) versus the consideration itself. This might help us to better understand why 50% of the online survey voted to abstain. During this discussion, the abstain option was not available. The proposed agenda items and recommendations made in the background information raised much concern amongst participants but also some items and recommendations were found applaudable.

The most prominent point made in all the comments documented (direct or in-direct) was

- 1. Separate considerations for each proposed agenda item (5),
- 2. The need for more clarity on each item (some made available in the background information but more needs to be done).
- 3. and what would be the proposed intent for each item considered (Clear intention for change)

This would make clear a yes and no voting process. It is obvious in the notes that each participant's comment reflected both sides of the argument (yes and no to individual items based on recommendations) because all the items were bundled into one.

With this said, I highlighted the individual comments that may have supported the yes vote. We hope this provides a better understanding to the majority and the minority conscience of the DCMs.

In summary,

It was difficult to decide on a yes or no vote on the entire consideration due to multiple items being bundled in one consideration. Though the majority voted yes to support the consideration, it is important to understand that the intent of this consideration is to see if the proposed agenda items can be addressed by a common solution. Nothing more.

Highlighted comments may represent support for the majority vote (6) and comments not highlighted may represent support for the minority vote (4) or may not represent either. Will use some comments as examples if presentation time permits

Discussion documented on April 26, 2020 by Roxanne Z.:

- Lots of discussion. Common Solution? No too many items. Conversation held about each specific item. Yes on simplified language, no change to first 164 pages of Big Book.
- 5 different items in question. Need more clarification.
- Plain language book is not replacing BB.
- A lot of good input from GSRs. Stay as is. Could not agree to abstain or say yes.
- How much do we accommodate every subgroup? Then it possibly could remove/minimize the face-to-face, the personal aspect of AA. The use of a sponsor is important to understand the BB.
- Again, don't change original document (BB). OK with stand alone companion book abridged in 5th grade language. (from p368 369) Questions to ponder: Does this request belong to the Conference Literature Committee or does it belong in Accessibilities? Are we really serving the members of our fellowship when we continue to encourage our newcomers to buy a Big Book that some cannot read? Would not an additional piece of literature meant to make "Bill's Story" and the "12 Steps," more understandable, pay for itself in ways we can't begin to imagine? Doesn't our 5th Tradition call us to carry the message to the still-suffering Alcoholic and this message is in the Big Book, but it is possible the message cannot be understood by everyone?
- Against changing BB.
- We either support the item in its entirety or not (similar to budget). As a whole, too many pieces. Our duty is to have a yes/no vote, not abstain.
- A lot of tiers to this question. If the question is understood, ok on some items, not ok with others.
- BB changes: Over 85 years there have probably been 5th grade level readers. About changing/adding appendix addressing religion/spirituality: Where do we get by adding religion to the program? It's a spiritual program.
- There are already workbooks and dictionaries available.
- It's the responsibility of the sponsor to help the sponsee by walking them through the BB.
- Too many items in question. We wouldn't want all of these pieces to be approved.

- Too many pieces. Ok with companion to BB in Simplified Language. Some of the background material was 20-25 years old and not new to discussion.
 - Large print for accessibility? Already have one (big print BB).
- Went to PRAASA and my take-away was Relevance and Inclusivity. Is this
 relevant and inclusive to all. The question presents all these ideas. The
 background materials give examples of simple language Do not like. Who will
 be the deciding party to translate and how will they do it? A lot of the BB is
 beloved and poetic. A lot of Bill W. More conversation needs to take place.
- Inclusivity is the main consideration.
- There is so much supplemental literature out there that will never replace the first 164 pages. A simplified language could be a supplemental to BB to help those simple language potential members. Why not let AA take control of the simplified language market. Simplified language helpful to marginalized members.
- No change to first 164 pages of BB. BB is still the predominantly used text and a minority would/will use supplemental (translations).
- Break down question into separate considerations.
- No changes to BB. They used BB with sponsor and looked up words together. Sponsee better understood BB with help of sponsor.
- Ok with additional book for simplified language.
- Why is all of this bundled in one category? All items are there to enhance, help with literature of AA, in addition to simplified language.
- The individuals in our district were very vocal against a plain language and simplified language versions of BB. They questioned what "accessible translations" meant. And, isn't there a big print BB already? The group liked the idea of a workbook. Group. Consensus: This entire item cannot be addressed with a common solution

Then discussion went over what the Conference would be considering. Would they be voting on the question to move forward or voting on further consideration. Some were understanding it one way, others the other way.

Comment: Consider means it may be voted on or not.

One comment: Too many subtopics to vote all together. Need individual discussion on topics. Stop agenda item before it goes to floor for vote.

Registrars Report for Inform the Delegate Assembly

Since our February Committee Meeting, I have done the following:

- 1. I sent group updates to GSO. The process is slow as the Net Suite data base is not yet totally functional. Please continue to send me group changes and I will send them to GSO. That way, I can ensure that our records are up to date.
- 2. I attended PRAASA and networked with the Registrars from other Areas. We are all frustrated about the delay in the implementation of the new system.
- 3. I sent an email to GSO asking if a more efficient mailing method could be considered for service kits that are sent to Hawaii. I received a favorable response moving forward the kits (GSR, DCM etc.) will be sent via FedEx ground which should take about 7 days. I have not had a chance to ask new GSR's if that has been implemented.
- 4. GSO had initially hoped that the Net Suite system would be ready for full deployment by the end of March 2020. When I asked when the system would be available for registrars to enter data, the following is the response that I got from the Records Department: "I wish that I could answer you question about registrar access with certainty but I cannot. We have gone back to the drawing board and are working with a new NetSuite team. We are concentrating on our internal processes right now because they are just too much. Once we get the internal processes out of the way additional work will be done on the Portal."
- 5. I have been trying to keep the Area committee assignments up to date sometimes not a small task as new GRS's are often coming board and others are leaving. Mahalo to DCM's who keep me up to date with any changes.
