There were 121 registered for Saturday with 114 in attendance. On Sunday there were 128 registered with 111 in attendance.



Possibly only the first time all of the Hawaii Intergroups were all at the Assembly. Group contributions have decreased this year, and individual contributions have picked up enough for Oahu to replace money that was taken out of their Prudent Reserve. Increase participation through events and going to meetings that don't have IG Rep; some GSRs also attend Intergroup. Maui has a Maui Intergroup/Central Office flyer saying who we are and what we do. Reach out to people who are unsheltered by giving out Grapevine magazines. The Intergroups might like to be able to work together where possible – maybe discounts on Big Books if ordering 200 or more at a time. Oahu CO Manger let people know there is a meeting for Special Workers, and also the Intergroup/Central Office Seminar held yearly. Again, the Intergroups wanted to thank the Area for inviting Intergroup participation.

The finance committee members were selected from across the state so there would be someone to present the information to all of the Districts and Groups who would like to be informed. We want to 2022 proposed budget to provide enough money for Hawaii Area Committee to be able to resume in-person Assemblies and Committee meetings when they are again feasible, and to be able to adequately fund the work done by all off the Standing Service Committees.

The finance committee needs to make sure Hawaii Area Committee maintains its tax-exempt status. Our past Delegate does the tax preparation each year, and is a great help for the Treasurer. Our immediate past Treasurer and finance committee did a great job on setting up a smooth transition. The past Treasurer contributed a lot of her time and efforts to clear up the legal name of the Area and to transfer our Prudent Reserve/savings account and Operating funds + accruals / checking account to another bank that would allow online access and increased number of free transactions before incurring additional bank fee charges. The past finance committee also did research into the possible choices of how to accept online contributions from AA Members on the Area website.

Our committee plans to follow through, with the assistance of our Webmaster/ Web committee to have this become a reality.

Our Past Delegate was able to answer a question the Treasurer asked to explain why we in AA service use the word "Contribution" instead of donation. "Contribution" has a spiritual connection. When you donate an object or money, you give it away and have no more action with it. When you are contributing, you have no expectations, but you have a connection and your contribution helps to carry the message.

CEC chair: Billy S from the island of Hawaii currently works in the geriatric field. Mentioned that the last panel did a wonderful brochure and focused on nutritional routes. In his experience the director of the facility would be able to assist us with clear-cut direction. Perhaps set up a FaceTime or zoom. Necessary to capture information on the various capabilities of an individual

facility on how we could reach the suffering alcoholic. Director of facility might introduce us to the Activity's Director. We also discussed the need to educate staff, where there is no understanding about seniors in with alcoholic problems. How do we educate staff? Flyers ... one on ones? Ask the facilities what they need! How can we assist them? Many care homes now provide tablets. Work with other committee chairs to develop PSAs that could encompass several topics for radio station use? Tailor a plan to the community. And what their capabilities are. If they have a communal library where people sign up, do they have a computer, could we add a zoom link to the top of that computer screen? Should we set up a 24 hour a day seniors in Sobriety zoom meeting, or just one already exist?

There is a seniors in Sobriety website...

But it seems to be a bit outdated.

Grassroots effort in our home group and provide outreach. What members are in our old home group, (when we met in person) that of senior age? Set up a buddy system to check in with them help them get online and general outreach... "I am responsible"! New residents who are diagnosed may not have any ability to find us. Suggestion to do PSA through church bulletins. Elder housing also have bulletin boards and newsletters, potentially. Inquire if they have a private channel on an internal TV station where we could provide access to a zoom meeting. Or perhaps a YouTube grapevine talk. If that is impossible perhaps that allow for a posting on the internal television station offering phone number. Ask if there are phone calls allowed to residents.... or letters to individuals who might be in need. After discussion with former delegate,

we would not be able to ask for donations of used equipment, but perhaps the resident could speak to their family members who have just recently upgraded equipment, then we could teach them how to use it. Mentioned Oahu intergroup is putting together a training for seniors – will research status. Pass this information onto GSR's in the "what to take back" and suggest a buddy system! Phone list of active service commitments, reach out to the seniors, a wellness check, an offer to hook them up with a zoom meeting and carry the message. District 8 started the CEC standing committee and has a Seniors in Sobriety group, Eric will research what they're currently doing. Past delegate mentioned at the lower income senior housing all live meetings have been shut down. How can we assist? A new service position? One Alcoholic meeting the needs of another Alcoholic! GSR's can go to the area 17 website click on area committee click on area standing committee click on CEC. A wealth of information!

It was great to get know Al a little more(He also presented in the recent Western Forum) but I really appreciated the information provided by Tim. He made references to several resources(more for me to study...) and also spoke extensively about tayloring AA websites to make it easier for people in need of help find us. I think it would be good for us to take a look at our website if we want to help potential alcoholics find us (I assume we want this). A couple of major points are the key words associated with the website. If someone is seeking help we want to be easily found. I searched "Hawaii Alcoholics Anonymous" in google and the Area 17 website came up on page 2 of the search. That is not bad but I also searched "drinking problem Hawaii" and did not find the Area website listed in the first 15 pages of links and gave up. The other major point that I would like to work with the Website committee on is creating a link on our website for professionals that will take them to a landing page that can provide information about what we do, don't do, and how I can be contacted for more help. I have more to research on this also. If any districts have CPC chairs I am eager to connect with them. I will email DCM's requesting contacts. Present: Panel 61 Past Delegate, Alt Chair, DCM2, DCM4, DCM6, Treasurer.

Discussed the timeframe for planning the 2022 Budget in time to inform the Districts and Groups about the Area's priority of spending, comparisons to prior years, and proposed amounts for each of the budget categories, so that the Area would be able to make an informed decision to pass the budget in its entirety at the Budget Assembly in August. The finance committee members were selected from across the state so there would be someone to present the information to all of the Districts and Groups who would like to be informed. We want to 2022 proposed budget to

provide enough money for Hawaii Area Committee to be able to resume in-person Assemblies and Committee meetings when they are again feasible, and to be able to adequately fund the work done by all off the Standing Service Committees.

The finance committee needs to make sure Hawaii Area Committee maintains its tax-exempt status. Our past Delegate does the tax preparation each year, and is a great help for the Treasurer. Our immediate past Treasurer and finance committee did a great job on setting up a smooth transition. The past Treasurer contributed a lot of her time and efforts to clear up the legal name of the Area and to transfer our Prudent Reserve/savings account and Operating funds + accruals / checking account to another bank that would allow online access and increased number of free transactions before incurring additional bank fee charges. The past finance committee also did research into the possible choices of how to accept online contributions from AA Members on the Area website.

Our committee plans to follow through, with the assistance of our Webmaster/ Web committee to have this become a reality.

Our Past Delegate was able to answer a question the Treasurer asked to explain why we in AA service use the word "Contribution" instead of donation. "Contribution" has a spiritual connection. When you donate an object or money, you give it away and have no more action with it. When you are contributing, you have no expectations, but you have a connection and your contribution helps to carry the message.
