PLEASE SEE "**Budget vs Actual**" and "**Group Contributions**" posted on the Area17 website. We will be voting on the proposed 2022 Budget at this Area Assembly. Please let me know by Area email if you would like a copy of the Proposed Budget either by email or a printed copy by mail.

Hawai'i Area 17 is still in good shape financially. Contributions received so far this year are \$14,200 and expenses are: \$7,841.

Mahalo to all the Groups that continue to contribute to the Hawaii Area. Your contributions are helping to carry the AA message of recovery.

The proposed budget for January 1 through December 31,2022 is \$42,394. There were two updates after the Committee Meeting of May 15. I had included some travel costs that Area does not pay for, and I missed an expense that Area does pay for. The July 7, 2021 version is what we are voting to approve this Assembly.

The proposed budget was based on several assumptions:

- We will spend money based on the Priority of Spending as spelled out in the Area 17 Structures and Guidelines to make sure Hawaii Area is well-informed and our voice is heard at the General Assembly, and AA continues be available for the still-suffering alcoholics.
- We will continue to have the support of the AA Groups and receive their monetary and personal contributions;
- We want to be able to fund Area Assemblies and Committee meetings, whether they are going to be held in-person, virtually, or some form of hybrid meetings.

I want to let all of the Area's Standing Service Committees know that funds are available, and I would love to see the committees spend ALL of the money budgeted, and even more if there is a need!

Hawaii Area has 146,362 Hawaiian Miles available for award travel.

**10:45am Mike L. presented Area 17's Budget Proposal for 2022**

The Budget Proposal was presented by Mike L. Please refer to the Area 17 website for information on the Budget Proposal area17aa.org. Corrina GSR/Makakilo Hill Climbers motioned to accept the proposal, and Bill M. PI Chair second. The Budget Proposal passed for 2022 by 11:00 am. 96% / 4 %

**11:15:** The area body was in consensus with amend the agenda, i.e. to move Pacific Regional Trustee Nominee to 1:15 and Proposals to amend Section 7 and Priority of Spending Section 7.5D.4 by Rachel S. Panel 69 Treasurer. Sean made a motion to do Standing Committee reports earlier and Tommy declined. Vote was taken for the original motion and it passed.

*Rachel proceeded to present her proposal asking for this information to be brought back to the Home Groups. Rachel provided background history for reasons of her proposal to amend the financial section in the Hawaii Area Structure and Guidelines, i.e. during her time of serving Treasurer for Panel 69 she would go the bank with a lot of checks that were written to Hawaii Area Committee or Hawaii Area 17, until there came a time when the banks were rejecting the checks, however, Rachel was able to cash these checks anyway. This opened a can of worms and it took a year to fix. Through this process, Rachel discovered that Area 17 was doing business under (5) different names and this is not the standard way. Through many years, information has been passed along verbally since 1999. This proposal is to do it the right way not the alcoholic way. Rachel has spent a whole year with a lawyer working on correcting this. In a nut shell, these proposals are to revamp Finances on the Hawaii Structure and Guidelines-the right way to avoid future problems. There were a few concerns that confirmed by Rachel that the responsibilities of area officers listed have always been a part of as required by the Hawaii Department of Commerce and that this does not affect person(s) listed their personal financial matters. Once again, these proposals are to be brought back to the home groups.*

Detention Center till present, pending this Pandemic and gets the most out of helping people that he doesn't even know he helped.

The Third Legacy Procedure voting process took place extending to the "HAT" and the nominee of Area 17 is Bob H. past delegate for P67 who will be extending his resume that will be submitted to GSO by Kunani.

#### **Cooperation w/Professional Community/ Brandon L.**

Presenting the report was Lea V. DCM 5 The Area CPC committee has been meeting virtually on the 2<sup>nd</sup> Sunday of every month at 4pm since April with an average attendance of 5 people. All are welcome. Our last focus was Child Welfare Services. Joe R in District 8 was able to give a virtual presentation to staff of West Hawaii Child Welfare Services. This Monday 8/30/21 we have a presentation scheduled with Maui County Child Welfare Services which is supposed to include staff on Molokai & Lanai also. Aaron R on Maui has been instrumental in making this connection. Aaron R, Cathy B, and our own Deborah S are scheduled to virtually present to them Monday morning.

Our current focus is all things around the legal system to include probation, parole, DUI classes, lawyers, judges, etc, etc. Deborah S has been filling racks in the Honolulu courthouse and reached out to probation over there as well. More to come on this.

I have given CPC presentations to District's 1, 4, 5, 10, & 11 to encourage CPC participation within the districts. I was scheduled to visit District 2's meeting but, unfortunately, I have recently had health issues which made that meeting difficult. Sorry Gina and District 2! I hope to be able to make more district meetings soon.

I am currently aware of two District CPC Chairs in Hawaii: Joe R in District 8 and Mo L in District 6. DCM's if your district has a CPC chair not mentioned please connect them with me so we may work together.

The first ever North America CPC & PI Conference is scheduled to be held virtually February 12th & 13th, 2022. Mahalo, Brandon L.

#### **Treatment/Sean F.**

According to the Hawaii Area 17 Structures and Guidelines, Treatment Standing Committee Coordinates the service work of AA groups and individual A.A. members who carry the message to alcoholics and medical treatment settings. Sets up means of “Bridging the Gap” from treatment to A.A. can and cannot do, within the 12 Traditions, to help alcoholics in medical and treatment settings.

At this stage of Panel 71, treatment centers have been in constant contact with me to continue the ongoing replenishment of AA literature. It has been a great way for us to grow then relationship AA and the facilities. Our most recent facility addition was last month adding BISAC (Big Island Substance Abuse Counsel) to our list. I was also invited to District 5’s meeting to discuss with their GSR’s a little about what the treatment committee has been doing, what is planned for the rest of the year, and what they can do to engage and participate. Big Mahalo to Lea V. and District 5 for the invite and their support. Next step, for the committee and I, is to meet in September to start the planning for our next workshop...Traditions and Treatment: What’s the Connection?

Other topics: At our first workshop, Bridging the Gap, we elaborated on the importance of the Contact program and how we can utilize it to introduce a transition packet to the facilities. The transition packet would allow us to give the clients, who would be transitioning from the facilities, an opportunity to leave with contacts and information to enable them to stay plugged into the program, no matter what island they return to or stay on. I currently have 4 Contacts from Maui, 15 from Kauai, 2 from Big Island, 8 from Oahu, and 3 from outside of Hawaii. At this point, we have spent \$503.25 YTD. I would like to thank the Area and Finance Committee for the support in allowing us to continue to carry the message to our Treatment facilities and the clean and sober houses.

Aloha Area 17 trusted servants. At our May 2021 committee meeting, our chair asked for an ad-hoc committee to look at when we go back to face to face meetings – do we make it hybrid?

One of my duties as Alternate Delegate is to serve as a member or chairperson on ad-hoc committees as deemed appropriate by the Area Chair. Right after the committee meeting, I received a few emails from members volunteering.

Our ad-hoc committee met via virtual platform this past week. Thank you to Gina B., Karen N., Sean C., Chris N., and Eric V. for being a part of this process.

We first looked at logistics, equipment, equipment cost, venues and most important, having enough Wi-Fi bandwidth to support our hybrid functions.

A few of us attended some hybrid meeting workshops. One of them was from SENY Area 49 in the Northeast Region.

I learned a lot and got some important information. The equipment needed would be a laptop with HDMI ports, web cams, external monitor, USB and HDMI cables and possibly external microphones. I think our area PA system can be used for audio and microphone use. The most important is the hotspot with large bandwidth – lots of conversation on this.

A few things we had to consider:

- Location
  - Does it have 5G or cellular service for a hotspot?
  - Does facility have internet service?
  - All districts hosting assemblies would have to research this when choosing a location.
- Computer and large external monitor
  - The monitor would be for face-to-face attendees to see our hybrid attendees.
  - This equipment could be rented or borrowed.
  - The area would need to have members working the hybrid function of this hybrid assembly.
- Cost
  - The approved 2022 budget has a line item of \$1,200.00 for hybrid equipment, so we can purchase all equipment needed for hybrid assemblies and our committee meetings.

The recommendation of the ad-hoc committee is when Area 17 does go back to face-to-face assemblies and committee meetings, that it be hybrid.

17 months into this unprecedented pandemic, we still don't know what the future holds. We need to have a safe environment at our assemblies and a way to have A.A. members join the assemblies and committee meetings if they are not able to attend face to face.

We plan, prepare, and adjust. We trust our trusted servants. God through our group conscious will keep us unified and safe.

Opened with a moment of silence and a serenity prayer, 9 participants present: Ken, Lena, Mary N, Kimo, Conrad, Cori, Pete, Jason, and Jim.

Discussed and considered the following questions:

Mary N:

1. How can we maximize use of zoom to facilitate learning? Specifically, training GSR's during virtual assemblies projecting information necessary to understand background of an issue, be reminded of guidelines, protocols, etc.
2. How can we involve more seniors for online participation?
3. What are our collective experiences with online meetings?

Discussion:

Cori: I like to be seen at the meetings; various ways that groups transition from virtual into life or hybrid formats; uncertainty.

Mary N. shared some experience about innovative ways of conducting virtual meetings to make them educational, user engaged, leaving participant tools for recovery (electronic newcomer's packet that enables downloads of important information)

Suggestion: facilitate sharing of experience by the groups that accumulated tools and use online features to their fullest –to preserve and enhance online mode of recovery for new alcoholics.

OIG should take lead I helping elderly A members acquire technological literacy and participate in online recovery.

Also briefly discuss the future of the status of online groups with GSR: presently listing with GSO is available but participation in group consciousness at the level of AA structure is not Main question that we all will be answering: the role of online experience that we accumulated during Covid for the future AA fellowship

Closed with a minute of silence and serenity prayer.

### **DCM round table discussion submitted by Cliff.**

Our group discussed two significant subjects at length. The first being the health and status of different groups in our AA community from the perspective of the DCMs and members opinions and views of the participants on budget spending priorities. This report only provides a few of the ideas and information provided by our participants.

The first subject took the majority of our time and we had in excess of 10 people giving insight and wisdom on the current state of meetings in our districts in light of the current surge in covid-19 cases.

Alika DCM19 shared that Waikiki Breakfast meeting has decided to be virtual. Some the meetings are person to person, some are adapting and growing into hybrid meeting because of very positive experiences.

Ana DCM12 reported that there are few active meetings and due to low attendance and few locations for meeting they are all person to person.

At this time Freddy suggested that the group take up the subject of amendments for the budget. Considering splitting line items and the subject of priority of funding.

DCM17 expressed the opinion that the top priority is to carry the message.

Eric, our registrar noted that individual voices are of high importance and asked for open minds during our discussion.

Len of district 7 opined that the #1 priority of Area is to ensure the delegate be funded for attendance at GSO and then subsequent service expenses.

Sean reported that even though we haven't been meeting as frequently as we have been wanting to, he has still been in contact with all the treatment facilities, and has been doing what needs to be done to stay in front of them to let them know we are here to help. We have racks in almost all of the treatment facilities throughout all of the islands that have treatment facilities on them.

Our last workshop was about bridging the gap between the treatment facilities and AA when the person attending the facility is out. We have temporary contact cards that are apart of the packets that we are giving the treatment facilities. We need more men in the program willing to give their info for the temporary contact cards for the packets that we are making and handing out to the treatment facilities. We had a great turnout from our last workshop and got a lot of names willing to be contacts, but we are still needing more because of the amount of facilities on all the islands vs how many names we got.

We are asking everyone to please ask their home groups or meetings they attend, if anyone is willing to be a temporary contact for someone leaving treatment. You can pass this information on to our chair Sean.

We talked about what our next workshop will be about, and its going to be called: Treatment & Traditions: What's the Connection. We are meeting as a committee in Sept to brainstorm more ideas about this topic. We are super excited about the new workshop and can't wait to start meeting again and brainstorming all of our ideas!

Synopsys- What about contact tracing and proof of vaccinations for meetings? We want to stay safe, but we don't want to get political. Is there a way for us to do contact tracing and proof of vaccinations? General opinion of the group was that COVID is an outside issue and as members of AA we should do what's best for AA as a whole and in order to do that, maintaining ourselves, the ones we can control is the best way to address the safety issue. The question was asked how do we handle meetings when they get to large outdoors? We talked about having an emergency group conscious to shut down the meeting and go back online. We talked about online sponsorship and how or if that is working in an online platform and how do we get information on what works and what doesn't? We had one member that attends many online meetings and lives in two places and said that although the online can do in a pinch, the real magic is when two alcoholics are around each other often. Much is missed when you can only meet virtually. We discussed the difficulty of time zones on the sponsor sponsee relationship. We then discussed how AA started by mail and that in some cases that worked so it's already been done. We finally discussed the use of zoom versus virtual in our language. It was considered that it might be affiliation if we use the word zoom when describing meetings. It was discussed that maybe zoom will become a slang term like Kleenex so it will be fine when used in speech but should not be used when written as in the minutes.

Open with serenity prayer-

Topic 1 - Ernest-What about proof of vaccination for the meeting?

Ernest-We want to stay safe. We don't want to get political. Some people are and some people aren't. Maybe we could have a vaccine card proof and contact tracing to keep everyone safe.

Jona-COVID is an outside issue as far as AA goes. Keep what you have in your own circle.

When was ask others to do things in order to get into the meeting, it might cause people to get angry.

Mathea-COVID is an outside issue. As individuals, we should handle things ourselves. If we are worried about the bug, stay online. If discriminate, then you single people out.

Josh - Brought up that at the group level we are autonomous so at the group level, we can decide that as a group.

Linda - Contact tracing has anonymity issues. Also, we can make decisions at the group level as long as they don't affect AA as a whole. We are held to a higher standard than checking everyone. We need to protect the name of AA.

Jason – This is AA not the government. We can't make anyone get vaccinated. Told a story about an inside meeting of 40 people with only 4 wearing masks. This is unacceptable.

Jona – We are taught to follow direction and man’s law or god’s law. We are supposed to be masked indoors and not outdoors. What do we do when we are no longer following the rules? How do we turn people away from meetings?

Josh-Great question and I answered that we have the plan that if we have numbers exceeding guidelines for an extended period of time, we will call an emergency group conscious and vote to shut down the meeting.

## Topic 2 - Online sponsorship?

Mathea – She goes to about 12 online meetings a week. She lives in London and Kauai. She talked about how important it is to be around the person on a regular basis in order to be really effective. She talked about how she talks to her sponsor online and it works well but they both have had sobriety.

Jona-Suggestion that she has heard about. Sponsorship online through video conference has been successful. She talked about how it is difficult to know if what is said is what is done.

Linda- Talked about the difficult part of distance and time changes. It’s not fair to either side. Working with another alcoholic in person is very important. She meets with her sponsee face to face still.

Ernest – he doesn’t have any experience in this issue. But he does think we are going to pioneer this way.

Linda- There have been lots of meetings with online that email.

Mathea- Had an online group that would go online with Navy people on boats. Prison people, people in mental wards, and people deployed have been doing this for a long time. Maybe they have some info. Talked about meetings that have 25% of the people are not from where the meeting is from.

Jason – Mail used to be the way you got the big book. It worked before so it’s not a new concept. We just need to get back to how they were doing it then.

Mathea- Told on herself, she just doesn’t want to do it. But if someone really needs it, she would do it.

## Topic 3 – Should we be saying virtual instead of zoom?

Mathea- Zoom would be the slang word. If you are putting it in print or in a professional setting we should use virtual. But she will probably use Zoom because it’s one syllable instead of three.

Linda- As long as we don’t claim affiliation or promote it it’s fine. But amongst ourselves we will still use slang.

Ernest- if it’s going in the minutes we should not use zoom.

Linda- There was an article about this in summer 2020 issue of box 459 about opening or not opening meetings.

Josh- I like to remember rule 62, zoom, virtual, I have other things to worry about.

## Topic 4 – How do we enforce a mask wearing?

Mathea- I stay away from the meetings that don’t follow rules. If I go into a store and it says put a mask on....I put a mask on.

Jona- Her group conscious says that if someone shows up to the meeting that doesn't want to wear a mask they are not allowed to stay.

Linda-Enforcement of guidelines.

#### Break out: DCM's & Area Officers on Hosting

Main topic was on hosting; working with the hosting districts for 2022, expectations on the districts working with Jeannie, her responsibility working with the DCMs on assembly and committee meetings. Jeannie mentioned it is the DCM's responsibilities to host the face to face meetings, referred to the Hawaii Area Structure and Guidelines on the Alt. Chair's responsibility that is to work with the district, making sure a venue is set up, tips on hosting committee/assembly meetings is available on the area website under "service tools/forums," i.e. titled "Tips on Hosting Assemblies and Committee Meetings." 5-6 members did have experience with hosting face to face committee/assembly meetings. This "go-to" document was lost for a little while, however Sean is putting this information back on the website. For now, alternate chair, Jeannie, sends out a check list to the DCM's of what to do when hosting an assembly/committee meeting. Len asked if there was a virtual guideline for hosting i.e. protocol tips on procedures for virtual committee/assembly meetings- A- No for now, however it is in the process of having a guideline available on the area website. For now, if hosting a meeting, the area puts together a team that consists of virtual hosts, co-hosts, timers, etc. As members are registering, they are automatically dropped onto a spreadsheet. Through out the day, screen is being monitored, 1 person per screen, watching the backgrounds, the timer helps to monitor and ensure that we keep up with the agenda. It takes 10 persons to be on a virtual team and Deborah S. has a list and uses color coding for scheduling. We are learning as we go. Kunani assisted Jeannie with learning and using the Google Forms regarding the spreadsheet, it limits access to spreadsheet for confidentiality. Confirmed that resource on tips for hosting virtual committee/assembly meetings is in the process of being developed. Gina questioned if the hosts for the virtual meetings need to be from the hosting district? A- No, most important is to have a place to conduct the meetings. For the committee and assembly meetings there is a seed amount of moneys provided to the DCM's from the area to start off with. Eric reiterated for assistance from DCMs to register for assembly meetings in advance rather than on the day of. Freddy had a question on airfare for DCM's to participate in the physical meetings. A- Area covers airfare for the Area Officers and the Standing Committee Chairs and the Districts covers the DCM's airfare and registration fees for both committee meetings (1-day) and assembly meetings (2-days). Next the group discussed making virtual meetings more fun. Evan suggested of someone could be available during breaks for live music, Bob suggested making breakout rooms so that people can go to during the breaks and fellowship and have conversations, and Julie suggested having skits played out.

## Concept IX – Vision and Leadership

“Good service leaders, together with sound and appropriate methods of choosing them, are at all levels indispensable for our future functioning and safety. The primary world service leadership once exercised by the founders of A.A. must necessarily be assumed by the Trustees of the General Service Board of Alcoholics Anonymous.”

I'd like to thank our Panel 71 Chair for asking me to say a few words on Concept IX. I feel at a loss because, in truth, the best thing I could do is simply read the full essay on this Concept found in *The Twelve Concepts for World Service*. We've already heard a good bit of it today when we heard excerpts from “Leadership in A.A.: Ever a Vital Need.” I beg you to read the whole Concept; it's a gem.

The topic I was given for this share is “Vision and Leadership,” so naturally, I'm going to take it in reverse order.

Why do we even need leaders? To me, the answer is simple:

“Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward.”

A.A. must continue to live or most of us will surely die. That's a pretty good reason to make sure we choose our leaders wisely.

Now let me define just who I think is a leader in A.A.

It's you. And it is not just you. It is everyone in A.A. who steps up to the plate and acts for the good of A.A. Bill even says this at the end of the complete article:

While this article was first thought of in connection with our world service leadership, it is possible that some of its suggestions can be useful to anyone who takes an active part in our Society.

This is true particularly in the area of Twelfth Step work, in which nearly all of us are actively engaged. Every sponsor is necessarily a leader. The stakes are about as big as they could be. A human life and usually the happiness of a whole family hang in the balance. What the sponsor does and says, how well he estimates the reactions of his prospects, how well he times and makes his presentation, how well he handles criticisms, and how well he leads his

prospect on by personal spiritual example — these qualities of leadership can make all the difference, often the difference between life and death.

But we are usually focusing on the General Service Board and Conference process when we discuss this Concept. But remember, the Conference process involves more than just our delegates and trustees.

“First, let’s remember that the base for our service structure rests on the dedication and ability of several thousand General Service Representatives (G.S.R.’s), several hundred area Committee Members, and nearly a hundred Delegates. These are the direct agents of the A.A. groups; these are the indispensable linkage between our Fellowship and its world service; these are the primary representatives of A.A.’s group conscience. Without their support and activity, we could not operate permanently at all.”

That’s you. That’s all of us. Okay, but what attributes do I need to do this?

A good leader:

1. Can personally put principles, plans, and policies into such dedicated and effective action that the rest of us want to back them up.
2. Does not power-drive.
3. Exercises judgment.
4. Consults widely.
5. Remembers that a good idea can come from anywhere and discard their own plans for a better one.
6. Never passes the buck.
7. Can stand against a storm when it is crucial.
8. Realizes that even angry people can be right.
9. Can give and take and compromise.
10. Can face long-term criticism.

What an order, I can’t go through with it. Do not be discouraged. No one among us has been able to maintain anything like perfect adherence to these principles. And for that, I am really grateful.

Finally, the most crucial attribute Bill mentions is vision.

What the heck is vision? I started with the best dictionary definition I could find:

“the ability to think about or plan the future with imagination or wisdom.”

I can't do better than quote Bill on this all-important idea:

“Vision is, I think, the ability to make good estimates, both for the immediate and for the more distant future. Some might feel this sort of striving to be a sort of heresy because we A.A.'s are constantly telling ourselves, “One day at a time.” But that valuable principle really refers to our mental and emotional lives. It means chiefly that we are not foolishly to repine over the past nor wishfully to day-dream about the future...

... vision is therefore the very essence of prudence, an essential virtue if ever there was one. Of course we shall often miscalculate the future in whole or in part, but that is better than to refuse to think at all.”

I really like Bill's vision of vision. In this context, it isn't a grand plan of where we should go so much as it is the desire to leave A.A. better than we found it. Could A.A. be better? Absolutely. Okay, just how do we accomplish that? We have examples all around us.

We've seen it just this weekend in various ways. When we heard our Past Treasurer's proposals for modifying our Structures and Guidelines, we listened to her vision for a better Area Assembly. When our Delegate shares agenda items with us and looks for our feedback we hear about and participate in our collective vision for a better, more inclusive, more united Alcoholics Anonymous.

So when we chose our leaders, I don't think we are looking for folks with epic plans for remaking A.A. We are looking for people with the ability to evaluate where we are, where we can improve, and who are willing to work hard to bring about the changes our collective group conscience has decided upon. Our collective vision for A.A. and our future.

In the end, I think this Concept reminds us that we are all leaders. We first call upon ourselves to step up and act for our common good. Then, as we progress, we learn, grow, and begin to discern what authentic leadership means by seeing it in others. It calls on us to use prudence when choosing leaders for our groups, our districts, our assembly, our Conference, and our General Service Board. It reminds us of the need to be careful we aren't turning our elections into popularity contests or voting based simply on friendships and favors owed. It reminds us to be discerning about those we choose to lead us at any position, from home group greeter to trustee.

We must remember Tradition One:

“Each member of Alcoholics Anonymous is but a small part of a great whole. A.A. must continue to live or most of us will surely die. Hence our common welfare comes first. But individual welfare follows close afterward.”

When we chose our leaders, we need to keep in mind this overriding idea, “our common welfare comes first.” Let us always choose our leaders with an eye to what is best for A.A., today, tomorrow, and beyond.

“This we owe to A.A.’s future: To place our common welfare first; To keep our Fellowship united. For on A.A. Unity depends our lives, and the lives of those to come.”

#### Deborah S. The Group Conscience

Deborah read information from literature on The Homegroup: Where it all Begins. Talked about the informed group being a collective conscience. Hope is knowing the importance of our voice, the opinions viewed at the group, district and conference. Our part of being able to come up to the mike at area assemblies and speaking. GSR’s (Group Service Representative) is the voice for the group that can bring the groups conscience/voice to the assemblies, their voices is important and the most authority is coming from the groups.

#### Cheryl Service Sponsorship

Cheryl referred to the pamphlet and talked about the alcoholic’s experience in recovery. Service is helping someone who is new. The service sponsor can translate the 12 Traditions, the 12 Concepts, and traditions and other services in A.A. through our literatures. Service sponsors can introduce to the various levels of service in the home groups, district level and area level. Overall sharing responsibilities, learn more about committee /assembly meetings. We are a diversity of groups but all hear for the same purpose, stay sober and help others. Service Sponsors stresses the importance of learning the 3 Legacies- Unity, Recovery, and Service and to continue on. Service sponsorship allows us to pass it on.

Floor opened for comments and questions:

Tommy C- mentioned that service sponsorship is not about going through the steps with a newcomer, but helps with understanding the traditions and concepts and strongly suggests to get a service sponsor.

Sean-talked about area assemblies voting process being based on Roberts Rules of Order- questioned about floor actions, motions for floor actions and having the opportunity at the assemblies.

Bob commented: Floor actions in a GSC based on his experience, is highly discouraged, reasons being that background history is already done. Floor action is moving too fast, recalls it had nothing to do with the agenda at the GSC.

Cheryl: Mentioned that we do have a few places in the assembly agenda where people can bring up new ideas in the “Ask It Basket” for discussion. And also may talk to someone on the side, like talking to past delegates/dcm’s, elder states people, etc.

Kunani: talked about his experience where someone brought to the floor a matter, and the body allowed for this person to voice the matter, it was discussed and voted on. When things are brought ahead of time, able to research and have an informed discussion. At a past budget assembly, someone brought up a floor action, presented the area body with the background history and it was discussed. The Area Chair will make the decision on whether or not it is appropriate at the time.

Eric shared his experience: based on his experience in the Oregon that does allow for Floor Actions to be discussed at the assemblies, they allow time for that, usually if it gets shut down, they allow for someone to bring up a motion to discuss and he can see how this process can be time consuming.

Linda commented: not sure what a floor action is, has to be submitted to one of the conferences and go through the whole process. There may be an agenda topic, thinks for us, with the way we do things, it may be too time consuming.

Deborah S.: Shared her experience as a GSR where at a district meeting she decided to add an issue at New Business, shared the issue and the background history, followed by a discussion of the issue. Love the term “Point of order” that helped the meeting flow.

### **2:30 Tommy provided the Ad-hoc committee report:**

Ad-hoc recommendations: when going back to physical assemblies, considering combining both physical and hybrid virtual meeting at the same time. Logistics involved is having the equipment and it’s cost. Equipment such as, laptops, HDMI ports, web, microphones, most important band and hotspots, or locations with hot spots, computer with an external monitor, projector, projector screen to view and see attendees. Equipment could be borrowed or purchased or rented which the area can afford. Still don’t know what the future holds. There is planning, preparing, and adjusting to keep everyone safe during this pandemic times.

Comments regarding Ad-hoc committee report:

- Area will need to purchase a hot spot, hot spot will not work if there is no cell phone service.
- Will this create new positions? A- has a tech team, need 2 members, maybe not, may look for volunteers within the hosting district.
- Mary- Did not communicate contributions, contributions was not discussed. A- TV screens can be rented, could be budgeting into the budget, still talking about this, the assistance that the area provides is for the venue and food. Ad-hoc committee is not done talking about this.
- Evan-Did the committee consider new tech towers, may be more functional. Evan will be getting with Sean for more discussion on this.



- Kunani- has a fancy owl camera that is able to follow the speaker, captures the entire room, to help multiple views instead of one view.
- Sean –asked about how are we going to handle an 80” TV, perhaps each island has its own projector and screen, there is places that can rent these
- equipment.
- Gina: commented that she did look into an Owl camera and the cheapest was \$1200, being on the finance committee, \$1200 is the Ad-Hoc budget. If the building does not have Wi-Fi set up, Wi-Fi 6 is not going to work.
- Freddy- commented his home group held and hybrid meeting, there was 30 to 50 online, all was ran off a phone wi-fi hotspot. It can be done @ a low budget and can be done with low band width.
- Bob- commented concurs that projectors is not the best idea, lots of assemblies are done in open areas, may not be able to handle the light output, in a closed room, it would work fine, a systems mike to be set aside to limit noises.

\*\*\*Deborah S. Area Chair did a poll of the area’s feedback on the area meeting in person for assemblies and committee meetings starting in 2022 and the final outcome was that 85 % was for re-assessing after the 1<sup>st</sup> quarter of the year and 15 % was against reassessing after the 1<sup>st</sup> quarter of the year. There was a lot of sharing on reasons for going back to physical and a lot of reasons as to why we should not for now.

Freddy : asked if can bring a motion to the body in the next assembly and it was suggested to hold off on the motion for the Inventory Assembly at this time.

Bill asked for clarity regarding Deborah S.s poll on feedback regarding physical assemblies and at this time the idea of going back to physical assemblies will be revisited quarterly.

Nirlepa: questioned when going back to face to face assemblies will hybrid be at the same time- hybrid will be benefit groups with GSRs that cannot make the physical assembly.

Motion to adjourn the meeting Josh and second the motion to adjourn was Bill @ 4:45pm
