**The committee discussed. No poll taken.**

**Viewpoints**

Fear change to the literature would not stick to what Bill W intended.

Trustees request feedback on how the impact feel about the changes to the text of the book Twelve Steps and Twelve Traditions.

The words Lust and rape were not understood as it is today.

The original text is judgmental. Partner is a better word than opposite sex.

Support Lustful enough to rape should be changed.

Supports the attachment of the twelve traditions at the end of each tradition.

If it helps people feel more inclusive change is good.

F. Consider request to restore a paragraph in the story “Freedom from Bondage” in the book Alcoholics Anonymous.

**The committee recommended a request to restore a paragraph in the story “Freedom from Bondage” in the book**

**Alcoholics Anonymous. Polling supports at 67% (34 of 51) Poll does not support at 33% (17 to 51).**

**Viewpoints:**

The paragraph was removed essentially to synchronize the page count between the 3rd and 4<sup>th</sup> edition, and the

committee did not think the reason warranted the paragraphs removal.

Of all the stories for some reason I connected with it.

There are other paragraphs from other stories strategically taken out to preserve the integrity of the story. No paragraph was randomly removed.

In favor, but the story selection for the fifth edition has not been done yet. It is possible Freedom from Bondage may not be chosen for the next edition.  
Need for clarification on cost and online availability.  
Clarification by Bob H. - With good ideas, cost is not considered when the merit of an idea is being discussed; financial prudence is left to the trustees. Bob reiterated Robs mention of an additional 7 blank pages would have been added per book and with that, costly.  
Literature will be printed but is available online first. Currently, no agenda items about literature being available online only.  
Footnotes added and paragraphs removed.  
Let's consider the work load we are asking our staff and trustees on fixing the 4<sup>th</sup> Edition. Let's move forward with the 5th Edition and leave the 4th Edition alone.

#### XI. Trustees

G. Consider request to revise pamphlet "Do You Think You're Different?" to include stories reflecting greater diversity.

The committee considered the request to revise pamphlet "Do You Think You're Different?" to include stories Reflecting greater diversity *but took no action*. No poll. Discussion only. Delegate has a sense of the body.

#### Viewpoints:

The committee felt the pamphlet was inclusive also explains all walks of life are welcome with open arms into the fellowship. Did not feel more stories should be added as there may likely be a group of people not specifically represented.

Is one of the most popular literature pamphlets in the treatment committee packet provided to the treatment centers and other related facilities.

Answer: Proposed agenda items (P.A.I) is reviewed and discussed by the trustee's agenda committee then the rest of the trustee body.

No

conference committee response reiterated or found.

Emphasize that A.A. is a spiritual group could prevent people from getting sober such as those who have problems with spirituality or the idea of a higher power.

The word spirituality could turn people away.

The way it’s written (sort of ) infers that if your not a spiritual entity you’re not a group.

The word “ought” (to be a spiritual entity) could sound to be more a mandate than an expression of God’s love within

the group.

More background needed.

The proposal is (a little too) vague.

We should consider the traditions keeping them in the forefront of our minds when considering changes to our literature. The traditions were written so we don’t repeat the history and fall into the trap other movements have

made.

The bigger message in how we will incorporate the traditions into proposed changes.

The word ought was chosen to describe the kind people (group) with this as their primary purpose.

The Committee recommended the request to include a G.S.R. preamble in the pamphlet “G.S.R.: Your Group's Link to A.A. as a Whole.” 72% (39 votes) in support of. 28% (15 votes) were not in support.

Preamble agreed on: The exact wording is: “We are the General Service Representatives. We are the link in the chain of communication for our groups with the General Service Conference and the world of A.A. We realize the ultimate authority is a loving God as He may express Himself in our group conscience. As trusted servants, our job is to bring information to our groups in order that they can reach an informed group conscience. In passing along this group conscience, we are helping to maintain the unity and strength so vital to our fellowship. Let us, therefore, have the patience and tolerance to listen while others share, the courage to speak up when we have something to share, and

the wisdom to do what is right for our group and A.A. as a whole."

Not a useful addition.

The pamphlet is useful as-is.

What is the origin of the GSR preamble? Information was not provided in the background.

Bob H. "During the time that **Genevieve L. was the Panel 24 (1974-75) Delegate of California Mid-Southern Area 9**, someone came up with a Preamble to read at Area meetings which was quite a strong directive to GSRs making them the ultimate authority over Alcoholics Anonymous" from the internet.

X. Treatment and Accessibilities

The committee recommended request to revise text in the chapter "Getting plenty of rest" in the booklet Living Sober. In support is 62 % (34 of 55) and not in support is 38% (21 of 51)

"Nobody has ever died of lack of sleep" be removed because there is no science behind that statement. The statement is authoritative, brutal, and bossy.

For removal of statement. The statement has infiltrated into working with another AA one on one.

For keeping the statement. Found it helpful to hear "Nobody has ever died of lack of sleep" helped normalize the insomnia and through early times of sobriety.

People die because of lack of slip as identified on the internet Is a disorder that is heredity.

Decision should be based on the traditions.

We have no opinion on outside matters.

It's probably time for it to come out of the book

*Rob: GSR D8 Daily Reprieve- went over this topic- at some point, this chapter was moved from pag1- by the time members got to this chapter, they leave... also it is important to learn the physical aspects- committee <took no action>*

#### ***XI. Trustees***

- A. F. Consider revising text highlighting service roles at the group level in the pamphlet “The A.A. Group.” (Pgs. 984 – 985)

*Comments: rob read the background information- committee is recommending that this motion be adapted*

*Discussion: Committee chose to not take action on the first item:*

- *think it may be worth taking a look at*
- *against consideration, too minor and that it is much pressure on the newcomer to get a sponsor*
- *can see either side of it, can't figure out why it is separated is for leaving as is*
- *Question: why was it to be moved/ Kawika – response, no documented reason as to why bill moved it in the book. / Kunani- 100 percent sure that it was similar –none of the reasoning of why was in the background information/ no answer to this question*
- *some people 209 big book study, a lot of –people that people was exposed to the Dr's Opinion , don't see a reason to move back to where it was I the 1<sup>st</sup> edition*
- *wanted to get to the meat of the program, did not hear about the Dr's opinion till 20 days sober, is for moving-*
- *basically as what Jim said – 172 vs 162 pages*
- *don't see the –point in the change- the program is in the first pages, the Doctors Opinion is not of that, it is more description of the problem but it is not the program- against*
- *it said that moved from page 1, –people, skipping and don't read the preference*

- *Thanks for sponsorship, the historical context leading up to alcoholics anonymous- exploring information, AA build on rich history, the forward- to show people the growth of history –*
- *expressed her concern- remember when a person recommended where to start reading, but statistics show that if people don't have a sponsor, likely to not read the front part of the book.*
- *thank you for finding out the information-*
- *2001 talks about the 4<sup>th</sup> edition that refer to 1995 first 164 pages, conference tells us what the decisions were-*
- *looked up what preferences is about- give insight into maybe Bill did not expect people to skip over it*
- *back then when they were talking about this- big book had to be read by alcoholics (rita)*
- *for moving it – 164 pages, as newcomer, Doctors Opinion did not even come up.*
- *this discussion- spiritual experience use asterisk as a reference.*
- *if we look at our text- referring to the preference- our recovery program clearly states the first portion of this book describes the program*
- *it's amazing how opinion will change, mental physical disease, 2<sup>nd</sup> is the necessity- maybe it should be moved to the first page*
- *remain the same*
- *agrees with using asterisk –make reference –*
- *unwilling to work with a sponsor – flipped through the book to pick and choose what could relate for – saw we agnostics – do see the worth in changing this to the second edition.*

*TJ – presented the proposal- 1985- GSC found in not need for step study workbook, study guide is under consideration- some of committee wondered if anything is broken, workbook may be a replacement of the big book, some on the fence, no one on the committee felt that would need a workbook right now.*

*Comments:*

- *odd DCM's not against the workbook, really feel not a lot of direction-*
- *concerned about sticking a workbook in there- purpose is to make the program accessible- we have no idea what higher power is going to point out see over time rigidity to part of the program, religiously working the program or wearing the the program like a loose garment.*
- *personal opinion – want to be able to attack- something like that would allow another ave*
- *thought all for the big book*
- *feel like there are so many ways- putting one seal of approval to get this done, may be a dis-service- possibility that maybe aa to review other avenues- reference to utilizing other resources to get that spiritual experience*
- *personally, would love a AA workbook to take sponsors through, it would be another option- currently utilizing other resources to help with her sponsors*
- *for the workbook, currently using guidance from somewhere else*
- *earlier program of recovery is contained in the first portion of aa- don't want to our program to be diluted by outside influence- hear in aa messages from drop the rock or treatment centers- one good reason to have our own workbook so that we would have a literature that is based on our language of recovery- home group only use conference aa approved literature*
- *this topic I a way important to me, I was not for this in the beginning- more was revealed- most of the clients was dealing with was born in 1991- we can direct of how the big book should be understood, a lot of times- language can be interpreted in the wrong way- think about how man newcomers could be reached- bridge the gap*
- *I am not sure if this is the same for the big book to be written in easy language, when first coming into program, terrified to ask for a sponsor- only concern is a new comer will think that they can do it on their own –the magic was when someone sat and explained this with me...*
- *am for that workbook, has been using google using other resources*
- *when we approached this a few years ago- was trying to help someone that did not know how to read, in the processes she lost that person, don't know if still alive, feel strongly that we need a workbook- only asked to write out thinks but not be another alternate for a sponsor.*
- *it would be fine if there were a conference approved workbook. Trusted the process working with a sponsor.*
  
- *to improve access to the big book, what kind of guide would help, incarceration system is difficult to reach inside- question- would we rather have members in the*



*inside have limited access or have access for them to help understand the big book where meetings and sponsors are limited or not available. Lot of members don't have access. How could we do this best*

- I would have to say that agree 100% need a workbook, I wanted to get sober, but did want help, I attended a AWOL group based on the Little Red Book- found it was understandable and encouraged to participate the group- 1-7 people functionally illiterate in corrections it's worse. Not so much how we do it but when we do it.*
- Grew up old school- sponsor interpreted the BB that way he did, does BB study today – regardless, feels a workbook would be a good idea more positive than a negative one- really want to understand the writer- studied up on what bill was trying to say- for the workbook*
- believe that one of our purpose is to carry the message and consider people who not able to be hear today and not able to have access support workbook – bill w turned over to the conference to develop more literature.*
- cross reference 12 by 12 also in addition to the big book.*

*Presenting Item – Kerwin DCM 8*

*First introduced in 2018- some language were drafted and added to the literature, “Living Sober,” insert a paragraph*

*Addition to include safety at the group level –*

*Committee did accept that language and agreed to have more stronger language and being more specific on safety.*

*Comments:*

- Was the note taker in that committee, allowed for her to sit and listen what was being shared, moved by the passion for the safety in aa, aa has a responsibility to keep the rooms safe.*
- this is the topic that she is passionate about, not only want to see it in the literatures but everywhere in Hawaii, it's okay for the literature, but it does not really say what is happening and what we can do for our community, would like more direction on what sponsors can do, groups can to do keep the safety in our community, possibly a security person in our groups.*

- *hot topic, also did not feel it was enough, read the safety card but that is different about safety in aa. Putting into format, posted in rooms, having workshops other than just the (2) literature, making references*
- *think about safety broadly and the language, it is going to be interpreted differently among our aa people, believes some of it addresses some issues, can it be more specific on the dos and don'ts*
- *just want to lend voice to this topic, we have had some local instances that were unpleasant and threatening, the response was everyone knows so and so is crazy and propose that those with sobriety speak up, suggest brings this up in autonomous groups discussing what can we do..*
- *the first thing that came to my mind is responsibility, I recall once I was going to ask a woman a question and this woman asked me where I was going and asked me if that was your sponsor then told me to go sit down.*

*D. Discuss the wide-ranging impact the Preamble change has had on our A.A. Fellowship. (Pgs 241 – 248)*

*\*\*\*Has this had an impact on the groups in our area?*

*Comments:*

My name is Jeannie and I am an alcoholic. I currently serve as your Hawaii Area 17 Alternate Chair.

I would like to thank our officers for facilitating our 2022 Inform The Delegate Assembly and TJ, DCM District 1 Diamond Head, and their Tech Team for hosting. You guys rock.

My duties as outlined in 2.9 of the Structure and Guidelines for Hawaii Area 17 General Service are as follows:

*A. Perform the duties of the area chair in their absence.* I am thankful Deborah is here!

*B. Arrange meeting places and hospitality for all area assemblies and committee meetings.*

- Hawaii Area 17 had its first hybrid committee meeting on February 26th, hosted by District 7 Hilo/Hamakua. We had a little glitch in the beginning but we plowed forward in uncharted territory. We learned a lot, took suggestions, and hope that each time we get

a bit better but for the most part, we accomplished the task at hand, conducting area business.

- I have been working with Karen O., DCM for District 9 Central North Shore Oahu, for the Hybrid Spring Committee meeting on May 21st. Registration is posted on the area website. We have another opportunity to improve before we attempt a hybrid assembly.
- As some of you may have heard, we are looking for a few districts to take on the task of hosting our first hybrid assembly, the Budget Assembly on August, 27th & 28th. Deborah, our Area Chair, has been working diligently in contacting the DCMs on Oahu and working with possible venues. Thank you to the districts that have expressed interest in working together to host not only the first hybrid assembly but the first assembly hosted by multiple districts. Anything can be accomplished as long as we leave room for our Higher Power.
- Lea, DCM for District 5 Maui No Ka Oi, please don't feel left out, I have an email already drafted ready to go out right after this assembly relating to the hosting of the Hybrid Fall Committee Meeting on October 15th.
- Gina, DCM for District 2 Honolulu is actively working towards securing a venue for the Hybrid Election Assembly on November 19th and 20th.
- Hawaii Area 17 will continue online registration throughout the rest of the year. All members need to register online whether attending in-person or virtually. We worked with Sean this past month to make it possible logistically to have two registrations online at the same time.
- As we move forward toward hybrid assemblies, toward in-person, we ask our DCMs to encourage our GSRs to register as soon as possible even before they have their flights. It is important to register early and send in the registration fee so those who provide homestay, transportation, and meals are better prepared for you. We will have a registration deadline for homestay requests. **If you register after the deadline there is no guarantee homestay can be provided.** I also ask DCMs to check their email daily, especially two weeks before the week of the assembly or committee meeting. The information sent out is important to forward to your GSRs in a timely manner.

*C. Serve as a member of the finance committee.*

*D. Serve as a voting member on the Hawaii Annual State Convention Steering Committee. We meet once a month and I will pass the reporting on to Kawika, our Convention Steering Chair.*

*E. Serve as temporary group registrar, recording secretary, or treasurer if any of these officers are absent.*

*F. Appoint the area's standing committee chairs in conjunction with other area officers.*

In my last report, I stated that I look forward to being more involved with the districts when we move toward in-person meetings. Well, there you have it!

On a personal note, I would like to take a few minutes to share a few things that have me thinking about service in Alcoholics Anonymous. I met her through the Area Chair Roundtable at PRAASA and she asked for help in setting up online registration. My duties as outlined in 2.9 of the Structure and Guidelines for Hawaii Area 17 General Service are as follows:

*A. Perform the duties of the area chair in their absence.* I am thankful Deborah is here!

*B. Arrange meeting places and hospitality for all area assemblies and committee meetings.*
