Q- Sean –speaking in favor, should this current motion pass, is there consideration to expand the structure and guidelines describing the responsibility?

Sean F.- it is to mirror GSC0 the alignment will allow for use to change our structures and guidelines-describing the responsibility, therefore, the title and responsibilities will be amended.

*Note: the area body voted to accept the amendments original motion of changing the name 43 in personal and 18 online then a motion to amend the structures and guidelines (Hawaii area 17)

Discussion on the updated motion-

Q- Karen- in expanding the description-talked about remote communities, does that mean that responsibility will be to consider remote communities? And does remote include those with disabilities i.e. hearing impaired, physically challenged, remote areas where internet is not available?

A-Sean F (3) island right now that have treatment facilities and clean and sober houses, responsibility will be to support, that will include treatment, the tri-island and clean and sober houses- we want to be able to help in the area, for example, Judy was able to start meetings and provide literature for Molokai to be more informed, want to get the entire state to be on the same level of what is available and were to go. Vision impaired, hearing impaired, whatever falls under accessibility, all accessibility issues, we want to have this information available in our area.

Kunani Commented: should this pass, we should expand, on the record whatever progress or the way we move forward that our Standing Committee Chair for Cooperation with the Elderly Community stays in tact the way it's always been because that is considered remote community, we were the first to create a CEC structure, whatever progress we create, Cooperation with the Elderly Community- stays!

Sean F- commented, he does not believe that every elderly need accessibility, - the main effort is that we work together-Bob H- commented on his experience, he had the privilege to work with the remote community- clarify in general remote also covers, physically, culturally and linguistically – it's not think as accessibility to be a challenge, it can also include skillful listening, language could fall under accessibility.

Tommy- commented that he will be updating the Hawaii sitting this room working on a proposal Hawaii 17 guided by the traditions
