Treasurer's Report Budget Assembly September 9th & 10th 2023

Big Mahalo to District 10 Waikiki for hosting us this weekend! It has been a while and it is awesome to see everyone. I do apologize for the delay in getting group contribution checks processed, we will work together to get them more quickly from the PO Box to the treasurer.

As of August 27th, 2023, the Hawai'i Area Committee Finances are as follows:

Our 2023 expenses, by Priority of spending as of August 27th:

- 1) Delegate Expenses: \$11,141.81
- 2) Area Assembles and Committee Meetings: \$ 9,080.50
- 3) Area Standing Service Committees: \$ 1,674.48
- 4) Area Operating Expenses: \$5,117.13
- 5) Service Events: \$4,937.32.

You can see by the increase in the PRAASA Reserve Fund that we have received over \$10,000 from the last PRAASA, and I for one am getting excited about hosting it in 2026!

As of August 27th, we have received \$2,898.80 in online contributions so far, and paid \$70.44 in transaction fees equaling 2.44%.

Great news, the Hawaiian Airlines Affiliate Program is finally back up and we have 153,725 Hawaiian Airlines Miles, which is less than earlier this year, so some have expired so am working on using them up. Access the program from our website from the Air Travel Information link at the top of homepage. Please be sure to use it to book your flights. You can use this for any flights you book with Hawaiian Airlines, and you will save 5% on flight to the mainland! You will still be able to use your Hawaiian Miles Number and get credited as well.

And a reminder that when mailing in a contribution the three most important things to include on check or money order are:

- 1) *Make check or money order payable to Hawaii Area Committee.*
- 2) *Include Group Name or anonymous if individual contribution.*
- 3) *Include District Number, not Group Number even for individual contribution.*

Duties:

The duties of the registrar have evolved with the implementation of Fellowship Connection. Registrars often are a crucial first point of contact for A.A. groups and trusted servant's data. Although the registrar's duties will vary by area, the need for accurate information and clear communication is the foundation of this role. Other duties may include:

- Develops and maintains records of all groups in the area, including group name, meeting location, and GSR or group contact
- Works with trusted servants to maintain accurate and up-to-date names, addresses, email, addresses, and phone numbers of the GSRs, DCMs, district and area officers, and area committee members
- Works locally with delegates and DCMs on verifying the accuracy of the data submitted and wherever necessary following up communication for corrections
- Works with the G.S.O. Operations department in keeping area information up to date
- Notify area committee members of upcoming area meetings
- Register all voting members at area assemblies and determine a quorum
- When voting, determine whether a motion is accepted or defeated
- Perform such other duties as may, from time to time, be deemed necessary by the area assembly.
- Appoint the area's standing committee chairs in conjunction with other area officers

In a continued effort to keep our Area updated, I have been working diligently to ensure the information received by GSO is up to date and current. I have been working thoroughly with Member Services to make necessary corrective actions regarding our district counts. In July, the Delegate and I received a memo regarding the "Unknown Group Status". Together, with DCM's, we have managed to get our count in that

category down to 7 (we had 46 at the time of the Memo being received). The deadline for our first progress report is September 29th, we plan to be at ZERO by that time. We look forward to meeting with Hilo/Hamakua District 7, Mark N. and team, to continue this best practice. These continued best practices will certainly ensure our smooth operations and much needed assistance for the Host District and its committees.

Learning that many of our home group meeting locations were lost is heartbreaking. Still, Mattie, the DCM for Tri-Island, who is here today, and his district members moved quickly to establish a safe location where the suffering alcoholic can attend meetings. In his DCM report, Mattie will no doubt provide specifics on that.

With all that said, we must move forward to the business at hand...

My duties, as outlined in the Structure and Guidelines for Hawaii Area 17 General Service, section 2.8 are as follows:

Area Chair's Duties: The area chair should:

- A. Read and adhere to the area chair's duties outlined in the A.A. Service Manual: *Consult with the area committee before setting the date and time of assemblies. Make sure members of the area assembly are notified about the dates and times of assemblies. Consult with officers and committee members on the program/agenda. Keep the delegate informed about what is going on in the area. Make sure that committee members are aware of what goes on in world services.*

- **Public Information PI** – Kimo N.

The Structure and Guidelines for Area 17 General Services states 3.7 (I) the duties of the Public Information Chair are responsible for creating an understanding and preventing misunderstanding of the AA program through the media, electronic media, PI meetings and speaking in the community groups.

The PI committee holds our meetings on the 3rd Saturday of each month. We discuss ways of getting the message out in the community that Alcoholic Anonymous may help the next suffering alcoholic. So, we discussed putting message signs on public transportation like the bus. Maybe having some bumper sticker that says if you think you have an alcohol problem call this number to ask questions about asking for help for the suffering alcoholic, maybe making a QR code.

I found out that we cannot put AA pamphlets in the hospital at this time. I invited two members from two groups in Oahu to join our PI meeting who are doing public information work, Shay from Malia discussion and Cathy from Ala Moana Bonfire meeting to attend the monthly PI meeting. At this meeting on the 3rd Saturday August 19, 2023, we discussed more ways of getting the message out to the suffering alcoholic like taking part in fairs like a senior fair or hotel fair to maybe have pamphlets available to read.

I encourage the district PI chair to attend the Area PI meeting. Kathy from the Ala Moana Bonfire meeting attended our monthly PI meeting. Currently putting message signs on the bus and bumper stickers is being worked on. The committee also has been writing letters to schools, hospitals and public groups to do presentations. The PI committee is finding ways to get the message out to help the suffering alcoholics. Here on Maui, I have talk to the bus company to put a message on the bus like if you have a drinking problem, please call XXX-XXX-XXXX. Also, the bumper sticker can say the same

thing. In closing I would like to thank the area committee for letting me serve as your PI chair.

- **Grapevine** – Karen N.

Mahalo to District 10 for hosting this assembly.

The duty of the Grapevine Committee is to keep the fellowship informed about the many benefits of a Grapevine subscription. The Grapevine can be thought of as a snapshot of the current membership of Alcoholics Anonymous. The Grapevine is available in both printed and digital formats.

Since our last Area Committee meeting, I attended a Zoom meeting for all Grapevine Chairs. The main topic of discussion was the new Grapevine App. We were given an opportunity to test it out and report any glitches in the system before the formal roll out.

The Grapevine App is now available both for I-phones and Android phones. The basic app is free, but for an additional charge of \$29.99/year or \$2.99/month full access to the Digital Grapevine and Grapevine Archive is available. I have been “playing” with it for a few days and have found it to be quite user friendly – and I am not particularly an “app user”. It is useful to have everything in one place – podcast, sobriety calendar, daily quotes, store, etc.

I have been sending the members of my committee the monthly Grapevine Newsletter and hope that they are sharing it with others.

The Grapevine is always looking for stories. The current requests are:

1. Favorite Big Book Stories or memories – what are your favorite passages and chapters and why? Deadline is October 15.
2. Why do you love the Grapevine – was there a story that once helped you? How did being a Grapevine Rep help your sobriety? Deadline is December 15.

One of the things that I learned at the presentations that I have attended is that the stories do not have to be perfect when submitted. The Grapevine editors will use their editing skills to make stories print ready. The important thing is to submit your story sharing your experience, strength and hope.

The next meeting for Area Grapevine chairs will be in a couple of weeks. I may or may not be able to attend, but the meetings are always recorded for future reference.

Per our Hawaii Area Structures and Guidelines, the Corrections Committee coordinates the service work to carry the message of Alcoholics Anonymous to the alcoholic who is confined in a correctional facility.

We had virtual meetings monthly. I missed two months due to travel (May and June.) We are inviting not only the GSR members assigned to the Corrections meeting, but also those AAs who are going into the correctional facilities. We share about what is happening on each island, who needs help, and what is working well. We meet virtually on the First Monday of every month at 4:30 – 5:30 PM. Meeting code: 820 8005 1814; Pass code: 566 874.

For those of you who are interested, September is “Recovery Month” and the people in custody at a correctional facility are presenting a virtual AA meeting every Tuesday and Thursday in September at 11 AM HST. Meeting code: 841 1036 5604; Pass Code: 223 531.

There is also an International Corrections Meeting of AA online. The first and last Sunday of each month is at 12 noon HST currently (1 PM in the winter.) The other Sundays in the month, the meeting is at 5 AM HST (6 AM when daylight savings time ends.) Same meeting information as Recovery Month meetings: Meeting code: 841 1036 5604; Pass Code: 223 531.

I have flyers for the A.A. Corrections Pre-Release Contact Information Program. There is one flyer for AAs on the INSIDE within 6 months of scheduled release and another for those AA Members on the OUTSIDE who would be willing to help get them connected with AA as soon as possible after returning to the community.

Mahalo to the area committee for allowing me to serve as Chair of the CEC committee. I want to thank Alcoholics Anonymous for a very full and productive life. I'd also like to apologize to this assembly for not being able to attend the last assembly and committee meeting due to the obligations and blessings of that life. A work trip and the graduation of my youngest son.

I also want to assure the assembly that the work of the committee has not suffered. Since the beginning of this panel, the CEC committee has met on a regular monthly on-line check-in zoom meeting to discuss our progress and challenges.

After PRASAA, which I did not get to attend, I was contacted by a new friend, David F. from Area 57 in Oregon who heard about the work of the CEC committee and was interested in how his Area Accessibilities Committee could benefit from our experience in reaching out to the older alcoholic. We were able to share resources and exchange ideas with them. It was a wonderful example of God's will at work through others.

The committee is currently working on a project that was suggested by Mary N., the past chair. We are creating a comprehensive list of facilities that deal with the senior population on each Island and/or district as our population dictates. (Oahu will need to be divided by district) We have had consistent participation from most of our members. The list is coming along and should be a lasting resource for this committee in the future. One committee member, Robert M, suggested that we include a contact name and number wherever possible.

District 8 in West Hawaii has a very active CEC Chair, Karen M, who has gone out into the community and made lasting relationships with folks from the "Office of Aging", "The Veterans Administration" and various county offices including the fire department to create contacts and make our literature available to them as our senior population is increasing, and we want to make sure that those professionals who may encounter someone with a drinking problem have access to the right information for these folks and their families.

Lastly, I had the opportunity to participate in a workshop that was held by District 8 and presented on the various Committees at Area level and was able to make acquaintance with the District 7 DCM who then joined our last on-line committee meeting, Mark and Julie, DCM Dist. 12, from East Hawaii, Hilo and Puna Districts who also have an enthusiastic member of their service structure that would like to create an event for the senior population. They have agreed to join forces to have an AA workshop similar to Dist. 8's after the first of the year and have invited myself and Karen to participate and present on the CEC committee. It will be very interesting to see how God uses this to continue to spread the message of recovery to the sick and suffering senior alcoholic. More will be revealed.

- Danniele talked about being voluntold to be GSR and it turned out to be a great thing for her. She loves being in service. Says area service 100% keeps her sober.
- Griffin (Offers Solution) - Proactively ask area service members to share when finder speakers for meeting as a way to spread the word about the benefits of area service.
- Reed - it's difficult because a lot of people just don't want to do the extra work.
- Problem: Homegroup business meeting formats can be improved to be more efficient and take less time (Scotty, Alternate GSR, Malia Discussion)
- Scotty: Talked about how great service has been for him and the lessons he's learned being selfless and helping others.
- Humility
- Keleka: Offers solution - bring up suggestions / make motions for proposed changes during group conscience.
- Scotty Counters - not enough time left in new business to address motions to

change meeting format.

- Danniele Offers Solution - The homegroup group conscience secretary (the GSR), their leadership is critical to ensure these types of things are heard and acted upon during the meeting.
- Stacy and Shannon: Offers Solutions - talk about different strategies that can be used to help during group conscience or business meetings. These basically come down to leadership and being assertive.
- Marianne - meeting members need to be informed and homegroup members should talk to each other and inform each other prior to voting on things.
- Griffin: Being in area service is a way to keep things working the way they did when he got sober paying it forward, giving back

- **Marianne E. – (New GSRs) Business Meetings**

After lunch I joined a Roundtable meeting for the Orientation of the new GSRs with Delegate Tommy. There were 14 new GSRs present. GSRs are the link of communication between our home groups and the General Service Office along with the world of A.A. The group's GSR is tasked with making sure the group's conscience is heard and fully considered at the district and the area and becoming part of the delegate's thinking at the Conference. Each GSR is responsible for informing their group on the Conference outcome. When a GSR is present at assemblies it shows the group cares about what is going on in the Fellowship and wants to learn and make its concerns and suggestions known. The GSR votes for the group. The GSR service is a 2-year commitment. Which is the same for the Panel. We have 2 Panels in the U.S. in 2023 (Panel 72 & 73) and Hawaii is Panel 73. Tommy started service at Panel 55. We follow the Guide of Life with the first tradition which simply stated is "Unity". Tommy mentioned the purpose of any A.A. business debate, whether in the home group, district, area or GSC, is to reach a group conscience. There are no winners or losers. We follow Robert's Rules of Order, when floor actions are practiced it allows the discussion to proceed in an informal, yet businesslike manner. Each GSR is placed in a Standing Committee of which there are 12. Therefore, I must report back to Lester what I learned here.

SCC Round Table Report back

Topics:

1. Proposal for a social media service position: Feedback- great idea, we need to progress with the times. We need to be on the front edge of technology, such as the QR

codes on the Myna Bird. Is this a PI job? Is this a technology committee, i.e., Webmaster ... response- it needs to be focused and streamlined to target the younger population. Suggestion: Since the budget has already passed for next year. Find out if anyone is interested and make sure they have a working knowledge of the traditions and trademark laws.

2. Mental health (dual diagnosis??)- some of the attendees that are disruptive, how to address it in the meetings. For home groups safety etc., should there be a guideline? It seems that there are more and more attending and that is changing the landscape of the meetings. Feedback: Pamphlet, P-87 AA for Alcoholics with Mental Health issues and their sponsors. T & A to perhaps do a workshop on this issue.

3. Ask to have meetings with our committees at every assembly.

4. Treatment and Accessibilities approached Intergroup about ride shares for hospitalized or home bound alcoholics (12 step calls), Intergroup felt that was a safety issue for drivers. There was some misunderstanding around this as it was assumed this would be random 12 step calls with people picking up strangers. One solution is to get a google number that is available to intergroup volunteers/staff for these particular folks. Or maybe staff a live chat?? That had lots of logistical issues.

5. Can we get a comprehensive list of treatment facilities that can be shared interagency?

Conference is the actual voice and effective conscience of our whole society.

- **Personal Sacrifice Relating to our 12 Traditions: Bob H. Past Delegate**

Personal Sacrifice Relating to Our 12 Traditions

Aloha, my name is Bob, and I am an alcoholic. I've been asked to talk about personal sacrifice as it relates to our Twelve Traditions.

I'll be honest, I'm not big on personal sacrifice. I'd much rather you sacrifice. At my worst, I'd sacrifice you myself in some way. Now I don't want to take anything away from the very obvious sacrifices made by those who went before us, and yes, even by our generation of alcoholics. But...

I think it's always good to define what we are talking about, so here goes from Merriam-Webster.

Noun:

1: an act of offering to a deity something precious especially: the killing of a victim on an altar

2: something offered in sacrifice

3 a: destruction or surrender of something for the sake of something else.

b: something given up or lost.

the sacrifices made by parents.

Verb:

1: to offer as a sacrifice

2: to suffer loss of, give up, renounce, injure, or destroy especially for an ideal, belief, or end

3: to sell at a loss

4: to advance (a base runner) by means of a sacrifice bunt

5: to kill (an animal) as part of a scientific experiment

When I think about sacrifice in relation to our Traditions, I think both the noun and verb definitions apply.

A.A. as a whole has talked a lot about sacrifice. You can find references throughout our literature. In the article, Why Alcoholics Anonymous is Anonymous, Bill directly talks about sacrifice in relation to the Traditions, both corporately, that is, as groups, and personally, as members. He's a lot more eloquent than I am, so I'll just quote him here. I'm going to skip parts of the quote to save on time, but I've written all this out and you can find the whole quote in that.

"Our new book, Twelve Steps and Twelve Traditions, states that "anonymity is the greatest protection our Society can ever have." It says also that "the spiritual substance of anonymity is sacrifice."

Let's turn to AA's twenty years of experience and see how we arrived at that belief, now expressed in our Traditions Eleven and Twelve.

At the beginning we sacrificed alcohol. We had to, or it would have killed us. But we couldn't get rid of alcohol unless we made other sacrifices. Big-shotism and phony thinking had to go. We had to toss self-justification, self-pity, and anger right out the window. We had to quit the crazy contest for personal prestige and big bank balances. We had to take personal responsibility for our sorry state and quit blaming others for it.

Were these sacrifices? Yes, they were. To gain enough humility and self-respect to stay alive at all we had to give up what had really been our dearest possession—our ambitions and our illegitimate pride.

(SKIP WHEN SPEAKING)

But even this was not enough. Sacrifice had to go much further. Other people had to benefit too. So, we took on some Twelfth Step work; we began to carry the AA message. We sacrificed time, energy, and our own money to do this. We couldn't keep what we had unless we gave it away.

Did we demand that our new prospects give us anything? Were we asking them for power over their lives, for fame for our good work, or for a cent of their money? No, we were not. We found that if we demanded any of these things our Twelfth Step work went flat. So, these natural desires had to be sacrificed; otherwise, our prospects received little or no sobriety. Nor, indeed, did we.

Thus, we learned that sacrifice had to bring a double benefit, or else little at all. We began to know about the kind of giving of ourselves that had no price tag on it.

When the first AA group took form, we soon learned a lot more of this. We found that each of us had to make willing sacrifices for the group itself, sacrifices for the common welfare. The group, in turn, found that it had to give up many of its own rights for the protection and welfare of each member, a "member, and for AA as a whole. These sacrifices had to be made or AA couldn't continue to exist.

Out of these experiences and realizations, the Twelve Traditions of Alcoholics Anonymous began to take shape and substance.

Gradually we saw that the unity, the effectiveness—yes, even the survival—of AA would always depend upon our continued willingness to sacrifice our personal ambitions and desires for common safety and welfare. Just as sacrifice meant survival for the individual, so did sacrifice mean unity and survival for the group and for AA's entire Fellowship.

(RETURN)

Viewed in this light, AA's Twelve Traditions are little else than a list of sacrifices which the experiences of twenty years has taught us that we must make, individually and collectively, if AA itself is to stay alive and healthy.

I suppose I could stop there if what I really wanted to do was talk about sacrifice.

I don't.

Sounds great, doesn't it? Really? A list of sacrifices? No thanks. I agree with Bill, but it's not necessarily how I choose to look at things.

Let's take another look at the Traditions themselves.

Tradition One tells us what the problem is, unity. If we don't hang out together, we die. Plain and simple.

Tradition Two gives us the solution; the group conscience, and I like to add, the informed group conscience...but that's another talk.

The rest of the Traditions are some suggestions of what we ought not to do if we want our solution, an informed conscience, Tradition Two, to work.

But let's turn this on its head. Instead of thinking of it as a list of things we shouldn't do, what if it were a list of things we receive, of things we do get to do.

Tradition Three - Our membership ought to include all who suffer from alcoholism.

We get to be members of something! That's new for many of us, for me for sure. We get to belong. If alcoholism is a disease of loneliness, then I'm not seeing a huge sacrifice here. I'm seeing a gift.

Tradition Four - With respect to its own affairs, each A.A. group should be responsible to no other authority than its own conscience. But when its plans concern the welfare of neighboring groups also, those groups ought to be consulted.

We get to run our own group the way we want. On a personal level, when did that happen anywhere else in anything I did? Sure, there are some suggestions on how to do it, but they are suggestions. Admittedly, they are good suggestions, and we ought to take them seriously.

Tradition Five - Each Alcoholics Anonymous group ought to be a spiritual entity having but one primary purpose-that of carrying its message to the alcoholic who still suffers.

How many folks here ever thought they would belong, could be part of anything, that could legitimately be called a spiritual entity. Not me!

Tradition Six - Problems of money, property, and authority may easily divert us from our primary spiritual aim.

I'm reminded of one of our Step Nine promises: "Fear of people and economic insecurity will leave us." What I hear in this Tradition isn't a sacrifice, it's a promise. The group I belong to won't be diverted by money, property, or authority. That doesn't sound like a sacrifice, it sounds refreshing.

Tradition Seven - The A.A. groups themselves ought to be fully supported by the voluntary contributions of their own members.

It seems to me that because of this one we won't be beholden to outside influences. And really, given how much money I spent on drinking can contributing to our Seventh Tradition really be considered a sacrifice?

Tradition Eight - Alcoholics Anonymous should remain forever non-professional.

Thank goodness that this isn't a job. It's more than a hobby. Bill describes it as an avocation. But it's not a job. I'm not going to get fired, I'm not going to get demoted. I'm not going to have annual performance reviews. Yay!

Tradition Nine - Each A.A. group needs the least possible organization.

That's a real gift. That's not a sacrifice. Imagine for a minute just how complicated we could make this. We know who we are. This could be a mess. It's not. While Dr. Bob wasn't necessarily referring to organization, the words from his farewell talk are apropos and apply, at least to me, as much to the Traditions as to the Steps.

Let's not louse it all up with Freudian complexes and things that are interesting to the scientific mind but have very little to do with our actual A.A. work. Our Twelve Steps, when simmered down to the last, resolve themselves into the words "love" and "service." We understand what love is, and we understand what service is. So, let's bear those two things in mind.

Tradition Ten - No A.A. group or member should ever, in such a way as to implicate A.A., express any opinion on outside controversial issues -- particularly those of politics, alcohol reform, or sectarian religion.

We don't have to have pointless arguments. We get to talk about things that really matter to us as a group, sobriety, unity, love, and service. Let's carry the message, not the mess.

Tradition Eleven - Our relations with the general public should be characterized by personal anonymity.

While it seems like we are giving something up here, I always need to remind myself that it's almost been my ego that has gotten me in trouble. I think too much of myself, too little of myself, and then I completely misunderstand what you've just said to me.

Tradition Twelve - And finally, we of Alcoholics Anonymous believe that the principle of anonymity has an immense spiritual significance. It reminds us that we are to place principles before personalities; that we are actually to practice genuine humility.

I get to participate in something of immense spiritual significance. We get to do that.
Sacrifice?

So yes, the Traditions, at least Traditions Two through Twelve can be viewed, as Bill says, a list of things we give up. Or, with a slightly different perspective, they can be viewed as gifts, gifts of immense spiritual significance. Sacrifice or transcendence? They are two sides of the same coin.

Transcendence is the ability to go beyond normal limits or boundaries. Does it sound like a sacrifice to you?
