She is a Delegate for the 2014 Woman's Conference and warned "fund raising will commence soon." Margaret is still taking woman's meetings into the jails. DCM Ken asked her if she would fill the open position of District Corrections Standing Committee Chair. After discussion, Margaret **stood** for the position, and was **approved** unanimously.

*Standing Committee Reports- Newly elected <u>Margaret for Corrections</u> expressed the need for books to take into the jails; soft cover Big Books, 12 and 12's, and the pamphlet "Inmate to Inmate" DCM Ken mentioned "Bridging the Gap", a program where members can become anonymous pen pals with inmates in need.
