# Garden Island Sobriety

## 'Step Three'

“Made a decision to turn our will and our lives over to the care of God as we understood Him.”



**He said:** When I finally made it to AA and was introduced to the Big Book and the Steps, I was instructed to read through from the beginning and to stop at the end of the paragraph that begins - *Being convinced*. I did what I was told and was able to concede on a lot of the points made in the previous chapters, but still was a little shaky on the God idea.

I believed I would have to begin living like some of those “church-going folks” in order to live a godly life. I was sure that it would not be possible for me to accomplish this, nor did I want to.

Early in my sobriety I had the opportunity to go to a meeting somewhere in LA that had a copy of the original manuscript from chapter 5, *How It Works*, in a glass frame. I read it and what stuck with me was that instead of saying rarely, it said never, and then it said “having read this far if you are not convinced, reread the book or throw it away.”

That is one heck of a statement. It made me seriously reconsider the prospect of getting busy with the steps, honestly and vigorously. The 12x12 states that the effectiveness of the whole program rests on how well and earnestly this step is performed. Why is that???

When I was in charge of my life and doing as I pleased, whenever I pleased, there was a lot of chaos, confusion and destruction. I was aware of the mess I was making and deluded myself with empty promises of making it better as soon as all my ducks were in a row. The only problem with that was those darned ducks keep running all over the place; it was hard to keep track of them.

Only when I came to the realization, with the aid of a sponsor, that maybe I should be held accountable to someone or something else and take responsibility for my actions, did I become willing to take Step 3.

Willingness to take this step has proven to be the keystone of the new and triumphant (*continued page. 2*)



**She said:** The most notable thing I saw when I reread/reviewed the Step 3 text in both my Big Book and 12 X 12 is the fact that everywhere that “God” is referred to as “He,” “Him,” or “His,” I had crossed out the masculine pronoun and penned in “God” or “God’s” in its place.

The males in my family of origin, my father and my brother respectively, abused and exploited me so I have a few problems with God, as a “male,” being trustworthy. I am so grateful that in AA it is “God as I (we) understand God.” Personally, I don’t believe that God needs a gender. That being said, I do trust and rely on God as I understand God.

This step says that (we) “made a decision...” I found myself dreaming about writing on this step and what came up was the Spanish language in which the preterit tense signifies action in the past that was one time, completed, done—like “made a decision” whereas the imperfect tense refers to action that is ongoing as in “to turn our will and our lives over to the care of God as we understood Him (sic.)” Actually, these tenses are pretty much the same in English, but they came to me as Spanish grammar in the dream.

So, what’s the point?! Well, the point is that I think it’s perfect that the imperfect tense applies to actions that are not completed since the 12 X 12 states (on p. 40) that “Nothing short of continuous action upon these (the steps) as a way of life can bring the much-desired result.” and “All of the Twelve Steps require sustained and personal exertion to conform to their principles and so, we trust, to God’s will.”

Personally, I have always been fond of projects that can be completed—nice neat projects, start, work through, finish. Next!

But this program doesn’t work that way so I am having to stretch myself to learn to practice the ongoing maintenance of my spiritual condition, my connection with my Higher Power (*continued page. 2*)

arch through which I passed to freedom. That is the keyword. Today I am free from the bondage of my alcoholic mind, one day at a time, as long as I trust that God has the best possible plan for the new life he has graced me with.

## Bedside Matters

My name is Jim and I'm serving as the Hospitals Chair for Panel 61. For reasons included in a lower paragraph, I'm writing this article as a first thrust at increasing communication within our fellowship about this work.

**At the Orientation** Assembly a committee was created to help "co-ordinate the service work of A.A. groups and individuals who carry the message to alcoholics in hospitals and medical clinics." The discussion among the six of us was exciting and revealed a broad range of activities across the islands. In Kona, for example, there is a meeting in the hospital which has been existent for fifteen years and nurses on most wards are aware of it! In other places we are just beginning to develop mechanisms for getting literature into waiting rooms.

**Similarly, some groups** are highly responsive to a hospital near their meeting spots and other hospitals have no particular group claiming responsibility for activity there.

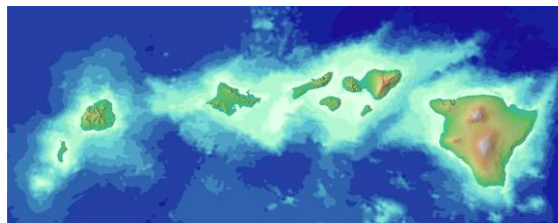
**Because of these** broad ranges of organization and activity, we chose two objectives for this panel's focus in carrying the message to hospitalized alcoholics: (1) improving communication between Central offices/Intergroups and those doing the work in medical facilities, and (2) improving communication between the local groups and the hospitals they serve.

**At this point** we assume there will be significant overlap with CPC and CEC committees as well as PI and Grapevine activity.

In addition to Intergroup getting a hold of your group, these numbers would also be available to Hotline operators in case of questions about meeting times or location changes and also to alert you to the possibility of a caller attending your meeting so that you can welcome them.

- ❖ We would like to encourage each group to get a home-group based email address for correspondence from Area, District and Intergroup. This will allow for greater personal anonymity in internet correspondence as well as easing the transition to a paperless office.
- ❖ Due to our current growth in scheduled meetings (yay!) we are asking each group to consider ways of shortening their schedule listing so that all of our meetings continue to fit on one page.

**Regarding the bylaws** I have asked each group to make a list of routine decisions they feel comfortable allowing the steering committee to make without an informed group conscience. This month I would like you to consider whether or not we need a required amount of sober time to be a committee leader. If you have any concerns about the bylaws please consult your IGR. I hope to have the bylaws signed at our meeting in April.
