Meeting is strong. We had almost 50 guys in there last week. Usually 25 + or 25-40 consistently lately. A lot of guys from Kihei and some guys from Paia last week. We do have a lot of newcomers. Strong group. I believe we're financially sustainable. Our treasurer was absent from our last homegroup meeting which I guess counts as our business meeting. We're holding it on the last Thursday but I'm going to see if we want to have a specific business meeting and I'll find that out next week and report back next month. We pay low rent I'll find out next week exactly where we're standing. I'm going to make a suggestion we start making a quarterly splits. Seems like we've only been doing every 6 months. We also have a new treasurer and he didn't have a ton of information from the last treasurer so he's kind of building a format for himself. Majority of our service commitments are filled. We got the ones for the meeting all filled. We have a lot of service commitments at the meeting we picked up a greeter last week. We have somebody who is interested in being our literature chair person, we're going to discuss it a little more. He's very new but we want to get him into service. We have an intergroup rep and I'm pretty sure it's Tom. We have alt-GSR, we have secretary, we have treasurer, we don't have a corrections person at the moment. This is the 2nd conference in a row where we've had a GSR. Kyle's are alt-GSR he will be present with us at the next assembly. Have a lot of guys that will be getting involved in service for the assembly. I'm doing food and beverage so there's lots of places to put people in. We're starting to get healthier and more structured as far as formatting and service structure goes. We're moving along!

Page W: Outreach for Remote Communities and The Crossing Chair

• Campout date for Lanai Crossing is St Patrick's Day weekend, March 15 – 17. Crossing Committee is well underway to plan that campout.

I went to Molokai on Feb 7th and stayed for 9 days. One of the things I've noticed over there is there's not a lot of spirit of rotation as far as service work goes. Most of the secretaries at meetings or people running meetings have been doing it for quite some time. I did notice that at one meeting the person who ran the meeting just picked someone to chair the meeting that night and they picked a newcomer which was neat. I want to look more into that about these newer people in the program who don't have much knowledge of service work and getting a service commitment. They were asking questions like couldn't we start our own meeting, and I said yes you can start your own meeting. And they're like how do you do that?? There are 7 AA meetings per week, 1 per day. One of my goals was to go to every single one. I didn't make it to every single meeting while I was there. One time we got cut off by a river, going across the road, so that's a thing that can happen over there. The night that the 2 members celebrated their 3 years, we had a bonfire and bbq meeting at another member's house. That was really cool cause there was no time limit, there were just 7 of us there and everyone got to share for as long as they wanted. One member talked about how he could get sober, but how difficult it is to stay sober over here. He said "it's hard because all my family all my friends do drugs, drink alcohol and I don't really know many people that don't." Another member said, "we're a really small group over here, but we're really a tight group and we stick close to each other". Their meeting attendance is growing. The smallest meeting was like 15 people. There's between 15 & 20.

GSR – they don't really know, and I didn't get an opportunity to sit down with a specific individual and explain in depth about that. It would be a great opportunity if they were to like go to the Crossing on Lanai or come to Maui and check out meetings here to hear other members who are experienced to explain that to them. Most of the members over there have hardly ever been off the island. Members of the fellowship over there took us in like we were family even though we were haole, and brought us in with their family, like 20 Hawaiians and took us up into there land that they just regained access to through inheritance and we had this super cultural experience with them. The fellowship there is arms wide open and welcoming. There were 11 members that are really amped to go to the Lanai crossing.

Next Wednesday I'll be going to Lanai to participate in their one meeting a week on the schedule on Wednesday night.

Tonia question – can we have a little forum or meeting while we're at the crossing so the folks in remote communities can get an idea about what service means.

Page – we can talk to the program chairman see if we can add that in.

Julie – Thinking about Molokai and Lanai about being aware of what general service is. This assembly in Lahaina is such an opportunity that I'm wondering if we could find one person to call and just ask if there would be anyone who'd be willing to come. Jubee – we've tried that through a member here that runs a meeting there and this person is supposedly aware of everything that goes on in the Molokai community. It just seems like we tried to reach out to that person and it came back more of a conflict because of the separation between the groups in Molokai. My suggestion what might be a good idea is having workshop over on Molokai to inform them about GSR work and Area service work. I don't know how we'd go about doing that. Maybe have one here and then invite them to come over.

Jim – what about having it situated with the Molokai crossing? Like we had the orientation assembly. Even if it's a one-hour meeting where whoever wants to get that information can be there and anyone new that's interested can also be there avoiding conflicts.

Page – most recently with the influx of newcomers over there it's just like it's shifting because there are so many more of them and they're on fire right now and so that's a good thing. One suggestion that I would have is if they were to come off the island to go to the Crossing or possibly the assembly here, we could shower them with information and try to get them interested in service. Having something informative to explain about area level service would be great. There is one particular individual over there that is coming up on one year. She's doing really awesome. She's come to Maui after the Molokai crossing, so she's willing and saying she's going to the Lanai crossing.

Old Business

- 1. Page and Anita were going to check with Lanai group and Molokai and report back if there's any interest in attending Assemblies or District meetings from both islands.
 - Page: As far as looking for GSR to attend, not anyone showing a whole bunch of interest in that but it would be a great thing to educate them more about. They really don't have much knowledge about that type of thing and that was one thing I was going to bring up.

Page – Makes a motion that:

District pays for 2 tickets for airfare for 2 people from Molokai to attend the ITD assembly here in Lahaina

Liz – 2nds motion Motion passed.

2. Page – Molokai boat ride to Lanai Crossing.

First time ever Molokai members are excited motivated and willing to go to the Lanai Crossing. It's like bridging the gap for them to attend the Lanai campout over there. Never have we connected with two islands and two remote fellowships in the history of the outreach efforts there's never been communication with Lanai fellowship and Molokai fellowship. Been in contact with the captain of the boat they plan to use for their transportation to and from Lanai. His going rate for Molokai to Lanai is \$1100.00 round trip, \$550 each way. As the Tri-Island District, are we willing to meet the Molokai fellowship half way? He can take up to 10 people on the boat. That's \$55 per person. Is the district willing to put up \$550 for one way of their round-trip transportation? There are quite a few members are excited about going and they have even got the paperwork they need to do.

Jubee - If out of the 10 people only 5 can make it will the boat still happen? If we foot half the bill and only 5 people can afford to come, who is coming up with the other half of the money.

Page - In the discussion with the captain he said he would still go, if only 8 people get on the boat that's still a go and charge \$55 a head and if there is less, then it's all taken care of; I know of an anonymous person that's willing to compensate for the rest of the trip. In the situation that there would be only be 6 people on the boat, and they could only pay their \$55 I will make that happen no matter what.

Jubee - The concern is if they don't show up and we give the \$550 and then all of a sudden not enough people go and then it gets cancelled, does he still get the \$550.

District 13 – Tri-Island Meeting Minutes Thursday – February 21, 2019 5:30 pm – Alano Club

Page - In my discussion with him, what he would want is \$200 deposit 2 weeks ahead of time, if some how it doesn't work out, the deposit is non-refundable and he'd keep the deposit. What I'm hoping to do, if this motion carries, I have a check of \$550 I take with me to Molokai when I go on 3/2/19 and I will give that to him, so that the whole boat ride for up to 10 people is already paid for. Whoever goes on the boat is going to pay their \$55 back and if there are not 10 people then I'll compensate for that.

Matty- does the Crossing have any funds for this?

Page – the Crossing has a certain amount of funds that fluctuate from year to year. In the past it was always mentioned, if we wanted, the committee could come ask the district for money. Right now, where we're at is that Lanai venue is \$40 per person for the weekend. We've already, as the committee, voted on anyone who comes from Molokai their registration fee is going to be that \$40 as opposed to the \$70 that's on the flyer for registration. They're going to get that grace as being a remote community. Already absorbing that amount of money if they come, they are paying their \$40 for the camp, but we feed them for free. We're also going to discuss this weekend how many scholarships we're going to make available.

Jim –We have \$700 in reserve. Page needs confirmation on boat trip today.

Jim – makes a motion that:

The District issue a check for \$550 for the deposit for the boat ride from Molokai to Lanai for the Crossing for the 10 people from Molokai.

Matty – 2nds the motion. Motion passed.

- 2. Julie, Alt DCM What kinds of things can I do as an alternate to support the community. One of the things I witnessed other DCMs do in other districts was to be outreach.
