DCM - Brandon

- I attended the June Committee Meeting in Hilo. I flew in that morning and out that
 evening. All three of the Maui DCM's were on the same flight in and out. It was a full day
 of AA. I was able to hear Coleen's Delegate Report and also the Budget Presentation by
 Rachel again. The Area Registrar requested that we email her with all of our District
 Committee members and their contact info.
- The Budget Assembly will be Kona side on August 24 th & District 5 GSR's that can make it present as well.
- The Maui Delegate Report Back was at the Cameron Center on June 22 nd. It was well attended with food and fellowship. Colleen did a great job. She told a little more than she did at the Committee meeting. Her written report is available on the Area 17 website. Thanks Colleen!
- Something that came from Colleen's report is the Area 17 August, 6 2019 \$8.06 Challenge. Oregon Area 58 created the challenge which is based on if every AA member (1,418,177 of us) contributed \$8.06 per year the General Service Office would be completely self-supporting (\$11,426,835 GSO service cost). The challenge suggests that your groups pass a special basket asking members to contribute \$8.06 then after 8/6/19 the group writes a separate check with the total contributions gathered. I plan on providing a few copies of the challenge forms for the meeting tonight.
- I received the following from our Area Registrar who received it from GSO. I have also Forwarded this to the District email list that I have. GSO is updating their business system and this requires a shutdown of some of their/our systems. Important: Our literature ordering and contributions systems will be shut down during the change-over period from Friday, July 26, 2019 at the close of business until Monday, August 5, 2019 when the new system will be available. Also, July 22, 2019 is the last day for us to receive orders. Orders received between July 23 and August 4 will not be processed until we go live. Online stores will close on July 22 at 5 p.m.
- In the latest issue of Box 459 they are highlighting the 2020 International Convention which will be in Detroit July 2-5, 2020. They stated that in August registration forms will be mailed out to all GSR's, Central Offices, Intergroups, and International GSO's. Online registration will be available September 9 th, 2019 on aa.org. Advance registration for the Convention (between September 9 th , 2019 and April 14th , 2020) will be \$115 per attendee. After April 15 th , 2020 will be \$140. Once you are registered you will have the opportunity to book a room. The earlier that you register the better options for rooms you will have. I am planning on attending and hope that you and your groups will be there also. Praying with 50,000 of your closest friends is an amazing experience.
