District 5 had 3 GSR's in attendance: The Wailuku Group was represented by Craig Y., Saturday Night Speakers by Kimo N., and Upcountry Sunrise by Dan M. Lea, our Alt DCM, was also in attendance. - This trip was my first time as home stay guest. Craig and I were both hosted by the same gentlemen named Kevin. I am grateful for his service and generosity. I was able to attend a meeting at a treatment center Friday night and then part of a meeting in a park Saturday night. It was a weekend filled with great fellowship while doing AA work. Thank you for allowing me to attend and represent District 5.
- I received the notes from our District 5 inventory sessions. I think that these need to be reviewed again to come up with any possible action items. We can discuss this further in old business.

GSR Reports

Saturday Night Speaker Meeting - Kimo

Membership up to 20 people. Kimo is donating cakes to group for bday meeting. Since some low attendance Kimo paid half cost of his trip to area assembly

Wailuku Group - Craig

Attendance very good. They are thinking of tweaking format. Some people are not satisfied with how long they get to share.

Upcountry Sunrise - Dan

They meet 6 days a week. Dan attends most days. Lots of newcomers. Good attendance. Lots of people in service positions. Active liaison with church. Church doesn't want dog droppings or smoking. Take in about \$50 per day from 7th tradition. He described what positions the group has - which are filled. Good participation at home group meetings. Finances are on track including travel for GSR. Dan invites everyone to come participate.

Committee Chair Reports

Hospitals - Richie

Once a week he is going somewhere to see what he can do for the hospitals. Brought meeting schedules from Central Office. Took pictures of AA literature racks at Maui Memorial. Went to Malama I Ke Ola and spoke to a woman. He found that he needs to speak to human resources person. There are 3 addiction classes per week. They are interested in obtaining Big Books and a literature rack. He shared some pamphlets with them and that he would be back to discuss how we can cooperate. They shared about another Akumai Recovery center which is also a free clinic.

Last week he visited Kaiser Maui Lani. Shared flyers with administrator to pass along to addiction counselor.

He has a list of other potential contacts from Kimo. Rack costs \$25 - Richie will proceed while he has funds

Treatment - Bill - Absent, but Lea and Dan spoke with him

All is going well. Dan and he discussed that Aloha house is not AA it is cognitive behavioural therapy. They don't work steps there. Bill and Dan will be meeting with administrator. Kimo said that Aloha house has a counselor that introduces clients to 12 step fellowships and takes them to meetings.

CPC - Neil

Appointed by Brandon. Neil qualified - gave background info about his AA service experience. Group clapped as vote to confirm Neil.

- Workshop Gigi suggested that we do a musical / skit. Lea encouraged attendees to continue to think of ideas and consider if they would be willing to participate.

He worked on Treatment with a guy and now they are working together on Minah Bird. He is learning more and more every day. Craig - Second orientation assembly. Fun. First time doing homestay. Got a ride to assembly from guy they stayed with. Had another Area service friend pick him up from the airport. Enjoyed hearing from Regional Trustee and took notes to bring back to his group. Learned a lot. Sat at the "Maui Table" where he knew everyone, but he thinks there is a lot value to meet new people. He looks forward to meeting new people at next assembly in Lahaina. Venue was not ideal since ¹/₃ of people needed to go into spillover room. Craig enjoys learning new things, meeting people and being a GSR.

Dan - Assembly was not his first, but first in Hawaii. He learned that he is not here to bring the way of doing things from his old place, he is here to learn how things are done here. Hawaiian Area seems very different. Spirituality seems different. It seems less Christian oriented here. Dan sat at Big Island table. Now he has several new contacts. He sees how judgemental he used to be and that now that he has pushed away that type of living he is more open to contact and relationships he never would have had before. He was amazed by how easy it is for him to go along with these ways of doing things that are different from what he knows. He was not like that in the past. He is grateful for the opportunity to serve and to serve in new ways. He had a great time.
