- Inform The Delegate Assembly via Zoom
 - Delegate sharing
 - World service rescinded virtual meeting in April, It will happen in May
 - This was based on polling of delegates
 - o There was more consensus on this rather than tabling items for next year
 - GSC will be reduced version of usual format
 - GSRs have between now and 4/24 to take survey online to report directly what groups thought of assigned panel topics
 - After 4/24 results will be forwarded to standing committee chairs for the input to be compiled
 - 5/1 panel presenters will have written presentations submitted
 - 3-5 minutes for presenters to present agenda items followed by online polling for voting members
 - Completely remote assembly

- Before 4/24 is when the online surveys can be completed. As a member of AA
 can I fill out a survey as an individual instead of representing a group? Yes
- Setting up online format for groups Matthew
 - Tons of meetings available online
 - Zoom Bombing people purposely join meetings to cause problems.
 - You can create a link for each meeting and distribute to group for each meeting to keep "Bombing" out
 - Meeting can also be controlled by password that is only shared with members
 - Automatically mute anyone that joins after the meeting starts and have co-hosts to help moderate and screen people in the waiting room.
 - Disabling screen sharing is important for general attendees to keep "Bombing" of illicit and offensive images that are shown to all attendees.
 - Bill I started online meetings with members of Pookela church groups.
 Protecting with password and sharing with word of mouth has been successful
- Concerns over some groups disregarding social distancing recommendations
 - Patty went to General Service Office and only found information from 3/19.
 Calling GSO did not yield any information.
 - Coleen
 - GSO is working from home
 - When writing to individual groups they state that they may do whatever the group conscious dictates
 - Traditions are spiritual recommendations rather than rules that can be broken
 - It depends on the conscious of the group and whether group is in accordance with the hosting facility rules and the facility's behavior is dictated by state and county
 - Groups should abide by whatever recommendations that organization renting spaces out asks
 - AA has never gone through this type of situation before.
 - Every group has the right to be wrong
 - Traditions were formed by groups making mistakes
 - The first tradition is about Unity and the rest of the traditions are what we do to create Unity
 - There is no part of AA that dictates to groups what they should do, they decide for themselves
 - Dan The issue of spreading a disease while asymptomatic was not discussed during group conscious. I am trying to keep as much distance as possible while serving the group.
 - Back to Basics and Upcountry Sunset both continue to meet
 - Church officials say that as long as tables get wiped down and they take other precautions mandated by the state then groups are allowed to meet
 - Various discussion with different points raised
