GSR Reports

Wailuku Group - Craig

- GSR has no contact with members of the group

- Question: has GSR thought of taking initiative to get some activity with the group?
 Members are a bit older and probably unlikely to adapt dynamically to online format

Up Country Sunrise - Dan

- Group is doing well
- Masks are mostly worn during meeting and social distancing is trying to be maintained
- GSR tries to keep group informed, but is unsure of the efficacy of these efforts

CPC - Neil

- Attended Intergroup meeting to see if district could use 5031c non-profit status to get a free license for some software
 - Chance are maybe 5% that they will allow us to use the status
- Called area delegate and asked area cpc char about non-profit status
 - Area said if support can be gained from other districts that will increase the likelihood of setting up an area wide software platform for managing contacts.
 - Brandon asks if we are to make a motion at the area level? Neil proposed making a motion at District to carry this notion to Area
- Neil shared a description/presentation of what kind of software is needed and how it would help us.
 - Continuity as CPC and other committees pass duties from person to person
 - Avoid professionals and other community members not wanting to work with AA from panel to panel since information is lost
 - The SalesForce product could track all contacts and all correspondence with professionals or the public during CPC, PI, H&I, CEC, etc...
 - Currently we try to use spreadsheets which is nearly impossible
 - SalesForce offers their product for free to organizations with non-profit status.
