DCM- Our Area chair will start attending OIG business meetings. ITD assembly will be done by 3:30p on Sunday. Bob asked DCM's to get GSR's to make use of our resources, the AAWS, Area 17 and OIG websites. Regarding the printer's copy of the original manuscript, the GSB of AA approved a settlement and mutual release agreement to avoid further expenses, inconveniences and uncertainty of continuing litigation. AAWS waives any claims of ownership of the manuscript and will pay \$135,000 to reimburse a portion of the holder's out of pocket costs, expenses and legal fees associated with the action. The trustee's committee on CPC/Treatment and Accessibilities of the GSB has an opening for a non trustee appointed committee member of ACM, see Bob's February report for more info. Hawaii was not chosen to host the 2030 International Convention. One of the main reasons is that
