The GSR for the group is my neighbor in a large condominium. We can attend Area Assemblies together as well as Thanksgiving, Christmas, and New Year Alkathons.

What attracted me to this group is that the shares are very heartfelt and I can relate to them. The shares are filled with hope even if the situation is distressing. The group has mature sobriety as well as newcomers who inspire the oldtimers.

As the days go by, am beginning to recognize the faces of people who attend regularly and looked forward to seeing them. The interesting thing is that a woman reached out to me for sponsorship and I said yes. Although I've never met this woman in person, I now feel very close to her and we contact each other daily.

Another member in "On Awakening" is in the Grapevine Writing group which meets once a month. This allows me to see some members in person. The Grapevine writing group has turned into a solid support meeting which cushions rough times with health issues.

My sense is that sometimes the easier path is ok. I don't have to wake up at 5:00 am and drive 5 miles to attend a morning meeting. Instead, I can wake up and 6:00 and leisurely drink my coffee until 6:30 when the zoom meeting starts. In conclusion, I'm reminded of "attraction rather than promotion" which is exemplified by the On Awakening group.

Bill M. – My Story

In 1989 my long-time love affair with alcohol and drugs came to an abrupt halt when my wife decided to pack up the children and leave back to her home state California. By this time as I see it today, she was tired of the high strung life and all the anticipation of something bad happening. Most of all, she knew that I didn't have it in me to realize that my involvement with alcohol and drugs and all that came with a risky lifestyle was jeopardizing the very thing that I valued the most. And that was my family. Today I thank her for 12-stepping me by staying sober and providing a nurturing and positive environment for both of us. I thank GOD for empowering me to do so on a daily basis.

By the time I realized my wife had gone back to California I was submerging my feelings in alcohol and drugs to the extent that it stopped deadening the pain and despair. My emotions overruled the state of mind that alcohol and drugs had on me. So I called my dad who had no clue what I was involved in. You see I had a business partnership with my dad as a locksmith and security consultant managing major accounts throughout the State of Hawaii generating finances to afford a very lucrative lifestyle. Nevertheless, I told him what was going on. Of course he was devastated but was willing to help. I checked into a treatment center and the only thing I remember is they provided a safe place and took me to Alcoholics Anonymous meetings. I immediately related to those who spoke about their experiences with alcohol, drugs and the associated feelings of loss, despair, deceitful living and family discord. After all, I was going through the same thing.

I stayed in treatment for about 30 days. Upon my departure and returning to my lifestyle, I immediately hung onto the AA fellowship. I went to daily meetings, gatherings after the meetings, round ups, camp outs and fellowship with other recovering alcoholics and addicts. Amazingly my family returned home after several months to a home that was still intact. My wife had also gone to Alanon until she realized that she belonged in AA as well. We were fortunate to find such loving people who accepted us and supported our recovery until we were able to get our lives back on track with minimal losses to our personal and professional lives. Things were going very well and we were on our way. We had arrived!

At about 8 months of sobriety, my wife was involved with a group of women, and she was doing her sobriety and I was hanging with a group of men maintaining my sobriety. We were heavily involved in the fellowship and enjoying this new found life. All was fine and dandy!

One night I was coming home from an AA meeting on my motorcycle with not a care in mind. It was a clear night and I was enjoying the cool air and the ride home. For some reason beyond me I thought it would be a great idea to go see my older brother and tell him how well I was doing. Honestly not thinking about drinking

or using. After all, things were going well. We spoke a bit about how I was doing. You see I also owed him a great deal for what he had done for me when I was at my worst. I felt I owed him to let him know I was okay. Without getting into details of my discussion, he offered me a package, I took it with no hesitation whatsoever, no thought processing, just a reaction. Mind you, I was in the best state of mind since my last use 8 months ago. Things were going well at home. I did think that maybe things can be different this time. So I took the package. Today when I look back at that moment I realize that I had stayed sober by just attending AA meetings and the fellowship alone. The psychic change the big book talks about hadn't taken place in my life because I didn't embrace the entire concept of the term powerless and I forgot the despair, desolation and misery my drinking and using did to me just 8 months ago. I had no mental defense whatsoever.

I drank and used for the next 2 years while my wife continued to manage her sobriety. Luckily she had this group of women who supported her through my alcoholism and addiction until she decided to pack up the children and leave once more. She could not believe that we were at this place again. After all the promises I made to her time and time again. By this time, I had lost the lucrative business partnership I had with my dad and every material possession that meant anything to me. We were also losing our home because I could not afford to pay for anything with no income. It was January of 1992.

I did the next best thing and went back to AA hoping to find my family. I knew my wife was still on the island and actively attending meetings. However, she made herself scarce. I knew she didn't want anything to do with me. When I look back, I realize today that she did what she had to do. I thank GOD today for this woman for her courage especially when I didn't have any myself.

By the grace of GOD, I stayed sober (white knuckle sobriety) and moved into a clean and sober house and once more started attending AA meetings, and hung on to the men of the fellowship. I walked into a Big Book study group one evening and they were about to start the third step prayer. I got on my knees like everyone else in the room and started praying not knowing why. All I knew and what occupied my mind was my family. I knew I had really screwed up this time. It was also the first time since I can remember that I said a prayer. When I look back, I realize that GOD was doing for me that I couldn't do for myself. All I had to do was ask. From that day on, every morning I prayed. I continued with that book study. This is where the 12-step program unfolded before my eyes. I started to understand the condition I was suffering from and if I wanted to pursue a more productive and fruitful life there were a few things I needed to do. By the time I got through the first four chapters of the book, I was convinced that I needed to incorporate the 12-step program into my life. Getting sober was only a part of it. I needed to find a way to stay sober. By this time I was working with a

sponsor who was actually leading the book study. I thank GOD for this man every day. He helped me realize the true meaning and value of trusting GOD, clean and keep your house in order, and help others. When I was in doubt about something in my recovery, I consulted my sponsor and the men he hung around with. As time went on, my family returned only by the grace of GOD. I had the opportunity to clear my wreckage and make amends to my children, my wife and countless others. I've taken this 12-step program and incorporated it into my life just like the book intended. I know what it feels like to experience those promises the book talks about. For the last 30 years of my recovery I haven't found it necessary to drink or use one day at a time. I am not the man I used to be because of AA. I have experienced the psychic change the book talks about. As a result, I make it a point to give of my time to serve this wonderful program by being available for others like me. I've been afforded a career working in the field of substance abuse for the last 25 years and obtained several degrees. I have everything I need to live a great life once again. However, on different terms. When I look back, I thank my wife for mustering up the courage to derail me and my addiction on several occasions. Only someone who believes in GOD would have endured what she went through with me. I thank my sponsor for introducing the 12-steps and much more about this program to me and helping me realize what was important in life. He is still my sponsor today. My sponsor would always say "Don't thank me, thank GOD". And last but not least, I want to thank GOD for the people in my life who he has empowered to help me become who I am today. The greatest gift this program has afforded me is GOD. After all, it is the main purpose of the book. I'm glad I did not know this at the beginning but I'm grateful I know this today. I've been given a second chance! Thank GOD for AA and thank AA for GOD.

What a surprise to be pulled out of the hat to serve as Alternate Chair! I was excited but I must confess, fearful! I am very grateful to Deborah S, our current Chair, who met with me to clarify the duties and responsibilities in my new position. She was very encouraging and did an amazing job at passing the baton. I was extremely grateful to her for easing my mind and I am grateful to be surrounded by fellow members and especially Cheryl N, my service sponsor, who gave freely of what they have learned in area service. I never serve alone.

My main objective as Alternate Chair is to support our Area Chair in running smooth assemblies and committee meetings and to perform her duties in her absence. Here is a summary of my activities as Area Alternate Chair:

- Participated in Plan-to-Plan Meetings with area officers.
- Attended Finance Committee Meetings during lunch at assemblies and committee meetings, when needed.
- Served as the Big Island Finance Committee representative and presented the area's proposed budget to districts and home groups as requested.

- Attended the Annual Hawaii Convention Steering Committee Meetings once a month as a voting member throughout the panel as well as attending the monthly Annual Hawaii Convention Committee meetings as a voting member during the first year. Attended the Hawaii Annual Convention in October of 2022 as a part of the steering committee.
- Supported the area registrar by creating the online registration forms for eight assemblies and six committee meetings.
- Helped review the revised GSR Handbook.
- Supported our area chair in working with and meeting with tech teams twice before each assembly and committee meeting.
- Work behind the scenes with hosting tech teams at our committee meetings and assemblies.

- Facilitated roundtable discussions at assemblies.
- Attended PRAASA both years.
- Attended West Hawaii Central Office and West Hawaii District 8 meetings.
- Worked more closely with hosting DCMs and committee chairs in the second year, as we moved towards in-person assembly and committee meetings.

I am excited we are moving back to in-person assemblies. In-person meetings give our districts greater opportunities for service. I always ask myself "do I only serve when it is convenient for me? If so, am I really serving? I have received my greatest gifts serving when it was most <u>in</u>convenient.

Hawaii Area 17 Panel 71 Summary

Standing Committee Chair Treatment and Accessibilities

On the one hand, I was very excited because I had been appointed to the position that I had first chosen. On the other hand, I was extremely nervous about the simple fact that I wasn't sure what I was going to be doing. I've learned along the way that fear is the opposite of faith. So, I needed to understand that faith was going to bring everything all together, the way that it was supposed to. Upon arrival at the orientation in January 2021, I must admit that meeting the newly appointed GSR's, trying to come together with a plan, and realizing that this was not in my hands at all, one word came to mind, Overwhelmed!

So, here's this alcoholic, already overwhelmed, and I haven't done anything to this point. As usual, everything I thought I knew, I didn't know. The traditions and concepts have told me very clearly, especially through the declaration of Unity, to place our common welfare first in order to keep our fellowship united. If I remember that simple statement. Everything was going to go the way that it was meant to go. The first thing I needed to do was get ahold of all the treatment facilities on all the islands. So, I was able to compile a list, send letters, and work with the GSR's that were on my committee in order to accomplish that goal. The next thing we set out to do was put together a series of workshops. My original goal was to accomplish 4 workshops throughout Panel 71. What I learned from this was that putting together 4 workshops was a lofty goal. We were able to get together and put on 3 workshops for panel 71. We started off with our original

workshop bridging the gap. We came together for a second workshop entitled Treatment and Traditions and we finished a third workshop entitled Treatment and Traditions Part 2. We were able to cover all the traditions in conjunction with the treatment committee that was utilized in order to put our best foot forward in support of working with the fellowship to keep them informed as well as keeping our doors open for the newcomer.

The workshops were well attended. We were able to keep our members informed, as well as our appointed committee members in action. The behind-the-scenes work that was accomplished within the treatment facilities and a lot of the clean and sober houses was wonderful. We were able to put literature racks and literature in 20 different facilities. I started a bit early as Webmaster while wrapping up last panel as the Corrections Chair, as help was needed to get the website back online after a suspension and restored to better functionality. I was grateful for and enjoyed the opportunity and had fun reworking the site and working with fellow area members to help develop the website to best suit or needs and it remains a continual work in progress as our needs continue grow and change. I also enjoyed learning all the aspects of managing the WordPress site, the domain & website hosting and Google Workspace Gmail and Google Drive and developing a system to quickly & efficiently perform ongoing tasks and request. This position offers a lot of quick gratification with the ongoing submittals for posting; a few clicks of the mouse and a quick reply with a smiley face leads to quick responses of gratitude from my fellows, greatly appreciated especially during the recent period of isolation. The Website Standing Committee description also says that technical training and services are provided as needed, however I somehow managed to avoid being involved in any of the virtual and hybrid meeting responsibilities. I look forward to helping the transition to the next willing trusted servant and will be available for as much assistance as needed during the process.

I do have a recommendation for the committee that I have not gotten around to submitting anything for. The Website Guidelines may not serve us well anymore as currently written and are likely due for a review and update. I did form a Website Committee as outlined, with an Alternate Webmaster and 3 other members and we met once to discuss the layout of the website, but we have not met since then. Due to the technical skills and the knowledge needed to maintain the website and domain hosting and email environment, I do think having an alternate trained and ready to step in if needed and available to help with some of the maintenance as needed is a good idea. As for the rest of the committee, perhaps a Technical Services Committee or the like to help anticipate and oversee our growing tech needs would serve us better to provide consistency and remove any burden of technical services management from the Officers already tasked with overseeing our meetings and any need for host districts to provide technical expertise.

I will finish by saying that General Service has been vital part of my growth in sobriety; I did not play well with others when I got here and desperately needed this environment beyond the ease of just going to meetings where I could bump up against other AA's, helping to knock the chips off each other's shoulders and learn about commitment, trusting the process and being part of a greater voice. 
